HICH operates in a tightly regulated rideshare environment where changes to TNC laws, insurance requirements, or licensing rules could increase costs or limit expansion. Any city or state-level delays in approvals could slow growth and impact revenue.

HICH is an early-stage company that must scale technology, attract riders, and onboard drivers quickly to remain competitive. If capital needs exceed expectations or growth is slower than planned, the company may face operational or financial strain.

HICH competes directly with Uber and Lyft, which have significant market power, large budgets, and strong brand recognition. If drivers or riders do not adopt HICH at the expected rate, revenue growth and long-term sustainability may be affected.

HICH has developed and owns the ridesharing software platform, which may contain bugs or vulnerabilities that disrupt service. Any data breach or system failure could damage trust and interrupt operations.

HICH's success depends heavily on the experience and involvement of its founding team and key executives. The loss of one or more leaders could materially impact execution and company direction.

A significant portion of HICH's early revenue comes from a limited geographic area. If demand in these markets slows or competition intensifies locally, revenue could fluctuate more dramatically than expected.

Because HICH blends rideshare, medical transport, and driver ownership, regulators may interpret certain requirements differently across jurisdictions. Misalignment or delays in receiving clear regulatory guidance could impact operations or force changes to the business model.

HICH's driver equity program requires ongoing stock issuances and careful accounting under changing SEC and IRS rules. Errors, delays, or unexpected interpretations of valuation or tax rules could create administrative or financial burdens.

Mohamed Hassan, Robert Cass and Shibu Abraham are part-time officers. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Raising our maximum would allow us to increase investments in areas of R&D (Enabling us to scale onboarding, ride fulfillment and other revenue generating areas), Hiring (Hiring tech talent to improve technology), and investing into marketing and branding efforts to get our word out to the people of Minneapolis. This will allow HICH to reach operating breakeven and positive cash flow within approximately 12-18 months by accelerating growth, and build a lean but fully capable operations team and capabilities that are not achievable with the \$50K minimum, which is focused primarily on platform validation and early traction.

This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors’ interests in the investments will be recorded in each investor’s “Portfolio” page on the Wefunder platform. HICH Inc is offering up to 5,500,000 shares of Class A Common Stock, at a price per share of \$0.50.

Wefunder VIP investors will receive stock at a price per share of \$0.40, and a pre-money valuation of \$8,800,000.

The campaign maximum is \$2,200,000.00 and the campaign minimum is \$50,000.00.

VIP Bonus

Hich will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow

disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Describe any other rights:

The Company's amended and restated articles of incorporation authorizes the issuance of Class A Common Stock and Class B Common Stock. The rights of the holders of Class A Common Stock and Class B Common Stock are identical, except with respect to voting and conversion. Holders of Class A Common Stock are entitled to one vote per share, and holders of Class B Common Stock are entitled to 10 votes per share. Shares of Class B Common Stock are convertible into an equivalent number of shares of Class A Common Stock and generally convert into shares of Class A Common Stock upon transfer. Any dividends paid to the holders of Class A Common Stock and Class B Common Stock will be paid on a pro rata basis. Upon liquidation and winding up of the Company, the shares of Class B Common Stock shall be entitled to receive on a per share basis the amount payable with respect to the shares of Class A Common Stock as if its shares of Class B Common Stock were converted into Class A Common Stock. Preferred shares have been authorized, but they have no associated rights yet.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing

vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional equity, an Investor's interest will typically also be diluted.

Based on the risk that an Investor's rights could be limited, diluted or otherwise qualified, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview

The rideshare app that empowers communities and elevates every ride. HICH Inc acquired a ride-sharing

platform and mobile-based application that connects drivers and riders across the United States of America. The platform generates revenue through ride-hailing services, offering an innovative alternative to taxis and traditional private transportation, while providing equitable earning opportunities for riders and drivers. The Company commenced its operations in May 2024, with its corporate officers acting as key personnel responsible for the day-to-day management of the Company's affairs.

Milestones

HICH Inc was incorporated in the State of Florida in March 2023.

Since then, we have:

- Zero marketing spend, 7,390 riders acquired. \$165K in revenue
- 42% average monthly growth in bookings. Organic demand drove strong, consistent growth.
- Strong rider interest validated our model, showing market appetite for fair ridesharing.
- \$148M in medical transport contracts with Ucare, BlueCross, medical assistance partners.
- Drivers own equity: 20% reserved for them, with 300+ drivers enrolled in shareholding.
- Zero commission model is profitable. Drivers earn 20% more than Uber, customers save 25%.
- Revenue from \$199-\$999 annual subscriptions, \$1.50 per ride booking fee.

Historical Results of Operations

Our company was incorporated in March 2023 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2024, the Company had revenues of \$11,784 compared to the year ended December 31, 2023, when the Company had revenues of \$0.
- *Assets.* As of December 31, 2024, the Company had total assets of \$9,672,379, including \$161,082 in cash. As of December 31, 2023, the Company had \$11,841 in total assets, including \$11,841 in cash.
- *Net Loss.* The Company has had net losses of \$1,052,498 and net losses of \$38,909 for the fiscal years ended December 31, 2024 and December 31, 2023, respectively.
- *Liabilities.* The Company's liabilities totaled \$1,072,445 for the fiscal year ended December 31, 2024 and \$0 for the fiscal year ended December 31, 2023.

Liquidity & Capital Resources

To-date, the company has been financed with \$7,600 in debt, \$1,300,000 in equity, and \$4,060,800 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 3 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 3 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

HICH Inc cash in hand is \$35,000, as of February 2026. Over the last three months, revenues have averaged \$45,000/month, cost of goods sold has averaged \$40,000/month, and operational expenses have averaged \$75,000/month, for an average burn rate of \$70,000 per month. Our intent is to be profitable in 13 months.

Since the date covered by our financial statements (December 31, 2024), HICH has experienced material growth in both operations and capitalization. We expanded to 3,513 onboarded drivers within 11 months and generated revenue 11x higher than projected, driven by increased trip volume and platform improvements. We also entered the medical transportation space through HICH Transport LLC, opening access to \$18.4M

through HICH Transport LLC, opening access to \$12.4M in NEMT contract opportunities that were not present during the reporting period. After year-end, we issued 430,000 shares for \$215,000 in new capital and 644,000 shares to drivers under our ownership program, increasing outstanding shares and strengthening our financial position. In addition, we improved our technology, expanded administrative capacity, and established new partnerships that significantly increased operational activity compared to 2024.

Over the next 3–6 months, we expect continued revenue growth driven by our expanding driver base, increased trip volume, and the ramp-up of HICH Transport LLC. Based on current trends, we project monthly revenues in the range of \$120,000–\$180,000, with operating expenses between \$150,000–\$220,000 as we continue investing in technology, insurance, compliance, and market expansion. We also anticipate that our pending Blue Cross NEMT contract will become active during this period, which would materially increase our institutional trip volume and shift projected revenues into the \$200,000–\$300,000 per month range once fully operational. While early-stage expansion may keep us near break-even in the short term, the combination of rideshare growth and institutional NEMT contracts positions us for significantly improved financial performance. Capital from this raise will support new market expansion, driver onboarding, and rider acquisition necessary to reach the next stage of revenue growth.

HICH is not yet profitable, which is normal for an early-stage rideshare and NEMT platform in its expansion phase. Based on current expenses and revenue growth, we estimate that \$1.2M–\$1.8M in additional funding will allow us to reach profitability by enabling us to scale driver onboarding, rider acquisition, and institutional NEMT operations. With our existing rideshare traction, expected growth in Minneapolis, and the activation of our pending Blue Cross NEMT contract, we project reaching operational break-even within 9–14 months after securing this round of funding. Profitability is driven by increased trip volume, higher institutional margins, and improved operating efficiencies as fixed costs are spread across more markets and rides. This raise is designed to give us enough runway to execute that plan and move the company into sustained, profitable operations.

HICH has several additional sources of support beyond the funds raised through Wefunder. To date, the company has been funded through founder capital contributions, private early investors, and ongoing revenue from rideshare and NEMT operations, which

revenue from hardware and NEMT operations, which together have provided the resources needed to sustain early growth. We also anticipate new revenue acceleration through the expected activation of our Blue Cross NEMT contract, which will strengthen short-term cash flow.

While we are not yet profitable, we intend to cover short-term burn through a combination of current operating revenue, disciplined cost management, and bridge support from founders if necessary. These measures ensure that HICH remains operational and continues scaling throughout the Wefunder campaign until the full raise is completed
