We are an early-stage company with limited operating history, no assurance of profitability, and negative cash flows expected for the foreseeable future. Our strategy requires significant spending on product development, marketing, inventory, and working capital, and we may never achieve profitability.

We will likely need additional capital, which may not be available on acceptable terms. Future financings could be dilutive, senior to this round, or contain investor-friendly terms (liquidation preferences, anti-dilution, debt covenants) that disadvantage you

Valuation and target milestones are uncertain. Our valuation is not based on a public market and may not reflect actual company value; we may fail to meet growth or margin targets embedded in our projections.

Our securities are illiquid. Securities sold under Regulation Crowdfunding are subject to transfer restrictions for one year and there is no active secondary market. You may be unable to sell your investment when desired, or at all.

Unproven market acceptance. Consumer demand for our products is uncertain. Even if the broader “health food” category grows, interest in our specific formulations, flavors, and formats may not materialize or may be short-lived.

Highly competitive industry. We compete with large, well-capitalized incumbents and numerous emerging brands on price, taste, nutrition profile, convenience, branding, and distribution. Competitors may copy product concepts rapidly.

Pricing and margin pressure. Grocery and e-commerce categories are price-sensitive. Promotional activity, discounting, and retailer/wholesaler chargebacks may compress margins.

Product portfolio execution risk. We may fail to launch on time, secure distribution, maintain flavor/texture consistency at scale, or hit targeted gross margins.

Expansion into third-party retail may not succeed. Retailers may require slotting fees, promotional allowances, favorable payment terms, return rights, or category performance thresholds that we cannot meet.

Food safety and quality risks. As a food company, we face risks of contamination, adulteration, mislabeling, spoilage, and allergen cross-contact. Any recall or advisory could be costly and damage our brand.

Compliance with food regulations. We must comply with federal, state, and (if applicable) local and international regulations relating to food manufacturing, labeling, facility registration, cGMPs, Hazard Analysis/Risk-Based Preventive Controls, and traceability. Non-compliance could lead to fines, enforcement actions, recalls, product seizures, or facility shutdowns.

Claims and labeling risk. Health, nutrition, and “free-from” claims (e.g., “high-protein,” “no added sugar,” “natural,” “clean,” “non-GMO,” “gluten-free,” etc.) require substantiation and precise labeling. Errors or challenged claims can result in litigation (including class actions), regulatory action, or retailer de-listing.

Allergen management. Failure to identify, label, and manage major allergens could cause severe consumer harm and lead to recalls and liability.

Proposition 65 and similar state laws. If our products are sold in states with warning-label regimes or specific contaminants thresholds, we may face additional testing, labeling, and litigation risk.

Evolving regulatory landscape. Rules, guidance, or enforcement priorities relating to food ingredients, novel proteins, sweeteners, fortification, or marketing (including for children) may change, increasing costs or limiting claims we can make.

International sales complexity. If we sell outside the U.S., we will face import/export rules, customs delays, tariffs, and country-specific labeling and ingredient restrictions.

Reliance on contract manufacturers. We do not own manufacturing facilities and depend on third parties for capacity, quality, scheduling, certifications, and compliance. Disputes, capacity constraints, labor issues, equipment failure, or loss of a co-manufacturer could disrupt supply.

Limited or no exclusivity. Our manufacturers may also produce for competitors. We may not secure favorable exclusivity, MOQs, or lead times, and may face unexpected price increases.

Ingredient availability and volatility. Prices and availability for proteins, grains, sweeteners, flavors, and packaging can fluctuate due to crop yields, geopolitical events, transportation costs, energy prices, or supplier concentration.

Scale-up risk. Formulations that work in pilot runs may not scale consistently, leading to quality variance, yield loss, or increased costs.

Shelf life and waste. Perishability or shorter shelf life may lead to write-offs, returns, and margin erosion, particularly in new retail doors or seasonal windows.

Third-party logistics dependency. We rely on 3PLs and parcel carriers

third-party logistics dependency. We rely on 3PLs and parcel carriers. Carrier surcharges, strikes, service interruptions, or fuel price volatility could increase costs or delay deliveries.

Dependence on online and social channels. We expect to rely heavily on e-commerce platforms, social media, and digital advertising. Algorithm changes, policy shifts, account suspensions, or increased ad costs could impair customer acquisition.

Influencer and affiliate marketing risk. We anticipate using influencers/creators whose statements must comply with advertising and disclosure rules. Misstatements, failure to disclose, reputational issues, or contract disputes could harm the brand and lead to regulatory scrutiny.

Claims substantiation and advertising law. We must substantiate express and implied claims in ads, landing pages, and influencer content. Failure to do so could lead to enforcement or litigation.

Data-driven marketing headwinds. Privacy changes (e.g., mobile OS and browser tracking limitations) can reduce ad targeting effectiveness and increase customer acquisition cost (CAC).

Customer concentration and churn. Sales may rely on a small number of channels, campaigns, or retailer accounts. Loss or underperformance of any key channel could materially affect results.

Reputational risk. Negative reviews, social media backlash, or product comparisons may spread rapidly and be difficult to remediate.

Website and platform reliability. Outages, cyberattacks, or failures of our website, e-commerce stack, payment processors, or inventory systems could disrupt sales and damage trust.

Data protection and privacy compliance. We collect consumer data and must comply with evolving federal and state privacy laws and payment security standards. Breaches or non-compliance can lead to fines, liability, and reputational harm.

Third-party dependencies. We rely on SaaS vendors, ad platforms, and analytics tools. Term changes, pricing, or outages may impair operations.

Protection of proprietary formulations and know-how is uncertain. Our value depends in part on trade secrets, recipes, and processes. Contract manufacturers, suppliers, employees, or influencers may misappropriate or disclose confidential information despite our protective measures.

Limited patent protection. Some formulations may not be patentable; even if patents are pursued, they may not issue or may be narrow or easily designed around.

Brand and trademark risks. We may face oppositions or infringement claims. If we are required to rebrand or modify packaging, costs and lost goodwill could be significant.

Content/IP from influencers. Ownership and licensing of influencer-created content can be complex; we may not secure broad, perpetual rights or may face takedown claims.

Key person risk. Our strategy depends on a small team. Loss of key leaders, formulation scientists, or supply chain staff could materially harm us.

Hiring and retention challenges. Competition for experienced CPG talent is intense, and we may be unable to hire at expected timelines or cost.

Internal controls and scalability. Rapid growth may strain systems, inventory control, QA/QC, and financial reporting processes, leading to errors or inefficiencies.

History of losses; need for additional capital. We expect negative cash flow from operations for the foreseeable future and will likely need additional financing, which may not be available on acceptable terms.

Inventory and working capital requirements. Manufacturing MOQs, retailer terms, and promotional spend may require substantial cash outlays before revenue is realized.

Insurance may be inadequate. Product liability, recall, cyber, and business interruption insurance may be unavailable, inadequate, or expensive.

Exposure to product liability and consumer claims. Allegations of injury, false advertising, or unfair competition could result in costly litigation or settlements.

Regulatory enforcement. We may be subject to investigations or actions by federal or state regulators related to labeling, claims, marketing practices, or privacy.

Contract disputes. We may face disputes with manufacturers, suppliers, influencers, agencies, 3PLs, or retailers that disrupt operations or increase costs.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. Simultaneously, it will set the stage to bring our next product(s) to market.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, Investors will receive a number of shares of **Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

- i. the total value of the Investor's investment, divided by
  - a. the price of **Preferred Stock** issued to new Investors

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Board Of Directors, and the Investor will have no independent right to name or remove an officer or member of the Board Of Directors of the Company.

### Management's Discussion and Analysis of Financial Condition and Results of Operations

#### Overview

The Company is headquartered in Austin, Texas, and is a consumer-focused company developing proprietary food and beverage products in high-demand categories. The Company will launch first through direct-to-consumer platforms, later expanding into brick-and-mortar channels, leveraging unique built-in marketing vehicles and a team of seasoned industry experts.

#### Milestones

GLO Ventures Inc., ("the Company") was originally formed as LYT Tech Inc. on October 18th, 2022 and incorporated into a Delaware C-Corporation and changed its name to GLO Ventures Inc. on August 5th, 2024.

Since then, we have:

- All-star team across every CPG industry category incl. the experts behind Magic Spoon/Stars & Honey.
- Created by Gabbi Tuft, Licensed Sports Nutritionist, w/over 80M monthly views on TikTok & Instagram.
- Highly targeted whitespace to target massive success; 1st-protein; 2nd-BARS; then, 3 more disruptors
- Vested influencer network driving GLO's marketing funnel--100M+ combined followers
- Clean formula: no artificials, seed oils, or GMOs—glyphosate-free & sweetened w/ allulose.
- Bars contain myoinositol— tastes great, helps stop carbs turning to fat, while curbing hunger!

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

#### Historical Results of Operations

Our company was incorporated in October 2022 and has limited operations

upon which prospective investors may base an evaluation of its performance.

#### **Liquidity & Capital Resources**

To-date, the company has been financed with \$20,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 8 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 4 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### **Runway & Short/Mid Term Expenses**

GLO Ventures Inc. cash in hand is \$7,640, as of October 2025. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$20,000/month, and operational expenses have averaged \$0/month, for an average burn rate of \$20,000 per month. Our intent is to be profitable in 6 months.

Since the date our financials cover, we have tested proof of concept by Launching GLO protein through co founder Gabbi Tuft's separate channels.

Over the next 3-6 months we expect revenue of approximately \$230,000 - \$350,000 and expenses of approximately \$211,411 - \$422,822. We are not currently generating revenue and will need at least \$200k in funding to reach revenue generation. We expect that we will begin to generate revenue immediately upon moving assets of GLO protein to GLO Ventures; bar revenue generation to begin upon launch of crowdfund.

We are not yet profitable; however, upon completion of this crowdfund, we will effectively be operating in the black. We expect this to occur no later than the end of this calendar year. In order to become profitable, we will need at least \$200k in funding.

The completion of the crowdfund will enable us to produce and bring the GLO Bars to market, for which we already have a ready-made buyer constituency. In addition, GLO Protein will generate concurrent revenue, further strengthening our early profitability position.

In addition to raising capital through Wefunder, we are concurrently securing funds from more traditional sources, including family offices and early-stage venture capital firms. If we don't raise more than \$50k in funds via Wefunder, we would plan to continue raising funds through family offices/VC.

Furthermore, upon transferring the assets of GLO Protein to GLO Ventures, the company will begin generating immediate revenue from that product

line, while also expecting to generate additional revenue from GLO Bars as soon as the crowdfund launches.

Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect.
