Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Greenopia helps the rapidly growing number of eco-conscious individuals navigate the overwhelming landscape of sustainable and socially responsible choices to find carefully vetted local businesses and products that are healthy for people and the planet. Our goal is to verify the sustainability credentials of hundreds of thousands of local businesses to assist ecologically conscious consumers (a \$0.5T market). Once this network is established, we will build a community and marketplace with incentives and additional services. We verify merchants via an EPA-awarded system, whereby the sustainability credentials of companies are assessed by Greenopia's rigorous ESG ratings review, assigning attributes across 50 categories of businesses. This information is made available to consumers via a web app and through corporate partnerships, licensing, and API. Greenopia's sustainability attributes fall into 3 pillars: Revenue Sources: Use of Funds:

1. Our future growth depends on our ability to develop and retain customers. Our future growth depends to a large extent on our ability to effectively anticipate and adapt to customer requirements and offer services that meet customer demands. If we are unable to attract customers and/or retain customers, our business, results of operations and financial condition may be materially adversely affected.
2. Inability to protect our proprietary technology would disrupt our business. We rely, in part, on trademark, copyright, and trade secret law to protect our intellectual property in the United States. We

seek to protect our software, documentation, and other written materials under trade secret and copyright law, which afford only limited protection. We do not currently have United States and foreign patents on our technology to protect our intellectual property. The intellectual property rights we have may not be sufficient to provide us with a competitive advantage, and could be challenged, invalidated, infringed or misappropriated. We may not be able to protect our proprietary rights in the United States or internationally (where effective intellectual property protection may be unavailable or limited), and competitors may independently develop technologies that are similar or superior to our technology, or duplicate our technology. We attempt to further protect our proprietary technology and content by requiring our employees and consultants to enter into confidentiality and assignment of inventions agreements and third parties to enter into nondisclosure agreements. These agreements may not effectively prevent unauthorized use or disclosure of our confidential information, intellectual property or technology and may not provide an adequate remedy in the event of unauthorized use or disclosure of our confidential information, intellectual property or technology. Litigation may be necessary in the future to enforce our intellectual property rights, to determine the validity and scope of our proprietary rights or the rights of others, or to defend against claims of infringement or invalidity. Such litigation could result in substantial costs and diversion of management time and resources and could have a material adverse effect on our business, financial condition, and operating results. Any settlement or adverse determination in such litigation would also subject us to significant liability.

3. **Technological Risk** We operate in an emerging market that is characterized by rapid changes in customer requirements, frequent introductions of new and enhanced products, and continuing and rapid technological advancement. Our technology may underperform the technology utilized by our competitors.
4. **Key Employee Risk** We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if she fails to perform in her current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other executive officers could harm the Company's business, financial condition, cash flow and results of operations.
5. **Third parties might infringe upon our technology, trademark, or other proprietary rights, or think we are infringing upon their rights.** We cannot assure you that the steps we have taken to protect our property rights will prevent misappropriation of our technology. To protect our rights to our intellectual property, we plan to rely on a combination of trade secrets, confidentiality agreements and other contractual arrangements with our employees, affiliates, strategic partners and others. We may be unable to detect inappropriate use of our technology. Failure to adequately protect our intellectual property could materially harm our brand, devalue our proprietary content and affect our ability to compete effectively. Further, defending any technology rights could result in significant financial expenses and managerial resources.
6. **Despite Greenopia 1.0 being a successful concept proven in the past with more than 120,000 merchants subscribed, the printed version experience may not be applicable to digital version.** Also, whilst we had successful partnerships in the past, there is no guarantee that we will achieve the same with this new version.
7. **Despite the fact that 100% of merchants asked in Atlanta (our original pilot city) in 2024 expressed their interest to participate in Greenopia 2.0, merchants have not yet been presented with the subscription agreement to corroborate their intention.**
8. **We are a pre-launch, pre-revenue, pre-seed company with all uncertainties related to early stage investment.**
9. *The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.*

10. *Neither the Offering nor the Securities have been registered under federal or state securities laws, leading to an absence of certain regulation applicable to the Company.*

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. 12. *The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.*

Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

13. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities*

regulations may apply, and each Investor should consult with his or her attorney.

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Because the Securities offered in this Offering have not been registered under the Securities Act or under the securities laws of any state or non-United States jurisdiction, the Securities have transfer restrictions and cannot be resold in the United States except pursuant to Rule 501 of Regulation CF. This lack of information could put Investors at a disadvantage in general and with respect to other security holders.

15. *The shares of Securities acquired upon the Offering may be significantly diluted as a consequence of subsequent financings.*

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

16. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The availability of capital is at least partially a function of capital market conditions that are beyond the control of the Company. There can be no assurance that the Company will be able to predict accurately the future capital requirements necessary for success or that additional funds will be available from any source. Failure to obtain such financing on favorable terms could dilute or otherwise severely impair the value of the investor's Company securities.

17. *There is no present public market for these Securities and we have arbitrarily set the price.*

The offering price was not established in a competitive market. We have arbitrarily set the price of the Securities with reference to the general status of the securities market and other relevant factors. The Offering price for the Securities should not be considered an indication of the actual value of the Securities and is not based on our net worth or prior earnings. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

18. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the

Company cannot predict whether the Company will successfully effectuate the Company's current business plan. Each prospective Investor is encouraged to carefully analyze the risks and merits of an investment in the Securities and should take into consideration when making such analysis, among other, the Risk Factors discussed above.

The Offering

Greenopia USA Inc ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$505,778 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

In the event The Company fails to reach the offering target of \$10,000, any investments made under the offering will be cancelled and the investment funds will be returned to the investor.

8. What is the purpose of this offering?

We have 2 goals for 2025 once we are funded: 1) onboard 10,000 businesses 2) build the MVP of our user facing app For on-boarding operations, we will continue to improve the automation and self serve capabilities of our sign up process to get our first customers on board, and to prepare for further scale. We do this through our 3rd party data tech team. The user facing app will be designed and built partly in-house, with the bulk of the engineering and build effort outsourced through 57 Blocks. Once launched we will have marketing costs, mostly directed towards social media, to help build awareness and engagement with the web app. We will also pay the founders a small salary, and allow for legal and accounting costs.

10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and Greenopia USA Inc must agree that a transfer agent, which keeps records of our outstanding common shares (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). Similar to other online investment accounts, the transfer agent will give investors access to a web site to see the number of Securities that they own in our company. These Securities will be issued to investors after the deadline date for investing has passed, as long as the targeted offering amount has been reached. The transfer agent will record the issuance when we have received the purchase proceeds from the escrow agent who is holding your investment commitment.

11. How can an investor cancel an investment commitment?

You may cancel an investment commitment for any reason until 48 hours prior to the deadline identified in the offering by logging in to your account with Netcapital, browsing to the Investments screen, and clicking to cancel your investment commitment. Netcapital will notify investors when the target offering amount has been met. If the issuer reaches the target offering amount prior to the deadline identified in the offering materials, it may close the offering early if it provides notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). If an investor does not cancel an investment commitment before the 48-hour period prior to the offering deadline, the funds will be released to the issuer upon closing of the offering and the investor will receive securities in exchange for his or her investment. We are issuing Securities at an offering price of \$0.64 per share.

14. Do the securities offered have voting rights?

The Securities are being issued with voting rights. However, so that the crowdfunding community has the opportunity to act together and cast a vote as a group when a voting matter arises, a record owner will cast your vote for you. Please refer to the record owner agreement that you sign before your purchase is complete.

15. Are there any limitations on any voting or other rights identified above?

You are giving your voting rights to the record owner, who will vote the Securities on behalf of all investors who purchased Securities on the Netcapital crowdfunding portal.

16. How may the terms of the securities being offered be modified?

Any provision of the terms of the Securities being offered may be amended, waived or modified by written consent of the majority owner(s) of the Company. We may choose to modify the terms of the Securities before the offering is completed. However, if the terms are modified, and we deem it to be a material change, we need to contact you and you will be given the opportunity to reconfirm your investment. Your reconfirmation must be completed within five business days of receipt of the notice of a material change, and if you do not reconfirm, your investment will be canceled and your money will be returned to you.

Restrictions on Transfer of the Securities Offered

The securities being offered may not be transferred by any purchaser of such securities during the one-year period beginning when the securities were issued, unless such securities are transferred:

The shares being offered on Netcapital will increase the total number of shares in the company. As a result, the percentage ownership of each existing shareholder, including new investors from this campaign, will be proportionally reduced. The Company's bylaws can be amended by the shareholders of the Company, the shareholders or the directors can increase the size of board of directors, most vacancies can be filled by the directors, and directors can be elected or removed by the shareholders. As minority shareholders, you are subject to the decisions made by the majority shareholders. As a minority shareholder, you may be outvoted on issues that impact your investment, such as sale of control of the Company, permitted transfers of shares of common stock, increase or reduction in the capital of the Company, issuance of additional shares in the capital of the Company, consolidation or merger of the Company with another entity, leases of certain corporate property, loans to a shareholder or affiliate of the Company, transactions out of the ordinary course of business of the Company, including changing the nature of the business, change in the authorized signing officers in respect of legal documents or any financial institution, waiver of appointment of auditor, amendment of employment contracts, employment by the Company of relatives of a shareholder, amending or restating the shareholder agreement or the Company's certificate of incorporation. The Company is governed by its Shareholders Agreement, which governs the transfers of shares of common stock, and admission of a new shareholder requires the approval of a majority of shareholders. In addition, any voluntary transfer gives rise to a right of first refusal on behalf of the Company, and to the extent not fully exercised, the remaining shareholders have the right of first refusal to purchase such shares of common

stock. Upon an involuntary transfer of shares of common stock, the Company, and to the extent not fully exercised, the remaining shareholders, have the right to repurchase any transferred common shares for fair market value or such other value as set forth in the Shareholders Agreement. The Shareholders Agreement also contains tag-along rights in the event that the holders of a majority of the outstanding common stock choose to sell such shares that result in a sale of control of the Company. As Gay Browne owns the majority of all outstanding shares of common stock of the Company, she has voting control over the Company. Gay Browne is also the sole member of the board of directors.

The price of the Securities was determined solely by management and bears no relation to traditional measures of valuation such as book value or price-to-earnings ratios. We expect that any future valuation will take the same approach.

As the holder of a majority of the voting rights in the Company, our majority shareholders may make decisions with which you disagree, or that negatively affect the value of your investment in the Company, and you will have no recourse to change those decisions. For example, the majority shareholders may decide to issue additional shares to new investors, sell convertible debt instruments with beneficial conversion features, or make decisions that affect the tax treatment of the Company in ways that may be unfavorable to you. Greenopia USA Inc. is a Delaware corporation that was originally formed as Greenopia USA LLC, a Delaware limited liability company on June 16, 2022, through the filing of a Certificate of Formation with the Secretary of State. On October 21, 2024, a Certificate of Conversion was filed by the Secretary of State to convert Greenopia USA LLC into Greenopia USA Inc., a Delaware corporation. An Amendment to the Certificate of Incorporation was filed with the Secretary of State of Delaware on May 27, 2025. Operating expenses for the year ended December 31, 2024 increased by \$44,038 to \$84,499, as compared to \$40,461 reported for the year ended December 31, 2023. Net loss for the year ended December 31, 2024 increased by \$44,038 to \$84,499, as compared to \$40,461 reported for the year ended December 31, 2023. The

Company incurred \$25,445 and \$2,800 in advertising costs for the years ended December 31, 2024 and 2023, respectively. On May 28, 2025, the company amended its authorized capital structure. The authorized share capital was increased from 100,000 shares to 10,000,000 shares. In conjunction with this, the par value of each share was reduced from \$0.01 to \$0.0001. The Company has been funding its operations through a loan provided by the founder of the Company. This loan is non-interest bearing and has no maturity date and is expected to be repaid as cash flows permit.
