Our founder, CEO and inventor of our groundbreaking and innovative water processing technology and the medium used to make it so successful has just turned 89 years young.

There is always the possibility that another company (however unlikely) could come up with a system as or more effective than ours.

Our lack of current International patent protection and difficulty enforcing International patents in the future is always a potential risk.

A seismic shift in public support and policy (worldwide) could virtually eliminate all the hydrocarbon and other chemicals that currently pour into our Oceans and Waterways... that our technology so effectively removes.

Ongoing hostilities and wars can lead to more contamination of our Oceans and Waterways while simultaneously making it difficult or impossible to safely clean up.

Use of Proceeds: 15% Partnership and Lobbying Contracts, 50% Presentation Materials (3D mechanical drawings/models as well as small scale working equipment to demonstrate effectiveness), 7.9% Wefunder fee, 27.1% Reserves (engineering more customizable solutions, international business travel, upkeep and maintenance of our First Response Vessel, additional marketing expenses, etc.)

If we raise: **\$124,000**

Use of Proceeds: 12% Distribution, 8% Operations, 10% Marketing, 10% Sales, 15% Fabrication, 17.1% Staffing, 20% R&D, 7.9% Wefunder fee. With \$124,000 we could hire outside Engineering Consultants, add additional Patent Protection, and Grant Writers that we couldn't do if we only raised \$50k.

The campaign maximum is \$124,000.00 and the campaign minimum is \$50,000.00.

#### Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly



The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

**Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

**Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. EcoSave Technologies Inc was organized in the State of California in May 2024. Prior to that, EcoSave CEO Benjamin Gurfinkel developed and patented the EST CORE technology as a sole proprietorship. These predecessor financials are attached to the Form C.

Since incorporation, we have:

- EST CORE™ technology exceeds EPA standards for ocean discharge.
- Independent lab tests prove 99.99%+ removal of hydrocarbons and 84%+ removal of other toxins.
- Three-phase approach developed for \$200B+ addressable markets.
- Partnerships with Ardurra & Falcon Strategies allow us to attain & execute contracts immediately.
- Dynamic team with key expertise in engineering, business, patents, biotechnology, sales & marketing.
- Valuable patented equipment & systems allow for internal growth as well as licensing opportunities.
- Invited to pursue large grant opportunities with the Port of San Diego and non-DOD Coast Guard.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

#### Historical Results of Operations

Our company was organized in May 2024 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended April 30, 2025, the Company had revenues of \$0.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 24 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### **Runway & Short/Mid Term Expenses**

EcoSave Technologies Inc cash in hand is \$122.33, as of July 2025. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$15/month, for an average burn rate of \$15 per month. Our intent is to be profitable in 6 months.

There have been no material changes or trends in our finances or operations since the date our financials cover.

We have already raised nearly \$60,000 in reservations via Wefunder which will allow us to execute our contracts and begin our partnerships with Ardurra and Falcon Strategies. Over the next 6 months, we expect approximately \$150,000 in business operational expenses, \$3,000,000 in contract expenses, and \$6,000,000 in revenues.

We are not yet profitable as we are not yet fully operational. The initial minimum raise (\$50k) combined with our partnerships with Ardurra, Falcon Strategies, and APWA allow us to be profitable in as little as 3 to 6 months.

We have and need no other sources of capital besides Wefunder. We expect to be operational with the initial infusion of capital allowing us to apply for contracts and have them be executable with the help of our Environmental Engineering Partner Ardurra.
