**Reliance on Third-Party Manufacturing: Partners**Currently, our production is dependent on a co-packing partner to meet growing demand. While we have strong relationships and quality controls in place, any disruption, delays, or quality issues at the manufacturing level could impact our ability to fulfill orders and maintain retailer trust.

**Competitive Pressure from Emerging Functional Beverage Brands:** The better-for-you beverage category, including kombucha and functional drinks, is becoming increasingly crowded with new entrants and larger brands expanding into this

space. While we differentiate through branding and formulation, heightened competition could lead to increased marketing costs and challenges in maintaining shelf space and customer attention.

Scaling Sales Velocity Across Retailers: While we have secured initial retail placements, our future success depends on achieving and sustaining strong sales velocity in stores. Underperformance at key accounts could lead to discontinued listings, slowing growth and limiting expansion into additional chains or regions.

Regulatory and Compliance Risks Related to Alcohol Content: Because kombucha is a naturally fermented product, it contains trace amounts of alcohol. Although our products comply with the legal limit for non-alcoholic beverages (<0.5% ABV), changes in regulatory enforcement, compliance requirements, or unexpected testing results could require operational changes, additional costs, or even product recalls.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

## Ownership and Capital Structure

### THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

**Conversion to Preferred Equity.** Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, Investors will receive a number of shares of **Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

- i. the total value of the Investor's investment, divided by
  - a. the price of **Preferred Stock** issued to new Investors multiplied by
  - b. the **discount rate** (85%), or
- ii. if the valuation for the company is more than **\$5,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
  - a. the Valuation Cap divided by
  - b. the total amount of the Company's capitalization at that time.
- iii. For investors up to the first **\$100,000.00** of the securities, investors will receive a valuation cap of **\$4,000,000.00** and a discount rate of 85.0%. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

**Additional Terms of the Valuation Cap.** For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

**Liquidity Events.** If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

**Liquidity Priority.** In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- ii. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- iii. Senior to payments for Common Stock.

#### VIP Bonus

RMBR will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

#### Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

#### Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
  - A. the Purchase Amount may not be amended, waived or modified in this manner,
  - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
  - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

- current business conditions and projections;

#### Overview

The Company is a Kombucha brand on a mission to craft functional non-alcoholic beverages designed to elevate daily rituals.

#### Milestones

The Company originally formed as an LLC in 2019. RMBR Bevs Inc. was incorporated in the State of Delaware in April 2025.

Since then, we have:

- RMBR revenue grew +197% from 2022 – 2024 and is poised to exceed \$1M in 2025! (not guaranteed)
- Entered retail in Fall 2021. By 2024, already in 750+ doors, 16 states & 9 distributors
- Current Retail & Distributors include: Jewel-Osco, Sprouts, Hy-Vee, Fresh Thyme

current retail & distro partners include: Green Spoon, Sprouts, Huggies, Fresh Engine, Compass Group & KeHE

- Established network of diversified sales channels: Retail, Ecommerce, Food Service & Private Label
- 2025 distro projections: +1,000 doors, 3 new distro centers & 2 new DSD partners (not guaranteed)
- New Confirmed Accounts: Good Earth, Better Health, Fruitful Yield, Festival Foods, Down to Earth
- Chosen by exclusive Take Root by Green Spoon Program; Accelerates growth for highly promising brands

#### Historical Results of Operations

Our company was formed in 2019 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2024, the Company had revenues of \$724,435 compared to the year ended December 31, 2023, when the Company had revenues of \$528,232. Our gross margin was 48.27% in fiscal year 2024, and 55.26% in 2023.
- *Assets.* As of December 31, 2024, the Company had total assets of \$89,539, including \$18,361 in cash. As of December 31, 2023, the Company had \$134,779 in total assets, including \$57,516 in cash.
- *Net Loss.* The Company has had net losses of \$94,082 and net income of \$58,767 for the fiscal years ended December 31, 2024 and December 31, 2023, respectively.
- *Liabilities.* The Company's liabilities totaled \$94,451 for the fiscal year ended December 31, 2024 and \$41,665 for the fiscal year ended December 31, 2023.

#### Liquidity & Capital Resources

To date, the Company has been funded by \$110,000 in capital contributions from the founder and \$24,746 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 3 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 1 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

RMBR Bevs Inc. cash in hand is \$30,000, as of October 2025. Over the last three months, revenues have averaged \$86,044.64/month, cost of goods sold has averaged \$27,209.15/month, and operational expenses have averaged \$70,070.34/month, for an average burn rate of \$11,234.85 per month. Our intent is to be profitable in 12 months.

We are making significant and ongoing efforts to both strengthen our supply chain and expand our sales network at scale. On the supply side, we're building long-term relationships with co-packers, ingredient suppliers, and packaging manufacturers to ensure we can grow efficiently while keeping costs under control. We're also working toward bulk purchasing and larger batch runs, which will drive down our cost of goods and improve margins.

On the sales side, we're rapidly growing our retail footprint through new partnerships with distributors and key retailers, while also investing in demos, trade shows, and strategic marketing to accelerate velocity in existing accounts. These efforts are not only expanding our presence in the market, but also laying the foundation for sustainable growth as we scale into larger regional and national chains.

We project \$200,000-\$250,000 in revenue over the next 3 months and \$500,000-\$600,000 over the next 6 months. During this growth phase, we expect expenses to represent 85-95% of revenue as we continue investing heavily into new retail partnerships. These investments include slotting fees, advertising, brokerage, and promotional allowances—short-term costs that lay the foundation for long-term scale. As these partnerships mature and our cost efficiencies kick in, we expect margins to expand significantly and set us on a clear path toward profitability.

We are not yet profitable, primarily due to the costs associated with expansion into new retailers. Each account requires slotting, advertising, and promotional spend, and we are also actively investing in trade shows and in-store demos to drive velocity and strengthen relationships with existing partners. With \$250,000 in funding, we can unlock two major efficiencies: bulk can purchasing, which will reduce our COGS by 9.5%, and larger production batch sizes, which we project will save an additional 9.5%. Together, these improvements will bring our landed margin with distributors and direct retailers to 50%+, putting us on a clear path toward profitability. We are currently raising up to \$124,000 on Wefunder.

in addition to the funds raised through the underwriter, we have access to business lines of credit that give us additional flexibility as we scale. We are also implementing cash-flow strategies with our existing partners, such as offering a 2% early payment discount, which accelerates receivables and helps us cover expenses in the short term. While we are not yet profitable, these measures ensure that we can manage short-term burn responsibly throughout the campaign. Combined with the operational efficiencies we are unlocking—such as bulk purchasing and larger batch sizes—these tools position us to bridge the gap until revenue growth and margin expansion bring us into profitability.

The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its

Company's offerings and may potentially be compensated for some or all services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

**Tax Filings.** In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. If applicable, the Company may also be required to pay Wefunder certain fees for the preparation of tax filings. Such fees and the Company's obligation to deliver required tax documents are further specified in the related Tax Services Agreement ("TSA").

Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

**Potential Dissolution of the SPV.** The Company has agreed that it will pay an administrative fee and / or certain tax fees to Wefunder, in addition to delivering required tax information in the manner prescribed by the TSA, where applicable. Failure to pay such fees or provide Wefunder with required tax information could result in the dissolution of the SPV (an "SPV Dissolution Event"). Subsequent to an SPV Dissolution Event, the securities held by the SPV would be distributed directly and proportionally to the individual investors. This could create administrative complexities, as investors would need to manage the securities themselves rather than having them held and administered by the SPV. Additionally, the unplanned distribution of securities may not align with investors' intended investment strategy or asset allocation.

Upon an SPV Dissolution Event, the Investor hereby consents to and agrees to accept direct assignment of the SPV's rights and obligations under any investment agreements between the SPV and the Company that is located in the Form C or C/A offering materials. The Investor acknowledges they will be bound by all terms and conditions of such agreements as if they were an original party thereto.

1. the issuer is required to file reports under Exchange Act Sections 13(a) or 15(d);

3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
