- Our growth relies on paid media and other digital marketing channels. Rising ad costs, platform changes, or declining efficiency could reduce our ability to acquire customers profitably.
- We are currently bootstrapped and rely on outside capital to scale. If we are unable to raise sufficient funding, growth may be slower than planned.
- The apparel and DTC space is highly competitive, with both established brands and new entrants. Competitors with greater resources may impact our market share.
- While we have strong customer retention and sales traction, shifts in consumer preferences, discretionary spending, or broader economic conditions could reduce demand for our products.
- Dependence on Third-Party Manufacturers and Supply Chain Risk. We rely on third party manufacturers and suppliers, including overseas sourcing of materials such as Peruvian cotton. Disruptions in manufacturing, shipping delays, labor shortages, geopolitical instability, tariffs, or changes in trade policies could increase costs, delay product availability, or impact product quality.
- Sustainability and Ethical Sourcing Claims Risk. Our brand messaging includes sustainability, ethical sourcing, and quality claims. Any real or perceived failure to meet evolving consumer, regulatory, or industry standards related to these claims could harm our brand reputation and reduce customer trust.
- Returns, Fit, and Product Quality Risk. Despite our focus on quality and durability, apparel purchases are subject to returns due to fit.

preferences, or perceived defects. Higher than-expected return rates could increase operational costs and reduce profitability.

Technology and E-commerce Platform Risk

Our business depends on the reliable operation and security of our e-commerce platform and third-party service providers. System outages, data breaches, or platform changes could disrupt sales or compromise customer data.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Daniel Gankin is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Book Entry and investment in the Co-issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

2. How can an investor cancel an investment commitment?

Ownership and Capital Structure

THE OFFERING

3. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see Appendix B Investor Contracts. The main terms of the SAFE are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to Preferred Stock in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves Preferred Stock on the standard terms offered to other investors.

Conversion to Preferred Equity: Based on our SAFEs, when we engage in an offering of equity interests involving Preferred Stock, investors will receive a number of shares of Preferred Stock calculated using the method that results in the greater number of Preferred Stock (i.e., the total value of the investor's investment, divided by

- a. the price of Preferred Stock issued to new investors multiplied by
- b. the discount rate (50%), or
- ii. if the valuation for the company is more than \$5,000,000.00 (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. For investors up to the first \$10,000.00 of the securities, investors will receive a valuation cap of \$4,500,000.00 and a discount rate of 50.0%. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

Additional Terms of the Valuation Cap: For purposes of option (i) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and without double-counting, in each case calculated on an as-converted to Common Stock basis:

- includes all shares of Capital Stock issued and outstanding;
- includes all Convertible Securities;
- includes all (i) issued and outstanding Options and (ii) Promised Options; and
- includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events: If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by, another company or new owners prior to investors in the SAFEs receiving Preferred Stock, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount").

Liquidity Priority: In a Liquidity Event or Dissolution Event, this Sale is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes to the extent such convertible promissory notes are not actually or rationally converted into Capital Stock;
- ii. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- iii. Senior to payments for Common Stock.

VIP Bonus

Tomorrow's Laundry, Co. will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum fundraising goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

Securities issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from this sale of its securities solely to purchase as one class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of rank, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferee or assignee (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) exercise, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The Company has authorized 100,000 shares of Common Stock, with 10,000 issued and outstanding. A 15% option pool (15,000 shares) has been established, with 5% (5,000 shares) issued and 10% (10,000 shares) reserved. All shares are Common Stock, with equal voting rights. The Company has not yet authorized preferred stock, which investors would receive in the offering if the SAFE converts. Preferred stock have a liquidation preference over common stock.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting its use rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also dilute the Investor's voting and/or economic rights. Among the factors we may consider in determining the price of Preferred Stock are prevailing market conditions, our financial information, market valuations of other companies that we believe to be comparable to us, estimates of our business potential, the present state of our development and other factors deemed relevant.

In the future, we will perform valuations of our stock (including both common stock and Preferred Stock) that take into account, as applicable, factors such as the following:

- unrelated third party valuations;
- the price at which we sell other securities in light of the relative rights, preferences and privileges of those securities;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or market multiples that compare transactions in similar securities issued by us that were conducted in

the market.

Overview

The Tee Customers Keep Coming Back For

Tomorrow's Laundry, Co. designs and sells premium men's essentials made from sustainable cotton. Its products are marketed and sold primarily through direct-to-consumer e-commerce channels and, to a lesser extent, through wholesale distributors to select retail partners. Tomorrow's Laundry, Co.'s headquarters are located in Costa Mesa, California, and its customer base is primarily in the United States.

Milestones

Tomorrow's Laundry, Co. (the "Company") was formed in the State of California on October 11, 2016 as an S-Corp.

To support its growth strategy and expand investor participation, the Company was converted into a Delaware C-corporation under the same name on October 31, 2025.

Historical Results of Operations

- **Revenue & Gross Margin.** For the period ended December 31, 2025, the Company had revenues of \$149,566 compared to the year ended December 31, 2024, when the Company had revenues of \$170,260. Our gross margin was 74.0% in fiscal year 2025, and 59.99% in 2024.
- **Assets.** As of December 31, 2025, the Company had total assets of \$223,053.22, including \$60,060.13 in cash. As of December 31, 2024, the Company had \$155,511 in total assets, including \$20,285 in cash.
- **Net Loss.** The Company has had net losses of \$22,287.50 and net losses of \$274,230 for the fiscal years ended December 31, 2025 and December 31, 2024, respectively.
- **Liabilities.** The Company's liabilities totaled \$731,346.37 for the fiscal year ended December 31, 2025 and \$837,429 for the fiscal year ended December 31, 2024.

Liquidity & Capital Resources

To date, the company has been financed with \$915,600 in debt and \$75,000 in equity.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 60 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from this offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The

Company intends to raise additional capital in the future from investors. Although capital may be available for early stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Tomorrows Laundry, Co. cash in hand is \$49,000, as of April 2025. Over the last three months, revenues have averaged \$85,000/month, cost of goods sold has averaged \$21,000/month, and operational expenses have averaged \$33,000/month for an average net margin of \$31,000 per month. Our intent is to be profitable in 6 months.

Since the end of 2024, the company has implemented several operational improvements focused on profitability and efficiency. These include a significant reduction in fulfillment and 3PL costs, a lower customer return rate, revisions to shipping and returns policies, improved marketing efficiency, and higher retail pricing without negative impacts to conversion or customer acquisition costs. The company also operates without a physical office, has reduced overhead, and streamlined its technology stack. As a result, the business reached EBITDA profitability in 2025 and is operating at a leaner, more efficient run rate.

Over the next 3-6 months (Jan-Jun 2026), we expect average monthly net revenue of approximately \$140,000-\$150,000. Operating expenses are expected to average approximately \$85,000-\$90,000 per month as we scale marketing spend alongside revenue growth. Cost of goods sold is expected to remain consistent as a percentage of revenue based on our current margin profile. The business is currently revenue-generating, with profitability increasing as revenue scales.

The business is already EBITDA profitable in 2025 and based on our funded-case projections, we remain EBITDA profitable throughout 2026, with margins expanding as revenue scales. We expect to be net profitable in 2026. Based on our current model, funding of approximately \$300-\$350k will support our growth and path to profitability. Profitability is driven by materially lower logistics costs, reduced marketing costs, improved marketing efficiency, higher average order values, disciplined pricing, and a lean operating structure with no fixed office overhead.

In addition to the WeFunder Reg C raise, the company has multiple sources of capital and liquidity:

Existing operating cash flow from a EBITDA-profitable core business
Existing revolving and term credit facilities used for working capital
A committed \$125,000 SAFE investment

Founder support, including short-term bridge financing when needed

Because the business is operating at positive EBITDA, short-term burn is limited and primarily tied to inventory timing rather than structural losses. Any temporary working capital gaps are covered through operating cash flow, existing credit facilities, and founder support as needed.

No matters are required to be disclosed with respect to events relating to any affiliated issuer that occurred before the affiliation arose if the affiliated entity is not (i) in control of the issuer or (ii) under common control with the issuer by a third party that was in control of the affiliated entity at the time of such events.

OTHER MATERIAL INFORMATION

31. In addition to the information expressly required to be included in this Form, include:

- (a) any other material information presented to investors; and
- (b) such further material information, if any, as may be necessary to make the required statements, in the light of the circumstances under which they are made, not misleading.

The Lead Investor. As described above, each investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by WeFunder Inc. and the identity of the initial Lead Investor will be disclosed to investors before investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by WeFunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by WeFunder Inc. The identity of the Successor Lead Investor will be disclosed to investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, WeFunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of WeFunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of investors. It is, however, possible that, in some limited circumstances the Lead Investor's interests could diverge from the interests of investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through WeFunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. If applicable, the Company may also be required to pay WeFunder certain fees for the preparation of tax filings. Such fees and the Company's obligation to deliver required tax documents are further specified in the related Tax Services Agreement ("TSA").

Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

Potential Dissolution of the SPV. The Company has agreed that it will pay an administrative fee and / or certain tax fees to WeFunder, in addition to delivering required tax information in the manner prescribed by the TSA, where applicable. Failure to pay such fees or provide WeFunder with required tax information could result in the dissolution of the SPV (an "SPV Dissolution Event"). Subsequent to an SPV Dissolution Event, the securities held by the SPV would be distributed directly and proportionally to the individual investors. This could create administrative complexities, as investors would need to manage the securities themselves rather than having them held and administered by the SPV. Additionally, the unplanned distribution of securities may not align with investors' intended investment strategy or asset allocation.

Upon an SPV Dissolution Event, the investor hereby consents to and agrees to accept direct assignment of the SPV's rights and obligations under any investment agreements between the SPV and the Company that is located in the Form C or C/A offering materials. The investor acknowledges they will be bound by all terms and conditions of such agreements as if they were an original party thereto.

4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
