Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Van der BILT Labs LLC, operating under the brand name BILT Nutraceuticals, is a wellness company focused on developing, marketing, and distributing premium, science-backed dietary supplements. The company's mission is to simplify modern health management by offering high-quality nutraceutical products that target specific health functions and are formulated with evidence-based ingredients. BILT Nutraceuticals was established with the objective of bridging the gap between pharmaceutical rigor and consumer wellness. The company's formulations are designed through a structured ingredient selection process that combines clinical research, market analysis, and global regulatory compliance. Each product or “collection” within the BILT portfolio addresses a specific health domain — such as metabolic support, immune function, cognitive balance, digestive health, and women's wellness — and contains distinct products working synergistically toward that functional goal. The company's short- and medium-term objectives are to build a strong foundation in the U.S. nutraceutical market while maintaining a globally scalable model. Initial efforts are directed toward the finalization of product formulations, supplier relationships, and manufacturing partnerships with GMP-certified facilities. BILT plans to position its products in the premium segment of the market, emphasizing clean formulations, transparent sourcing, and sustainable packaging. The company also intends to maintain flexibility to adapt its product lines to the evolving regulatory environment, consumer preferences, and scientific developments within the nutraceutical field. BILT Nutraceuticals intends to reach its objectives through a combination of brand-building, strategic partnerships, and digital distribution. The company's marketing approach focuses on credibility, education, and design clarity — aiming to build consumer trust through consistency and transparency rather than aggressive promotion. The company plans to utilize a direct-to-consumer model through its own e-commerce platform, complemented by selected retail and practitioner channels as relationships mature. Monetization will occur primarily through the sale of dietary supplements in capsule,

powder, and oil-based formats, as well as through recurring subscription models that support long-term customer retention. Over time, BILT may explore adjacent revenue streams such as international licensing, cross-brand collaborations, or data-driven personalization of supplement plans. The company does not currently rely on any single revenue source and intends to maintain a diversified product offering across multiple health categories to mitigate risk. The BILT leadership team combines expertise in nutraceutical formulation, regulatory compliance, and premium consumer brand development. The company's operational framework prioritizes quality assurance and transparency across every step of the supply chain. All formulations are developed with the intent of meeting or exceeding relevant standards established by the U.S. Food and Drug Administration (FDA) for dietary supplements, while also considering international regulatory guidelines to enable future market expansion. In the longer term, BILT Nutraceuticals seeks to become a trusted brand in the global premium supplement segment by maintaining disciplined growth, rigorous product development standards, and a responsible approach to science and marketing. The company recognizes that market success will depend on execution, consumer acceptance, and continued operational efficiency. BILT's business strategy reflects a balance between scientific integrity, commercial scalability, and brand credibility. While the company cannot predict future results, its intent is to create a durable platform that aligns profitability with measurable consumer benefit and long-term brand equity.

BILT Nutraceuticals currently has 3 employees.

7. Material factors that make an investment in Van der BILT Labs LLC speculative or risky:

1. **Dependence on Parent Company Relationship** The Company operates as a subsidiary of its parent company, and its business activities, financial performance, and strategic direction may be significantly influenced by the parent's decisions. While this relationship provides access to shared resources, infrastructure, and brand recognition, it also creates a dependency that could pose risks to investors. If the parent company were to experience financial difficulties, undergo a change in ownership, alter its strategic priorities, or discontinue its support, the Company's operations could be adversely affected. Additionally, any potential conflicts of interest between the parent company and the subsidiary—such as differing goals regarding capital allocation, governance, or future business direction—could impact the subsidiary's ability to operate independently or in the best interest of its shareholders.
2. **Regulatory Risk.** The nutraceutical and dietary supplement industry is subject to extensive and evolving regulation by the U.S. Food and Drug Administration (FDA), Federal Trade Commission (FTC), and other authorities. Changes in regulatory interpretation, labeling requirements, or enforcement actions could adversely affect operations or product viability.

3. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
4. Market Competition. The industry is characterized by intense competition, frequent product innovation, and low barriers to entry. Competitors with greater resources may adversely affect the Company's ability to achieve or maintain market share.
5. Supply Chain and Ingredient Risk. The Company's operations depend on the availability and cost of raw materials and ingredients. Supply disruptions, import/export restrictions, or cost fluctuations could negatively affect profitability.
6. We are dependent on general economic conditions. Potential customers may be less willing to invest in innovation and forward-looking improvements if they are facing an economic downturn. This may temporarily reduce our market size. Furthermore, a global crisis might make it harder to diversify.
7. Our ability to succeed depends on how successful we will be in our fundraising efforts. We rely on investment funds in order to use resources to build the necessary tech and business infrastructure to be successful in the long-term. In the event of competitors being better capitalized than we are, that would give them a significant advantage in marketing and operations.
8. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an investment in a mature business where there is a track record of revenue and income, the success of a startup or early-stage venture often relies on the development of a new product or service that may or may not find a market. The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. The Company may also end the Offering early; if the Offering reaches its target offering amount after 21-calendar days but before the deadline, the Company can end the Offering with 5 business days' notice. This means your failure to participate in the Offering in a timely manner, may prevent you from being able to participate – it also means the Company may limit the amount of capital it can raise during the Offering by ending it early.

12. *The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.*

Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

13. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.*

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. This lack of information could put Investors at a disadvantage in general and with respect to other security holders.

15. *The shares of Securities acquired upon the Offering may be significantly diluted as a consequence of subsequent financings.*

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

16. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The availability of capital is at least partially a function of capital market conditions that are beyond the control of the Company. There can be no assurance that the Company will be able to predict accurately the future capital requirements necessary for success or that additional funds will be available from any source. Failure to obtain such financing on favorable terms could dilute or otherwise severely impair the value of the investor's Company securities.

17. *There is no present public market for these Securities and we have arbitrarily set the price.*

The offering price was not established in a competitive market. We have arbitrarily set the price of the Securities with reference to the general status of the securities market and other relevant factors. The Offering price for the Securities should not be considered an indication of the actual value of the Securities and is not based on our net worth or prior earnings. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

18. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the Company cannot predict whether the Company will successfully effectuate the Company's current business plan. Each prospective Investor is encouraged to carefully analyze the risks and merits of an investment in the Securities and should take into consideration when making such analysis, among other, the Risk Factors discussed above.

The Offering

Van der BILT Labs LLC ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$250,000 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

In the event The Company fails to reach the offering target of \$10,000, any investments made under the offering will be cancelled and the investment funds will be returned to the investor.

All offering proceeds will be directed to the subsidiary, Van Der BILT Labs LLC for use in its business activities. The parent company, BILT Groupe, will not use or benefit from the funds raised in this offering. The breakdown is expected to be as follows: Product and R&D 10% (better delivery systems for increased bioavailability) Sales and Marketing 33% (Shopify launch, online marketing, luxury spa channel) Operations 52% (overheads, inventory, logistics, COGS, financial & legal costs, etc.) Fundraising fees, Netcapital 4.9%

10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on Netcapital to purchase securities, both investors and Van der BILT Labs LLC must agree that a transfer agent, which keeps records of our outstanding Membership Units (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). Similar to other online investment accounts, the transfer agent will give investors access to a web site to see the number of Securities that they own in our company. These Securities will be issued to investors after the deadline date for investing has passed, as long as the targeted offering amount has been reached. The transfer agent will record the issuance when we have received the purchase proceeds from the escrow agent who is holding your investment commitment.

11. How can an investor cancel an investment commitment?

You may cancel an investment commitment for any reason until 48 hours prior to the deadline identified in the offering by logging in to your account with Netcapital, browsing to the Investments screen, and clicking to cancel your investment commitment. We are issuing Securities at an offering price of \$0.70 per share.

14. Do the securities offered have voting rights?

The Securities are being issued with voting rights. However, so that the crowdfunding community has the opportunity to act together and cast a vote as a group when a voting matter arises, a record owner will cast your vote for you. Please refer to the record owner agreement that you sign before your purchase is complete.

15. Are there any limitations on any voting or other rights identified above?

You are giving your voting rights to the record owner, who will vote the Securities on behalf of all investors who purchased Securities on Netcapital.

16. How may the terms of the securities being offered be modified?

Any provision of the terms of the Securities being offered may be amended, waived or modified by written consent of the majority owner(s) of the Company. We may choose to modify the terms of the Securities before the offering is completed. However, if the terms are modified, and we deem it to be a material change, we need to contact you and you will be given the opportunity to reconfirm your investment. Your reconfirmation must be completed within five business days of receipt of the notice of a material change, and if you do not reconfirm, your investment will be canceled and your money will be returned to you.

While this section provides context regarding the relationship between the entities, the financial condition presented reflects only the operations and financial positions of the subsidiary, Van Der BILT Labs LLC. The parent company's financials are not included and should not be relied upon as indicative of the subsidiary's performance. The Company is a wellness company focused on developing, marketing, and distributing premium, science-backed dietary supplements. The company's mission is to simplify modern health management by offering high-quality nutraceutical products that target specific health functions and are formulated with evidence-based ingredients. Since Inception, the Company has exclusively relied on funding from the parent company for covering start-up expenses. As of December 31, 2024, the Company produced no cash flow from operations and it may incur losses prior to generating positive working capital. These matters raise substantial concern about the Company's ability to continue as a going concern unless it can raise capital. During the next twelve months, the Company intends to fund its operations by a crowdfunding campaign and from funding from an affiliate company. If the Company cannot secure the required capital to operate its business, it may cease operations.
