Business and Anticipated Business Plan

Business of the issuer and the anticipated business plan

Overview:

Renewables is dedicated to developing the e2T, an affordable, solar-electric mini tractor designed to address the challenges faced by small farms. Our mission is to enhance productivity, profitability, and sustainability in agriculture by providing an automation ready, remote control, zero-emission, low-maintenance solution that operates quietly and efficiently without physical stress and has compatibility with implements from legacy machines. Targeting small to medium-sized farms and landscape operations, our business model revolves around direct sales and partnerships with agricultural distributors and municipalities. The e2T is particularly appealing due to its ability to be charged from on-site solar installations providing energy independence and reducing operational costs. Investors may find opportunity in the growing market for sustainable equipment solutions, our unique offering that prioritizes soil and operator health and our planned expansion of production facilities to meet increasing demand in the \$4B light equipment market.

Competitors and Industry:

Industry: The agricultural and landscape equipment markets are experiencing significant growth, driven by the increasing adoption of sustainable practices like regenerative agriculture and emission reduction targets. The demand for low-emission and efficient equipment is rising as farmers and municipalities seek to mitigate the impacts of climate change. With a greater emphasis on sustainability and productivity, the market is expected to expand as equipment operators look for alternatives to traditional diesel-powered machines.

Competitors: Major competitors include: Tilmor, BCS, and Gillaro. These companies offer small gas or diesel walk-behind tractors that are noisy, polluting and physically stressful to operate. There are also a few electric options like Farm Ng and HandE but they are much more expensive. and do not accept existing implements. Renewables differentiates itself through the e2T's affordability, low-maintenance design, and versatility, making it a compelling choice for farmers and municipalities concerned about rising cost of fuel and maintenance.

Current Stage and Roadmap

Current Stage: Renewables is in the production prototype validation phase. We developed and tested the Gen1 e2T prototypes last year. We incorporated what we learned from Gen 1 and Gen 2 into the production prototype that we are now validating. We are now have components for the first 50 production units. The company has successfully self-funded its operations with the addition of \$200,000 from a Cf raise concluded on February 18. Going into production will require more outside investment so we are now initiating a second crowdfunding campaign to transition to full-scale production.

Future Roadmap: We finalized our production model and finish local testing, at the end 2025. Medium-term goals include scaling production to 200 units in 2026, followed by 400 units in 2027, while also expanding research and development efforts (please note these timelines are subject to change based on meeting fundraising goals). Looking ahead, we plan to establish production facilities in multiple regions, including potential expansions into Central and South America to further increase manufacturing capacity. The units are compact and have relatively few components so assembly can be done wherever there is a demand.

Market Opportunity:

Agriculture and land management represent multi-billion-dollar opportunities ripe for disruption. From a \$200B global ag machinery market to \$170B landscaping, \$10B+ municipal fleets, and emerging \$13B solar O&M, the need for affordable, zero-emission equipment is accelerating worldwide. The e2T is uniquely positioned to capture this demand—bringing automation and clean power to markets traditionally locked into diesel.

Traction:

Our traction speaks for itself: 200+ inquiries resulting from our social media engagement , confirmed pre-orders before launch, distributor and dealer interest, and successful farm testing . With unsolicited investor interest already on the table, we are entering production with both proven demand and clear pathways to scale across farming, municipalities, and beyond.

In particular, we are dependent on our managers. The loss of the Managers, the Principals or any other key personnel could harm the Company's business, financial condition, cash flow and performance. Therefore, if any of these personnel die or become disabled, the Company will not receive any compensation to assist with such person's absence. The loss of such person could negatively affect the Company and our operations. We have no way to guarantee key personnel will stay with the Company, as many states do not enforce non-competition agreements, and therefore acquiring key man insurance will not ameliorate all of the risk of relying on key personnel.

Any incident that erodes confidence in our brand could significantly reduce the Company's value and damage our business. We may be adversely affected by any negative publicity, regardless of its accuracy. Also, there has been a marked increase in the use of social media platforms and similar devices, including blogs, social media websites and other forms of internet-based communications that provide individuals with access to a broad audience. The availability of information on social media platforms is virtually immediate as is its impact. Information posted may be adverse to our interests or may be inaccurate, each of which may harm our performance, prospects or business. The harm may be immediate and may disseminate rapidly and broadly, without affording us an opportunity for redress or correct.

Risks Related to the Offering

The U.S. Securities and exchange Commission does not pass upon the merits of the Securities or the terms of the Offering, nor does it pass upon the accuracy or completeness of any Offering document or literature.

You should not rely on the fact that our Form C is accessible through the U.S. Securities and Exchange Commission's EDGAR filing system as an approval, endorsement or guarantee of compliance as it relates to this Offering. The U.S. Securities and Exchange Commission has not reviewed this Form C, nor any document or literature related to this Offering.

Neither the Offering nor the Securities have been registered under federal or state securities laws.

No governmental agency has reviewed or passed upon this Offering or the Securities. Neither the Offering nor the Securities have been registered under federal or state securities laws. Investors will not receive any of the benefits available in registered Offerings, which may include access to quarterly and annual financial statements that have been audited by an independent accounting firm. Investors must therefore assess the adequacy of disclosure and the fairness of the terms of this Offering based on the information provided in this Form C and the accompanying exhibits.

The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.

Unless the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the use of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

The Company has the right to limit individual Investor commitment amounts based on the Company's determination of an Investor's sophistication.

Investors should understand the potential for dilution. The investor's stake in a company could be diluted due to the company issuing additional shares. In other words, when the company issues more shares, the percentage of the company that you own will go down, even though the value of the company may go up. You will own a smaller piece of a larger company. This increase in number of shares outstanding could result from a stock offering (such as an initial public offering, another crowdfunding round, a venture capital round, angel investment), employees exercising stock options, or by conversion of certain instruments (e.g., convertible bonds, preferred shares or warrants) into stock. If the company decides to issue more shares, an investor could experience value dilution, with each share being worth less than before, and control dilution, with the total percentage an investor owns being less than before. There may also be earnings dilution, with a reduction in the amount earned per share (though this typically occurs only if the company offers dividends, and most early-stage companies are unlikely to offer dividends, preferring to invest any earnings into the company)

19. How could the exercise of rights held by the principal owners identified in Question 5 above affect the purchasers of Securities being offered?

The holder of a majority of the voting rights in the company may make decisions with which you disagree, or that negatively affect the value of your investment in the company, and you will have no recourse to change those decisions. Your interests may conflict with the interests of other investors, and there is no guarantee that the company will develop in a way that is advantageous to you. For example, the majority shareholder may decide to issue additional shares to new investors, sell convertible debt instruments with beneficial conversion features, or make decisions that affect the tax treatment of the company in ways that may be unfavorable to you. Based on the risks described above, you may lose all or part of your investment in the securities that you purchase, and you may never see positive returns.

20. How are the securities being offered valued? Include examples of methods for how such securities may be valued by the issuer in the future, including during subsequent corporate actions.

The issuer is raising this Regulation Crowdfunding round at a \$7,213,208 pre-money valuation, when including outstanding options. Including outstanding options, the fully diluted pre-money valuation is \$7,713,208.

The securities being offered are valued at the issuer's discretion. An early-stage company typically sells its shares (or grants options over its shares) to its founders and early employees at a very low cash cost, because they are, in effect, putting their "sweat equity" into the company. When the company seeks cash investments from outside investors, like you, the new investors typically pay a much larger sum for their shares than the founders or earlier investors, which means that the cash value of your stake is immediately diluted because each share of the same type is worth the same amount, and you paid more for your shares than earlier investors did for theirs.

There are several ways to value a company, and none of them is perfect and all of them involve a certain degree of guesswork. Any of these methods, plus others, may be used to determine valuation in the future:

Liquidation Value - The amount for which the assets of the company can be sold, minus the liabilities owed, e.g., the assets of a bakery include the cake mixers, ingredients, baking tins, etc. The liabilities of a bakery include the cost of rent or mortgage on the bakery. However, this value does not reflect the potential value of a business, e.g., the value of the secret recipe. The value for most startups lies in their potential, as many early-stage companies do not have many assets.

Book Value - This is based on analysis of the company's financial statements, usually looking at the company's balance sheet as prepared by its accountants. However, the balance sheet only looks at costs (i.e., what was paid for the asset), and does not consider whether the asset has increased in value over time. In addition, some intangible assets, such as patents, trademarks or

trade names, are very valuable but are not usually represented at their market value on the balance sheet.

Earnings Approach - This is based on what the investor will pay (the present value) for what the investor expects to obtain in the future (the future return), taking into account inflation, the lost opportunity to participate in other investments, the risk of not receiving the return. However, predictions of the future are uncertain and valuation of future returns is a best guess.

Different methods of valuation produce a different answer as to what your investment is worth. Typically, liquidation value and book value will produce a lower valuation than the earnings approach. However, the earnings approach is also most likely to be risky as it is based on many assumptions about the future, while liquidation value and book value are much more conservative.

Future investors (including people seeking to acquire the company) may value the company differently. They may use a different valuation method, or different assumptions about the company's business and its market. Different valuations may mean that the value assigned to your investment changes. It frequently happens that when a large institutional investor such as a venture capitalist makes an investment in a company, it values the company at a lower price than the initial investors did. If this happens, the value of the investment would go down.

The company's Certificate of Incorporation or Bylaws can be amended by the holders of a majority of the issued and outstanding shares of the Company. As minority owners, the crowdfunding investors are subject to the decisions made by the majority owners. If the company repurchases securities, so that the above risk is mitigated, and there are fewer shares of common stock outstanding, the company may not have enough cash available for marketing expenses, growth, or operating expenses to reach our goals. If we do not have enough cash to operate and grow, we anticipate the market price of our securities would decline. A sale of the company or of all of the assets of the company may result in an entire loss of your investment. We cannot predict the market value of the company or its assets, and the proceeds of a sale may not be cash, but instead, unmarketable securities, or an assumption of liabilities. It is unlikely that in the near term, a sale would result in a premium that is significant enough over book value to generate a return to our investors. We may need to negotiate with a related party for additional capital. No assurance can be given that such funds will be available or, if available, will be on commercially reasonable terms satisfactory to us. Financial Condition of the Issuer

Operations

The company is an early-stage, pre-commercial business focused on product development, which is reflected in its financial performance. In 2024, the company generated minimal revenue of approximately \$25K but incurred significant operating expenses (~\$209K), resulting in a net loss of ~\$210K.

In 2025, revenue declined to ~\$15K, indicating that the company remains largely pre-revenue or in pilot-stage commercialization. However, operating expenses increased substantially to ~\$682K, driven primarily by salaries, general and administrative costs, and other operating expenses. This led to a significantly larger net loss of ~\$661K.

Liquidity and Capital Resources

Liquidity improved materially from 2024 to 2025. At the end of 2024, the company held only ~\$4K in cash and had negative equity, reflecting limited capitalization and reliance on initial founder funding.

By the end of 2025, cash increased to ~\$102K, supported by ~\$144K in equity financing and \$50K from a related party loan. Shareholders' equity also improved to ~\$150K, reversing the prior negative position.

Capital Expenditures and Other Obligations

Capital expenditures have been relatively modest but increased in 2025. In 2024, the company invested approximately \$4.9K in fixed assets. In 2025, this increased significantly to ~\$47K, reflecting growing investment in equipment and infrastructure to support development and future production.

A key obligation is the company's operating lease, which originated in 2024 and represents a significant fixed commitment, with both short-term and long-term lease liabilities recorded on the balance sheet. The company carries minimal traditional debt, but obligations include lease liabilities and a related-party loan. These commitments, combined with ongoing operating losses, create continued pressure on cash resources.
