8. Discuss the material factors that make an investment in the issuer speculative or risky:

Area 51 Energy is a young company and has not yet established large-scale retail distribution. Our ability to generate revenue depends on expanding into major retailers and achieving sell-through velocity. If we cannot secure sufficient distribution or repeat consumer purchases, our growth may be slower than projected.

The energy drink industry though large, is dominated by established brands with substantial marketing budgets and distribution power. Competing effectively requires significant marketing spend, innovative branding, and unique flavor development. If we fail to differentiate or gain shelf space, it could limit market adoption.

We depend on third-party manufacturers, flavor houses, and packaging vendors for production. Any disruption in their operations—such as material shortages, capacity issues, or cost increases—could delay production or impact product quality, harming our brand reputation and sales.

The company's success relies heavily on its founders and small core team for brand direction, operations, and investor relations. The loss of any key team member could materially affect the company's ability to execute its business plan.

We may need to raise additional funding to support growth, marketing, and inventory purchases. There is no guarantee that future financing will be available on favorable terms, or at all. Failure to secure sufficient funding could slow or halt expansion.

Consumer preferences and market trends may shift rapidly. The energy drink market is highly trend-driven. Changes in consumer tastes, health preferences, or negative publicity around ingredients could reduce demand for our products. Failure to adapt quickly to evolving consumer expectations or regulatory changes could materially impact sales and brand perception.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Units** in the Company ("**Preferred Units**"), when and if the Company sponsors an equity offering that involves **Preferred Units**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Units**, Investors will receive a **number of shares of Preferred Units** calculated using the method that results in the greater number of **Preferred Units**:

- i. the total value of the Investor's investment, divided by
 - a. the price of **Preferred Units** issued to new Investors
- ii. if the valuation for the company is more than **\$15,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. For investors up to the first **\$250,000.00** of the securities, investors will receive a valuation cap of **\$12,500,000.00**. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Units basis):

- Includes all shares of Capital Units issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Units**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Units equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Units. The Investor's right to receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Units);
- ii. On par with payments for other Safes and/or Preferred Units, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Units, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Units in proportion to the full payments that would otherwise be due; and
- iii. Senior to payments for Common Units.

VIP Bonus

Area 51 Energy will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
 - A. the Purchase Amount may not be amended, waived or modified in this manner,
 - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and

The Company has not yet authorized Preferred units, which investors in the SAFE (if converted) will receive. Preferred units have liquidation preference over common units.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

Overview

The Next-Generation Energy Drink for Gamers, Athletes, and Dreamers.

The Company plans to generate revenue through the sale of its branded energy drink, Area 51 Energy, via both retail distribution and e-commerce channels.

Milestones

Alien Beverages LLC dba. Area 51 Energy was organized in the State of Texas in September 2023.

Since then, we have:

- Built by former leaders at Pepsi, Celsius, Rockstar (\$3.4B Exit), and Alani (\$1.8b exit)
- 2026 Retail Launch: Robust pipeline with several major US retailers
- \$25B+ Market; US Energy drinks are projected to reach \$33B by 2028
- Category-Defining Formula; 360° Functional Energy: 0 Sugar, Lion's Mane, Prebiotics, & Nootropics
- Distribution Secured: Signed LOI with major Anheuser-Busch Distributor
- Great Margins: Projected 48%+ gross margins on early retail rollout
- Clear Path to \$2m+ Revenue by 2026 (not guaranteed)

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was organized in September 2023 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2024, the Company had revenues of \$0 compared to the year ended December 31,

- *Assets.* As of December 31, 2024, the Company had total assets of \$28,841, including \$0 in cash. As of December 31, 2023, the Company had \$23,233 in total assets, including \$0 in cash.
- *Net Loss.* The Company has had net losses of \$1,952 and net losses of \$12,594 for the fiscal years ended December 31, 2024 and December 31, 2023, respectively.
- *Liabilities.* The Company's liabilities totaled \$43,387 for the fiscal year ended December 31, 2024 and \$35,827 for the fiscal year ended December 31, 2023.

Liquidity & Capital Resources

To date, the Company has been financed with \$25,886 in debt and approximately \$100K in capital contributions from the founders.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 9 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Alien Beverages LLC dba. Area 51 Energy cash in hand is \$46,960, as of November 2025. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$13,333/month, and operational expenses have averaged \$15,000/month, for an average burn rate of \$28,333 per month. Our intent is to be profitable in 12 months.

Over the past 10 months, we've restructured our supply chain and manufacturing partnerships to achieve more favorable terms, improved production timelines, and greater cost efficiency. These changes significantly enhanced our gross margin potential and long-term scalability. Operationally, we secured new distribution partnerships and expanded retail coverage, including onboarding H-E-B and a new regional distributor to support our 2025-26 rollout. We also invested in marketing and sampling initiatives to support these new channels and accelerate brand awareness in key Texas markets.

We expect moderate revenue growth as we transition from pre-launch to early retail activation, driven by initial purchase orders from H-E-B and distributor accounts. Over the next 3-6 months, we anticipate revenues in the range of \$150K-\$250K, with expenses in the range of \$200-300k, dependent on funding.

If additional capital is raised through this offering, the funds will be used to scale production and support retail marketing programs. We expect consistent monthly revenue growth beginning in Q2 2026 as store counts and velocities increase.

The company is not yet profitable, as we are still in the early commercialization and growth stage. Our primary focus is on scaling distribution and brand awareness before optimizing for profitability. Based on current projections, we expect to reach breakeven at approximately \$1.5 million in annual revenue, which we anticipate achieving by mid-late 2026 with expanded retail distribution and repeat sales. We estimate an additional \$500K-\$750K in funding will be needed to reach that point, mainly to cover production runs, trade marketing, and operational expansion.

To date, Area 51 Energy has been primarily funded through founder capital contributions, partner loans, and reinvested revenues from early distribution sales. We also maintain access to a partner lines of credit that can be used for short-term liquidity if needed.

In the short term, we are managing burn conservatively through tight inventory planning, deferred founder compensation, and negotiated vendor terms that minimize upfront cash requirements. Our monthly burn rate remains lean and focused on essential growth activities such as production and retail marketing.

We anticipate that funds raised through this Wefunder campaign will enable us to scale production for upcoming purchase orders, expand retail presence, and bridge to profitability over the next 12-18 months.

All projections in the above narrative are forward-looking and not guaranteed.

The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have

not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. If applicable, the Company may also be required to pay Wefunder certain fees for the preparation of tax filings. Such fees and the Company's obligation to deliver required tax documents are further specified in the related Tax Services Agreement ("TSA").

Potential Dissolution of the SPV. The Company has agreed that it will pay an administrative fee and / or certain tax fees to Wefunder, in addition to delivering required tax information in the manner prescribed by the TSA, where applicable. Failure to pay such fees or provide Wefunder with required tax information could result in the dissolution of the SPV (an "SPV Dissolution Event"). Subsequent to an SPV Dissolution Event, the securities held by the SPV would be distributed directly and proportionally to the individual investors. This could create administrative complexities, as investors would need to manage the securities themselves rather than having them held and administered by the SPV. Additionally, the unplanned distribution of securities may not align with investors' intended investment strategy or asset allocation.

Upon an SPV Dissolution Event, the Investor hereby consents to and agrees to accept direct assignment of the SPV's rights and obligations under any investment agreements between the SPV and the Company that is located in the Form C or C/A offering materials. The Investor acknowledges they will be bound by all terms and conditions of such agreements as if they were an original party thereto.
