Our Liquor License Application May Be Denied or Delayed.

Because the prior bar at this location had its liquor license revoked, there is a risk that the California Department of Alcoholic Beverage Control ("ABC") may deny, delay, or impose restrictive conditions on our liquor license application. Without a valid license, we will be unable to serve alcoholic beverages, which represent a primary source of anticipated revenue. Any delay or denial could materially impair our ability to operate profitably or at all.

Extensive Code Compliance and Infrastructure Work Is Required Before We Can Open.

We are effectively rebuilding the venue from its four walls, including bringing the building fully up to code with new electrical, plumbing, and fire suppression systems. These upgrades are necessary to obtain a certificate of occupancy and reopen to the public. Unforeseen structural issues, permitting delays, or new compliance requirements could significantly increase costs or postpone our opening.

Renovation and Construction Costs May Exceed Our Budget.

Our renovation plan includes major capital improvements—such as new bathrooms, patio expansion, sprinkler systems, and a complete lighting and sound overhaul. Construction and permitting costs in California are volatile and may exceed current estimates due to inflation, material shortages, or contractor delays. Any cost overrun could require additional financing or cause us to scale back our build-out, delaying operations or impacting the quality of the final venue

Our Ability to Operate Depends on City Approval of Our Planned Capacity.

Our financial projections assume approval for a capacity of approximately 720 patrons. If the City of Cathedral City approves a lower capacity or imposes occupancy restrictions, our revenue potential may be significantly reduced, limiting profitability and our ability to make investor repayments as planned

The Hospitality and Nightlife Industry Is Highly Competitive and Subject to Economic Cycles.

We will operate in a competitive market that includes numerous bars, clubs, and event venues in Palm Springs and the greater Coachella Valley. Our success depends on maintaining customer loyalty and delivering a distinctive experience. Economic downturns, shifts in tourism trends, or decreased discretionary spending could materially reduce patronage and revenue.

Seasonality and Tourism Trends Could Affect Our Financial Performance.

Palm Springs and Cathedral City experience strong seasonal fluctuations tied to tourism, weather, and event calendars. Patronage may be significantly higher during peak event seasons (e.g., Pride, White Party, Coachella) and substantially lower during off-peak months. This variability may result in uneven revenue streams and cash flow challenges throughout the year.

Community and Cultural Sensitivity Risks. Eagle Cathedral City will serve a diverse but niche community within the broader hospitality market. Changes in local social dynamics, public sentiment toward LGBTQ+ nightlife, or misunderstanding of our brand identity could impact attendance or subject us to unwelcome scrutiny. Managing these sensitivities responsibly is vital to sustaining a positive public image and long-term viability.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The company is issuing promissory notes to investors. The principal amount of each note is the amount invested by the investor. The company will use **10% of its gross revenues** to pay back principal on the notes. Each note will be paid back based on its pro rata share of all notes issued in this offering. The company will make interest payments to the investor quarterly. The company may prepay principal and interest at any time. The company will continue payments until investors have received **2.0x their principal investment (the repayment amount)**, provided however that at any time the company may defer up to 1 such payments upon notice to the Lender.

Investors in the **first \$100,000.00** of the fundraiser will **receive 2.2x their principal**. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met. Therefore, the company could potentially offer all \$1,235,000.00 at 2.2x their principal.

Upon the occurrence of an event of default (as defined in each note), all unpaid principal, accrued interest and other amounts owing will automatically be immediately due, payable and collectible by the company pursuant to applicable law.

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect gross revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, the shareholders may make decisions with which the Investor disagrees, or that negatively affect the gross revenues of the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the shareholders may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The shareholders may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The shareholders have the right to redeem their securities at any time. Shareholders could decide to force the Company to redeem their securities at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

An Investor in the promissory notes holds no position in the Company and will have no voting rights in the Company, and thus will be limited as to its ability to control or influence the governance and operations of the Company.

Overview

THE PREMIER LEATHER BAR AND NIGHTLIFE DESTINATION FOR GAY MEN IN PALM SPRINGS.

The Company is developing a bar and nightclub venue, with its initial revenue derived from the sale of branded merchandise. The management team plans to expand its revenue streams to include hosting events, serving alcoholic beverages, charging cover fees, and offering locker rentals for guests. As of October 2025, the premises are undergoing major renovations in preparation for the grand opening, which is scheduled for February 2026.

Milestones

Eagle Cathedral City, Limited was organized in the State of California in May 2025.

Since then, we have:

- Eagle CC's momentum is soaring, with 4,700+ Insta followers in just a few months and growing daily.
- On the very first day our website was live, over 1,000 enthusiastic people joined our email list!
- We're investing in an iconic gay space, making it Palm Springs' premier leather and nightlife spot.
- Enthusiasm for the Eagle is huge, with messages from DJs, promoters, and excited patrons worldwide.
- Palm Springs lacks a nightclub exclusively for gay men to gather without judgment or onlookers.
- We're passionate locals dedicated to bringing something fresh and exciting to the community.
- We will stay true to the Eagle vibe in our atmosphere and decor.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was organized in May 2025 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2025, the Company had revenues of \$35,679. Our gross margin was 83.7% for the period ending December 31, 2025.
- *Assets.* As of December 31, 2025, the Company had total assets of \$1,452,586 including \$961,745 in cash.
- *Net Loss.* The Company has had net losses of \$102,191 through December 31, 2025.
- *Liabilities.* The Company's liabilities totaled \$265,016 through December 31, 2025.

Liquidity & Capital Resources

To-date, the company has been funded through \$563k in capital contributions from the founders.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive

any investments from investors.

Runway & Short/Mid Term Expenses

Eagle Cathedral City, Limited cash in hand is \$818,879.56, as of April 2026. Over the last three months, revenues have averaged \$8,595.91/month, cost of goods sold has averaged \$4,500/month, and operational expenses have averaged \$2,666.67/month, for an average net margin of \$1,429.24 per month. Our intent is to be profitable in 6 months.

Eagle Cathedral City, Limited, is currently in the pre-launch and construction phase of our primary business model, which is operating a full-service nightclub. We are currently executing the build-out of our venue and are not yet open for daily or weekly nightclub operations.

Because our primary venue is under construction, our historical financial results are not representative of what investors should expect in the future.

Currently, our operations are limited to brand-building and initial fundraising activities. We are generating preliminary revenue through the sale of branded merchandise and by hosting monthly promotional events. These events and merchandise sales are primarily designed to raise early capital, build local market awareness, and establish a customer base prior to our official grand opening.

Once construction is complete and the nightclub is open for regular business, our business model and revenue streams will shift significantly. We anticipate that our future revenue will be driven primarily by high-margin alcohol sales, cover charges, locker rentals, and merchandise sales. Therefore, the revenue and expenses currently reflected in our financial statements are strictly related to our pre-launch phase and do not reflect the financial performance or operational scale of the completed nightclub.

To date, we have funded our construction and operational expenses through founder capital contributions and proceeds from a Regulation Crowdfunding campaign hosted on Wefunder.

We are conducting this Regulation Crowdfunding offering to secure the additional capital necessary to complete the final phases of construction, and fund our grand opening marketing budget. If we raise \$100,000.00, we believe we will have sufficient capital to open the venue and reach revenue-generating status. If we do not raise sufficient funds through this offering, we will need to rely on continued merchandise sales, founder capital contributions, monthly event revenue, and potentially seek outside loans or alternative financing to complete construction.

Over the next 6 months we plan to spend a large amount of capital to renovate and bring the property up to code in order to be able for business. We anticipate this costing \$400-500k. In total, we will need \$1.3M in funding to open the bar and start generating revenue. The founders have already contributed approximately \$563k which has been spent on demolition, liquor license, HVAC, etc.

We are not profitable yet. We expect to reach profitability as soon as we open based on initial demand. We don't expect to need any additional funding to reach profitability.

All projections in the above narrative are forward-looking and not guaranteed.
