Risk 1 – Product and AI Development Delays: Bespoke platform and AI feature delivery may slip due to technical uncertainty, data-readiness gaps, vendor/infrastructure constraints, and execution complexity. Key exposures include unstable model performance in production, integration friction across services, scope creep from evolving requirements, talent bandwidth constraints, rising compute costs, and compliance/security reviews that extend timelines. Delays at any of these layers can compound, leading to rework, budget overruns, missed launch windows, and reduced user trust.

Risk 2 – Market Adoption Is Not Guaranteed: Demand and willingness to pay may be uneven between India and the U.S. due to different price anchors, purchasing power, and trust in AI-led coaching versus human services. Conversion can be dampened by strong local substitutes (free content, low-cost tutors), misaligned pricing/packaging by segment (students/early career vs. mid-career), payment frictions (UPI vs. cards), and localization gaps in content and support. If ICP targeting or value messaging misses, CAC rises, LTV falls, and churn increases—slowing payback and constraining growth.

Risk 3 – Reliance on Coaching Partners and Creators: Delivery depends on external coaches/creators whose availability, quality, and brand alignment can fluctuate. Risks include inconsistent coaching outcomes, content that drifts from RISEUP standards, sudden churn (due to competing offers or burnout), uneven supply across time zones/skills, and disputes over IP, revenue share, or exclusivity. Dependency on a few high performers heightens fragility; any lapse can erode user trust, spike refunds/support load, and stall scalable growth.

Risk 4 – Dependence on Language Localization Quality: Adoption in target segments may stall if Hindi and Spanish experiences feel translated rather than native. Risks include dialect and regional mismatches, such as Hinglish versus formal Hindi and Latin American Spanish versus U.S. Spanish; incorrect career terminology; awkward tone in coaching prompts; and product copy that breaks layout or misstates intent. Gaps in voice and captions, search and SEO keywords, and support scripts can further erode trust. Any mistranslation, especially around career law or DEI topics, can appear insensitive or misleading, which lowers conversion rates, increases refunds and support tickets, and encourages negative word of mouth.

Risk 5 – Regulatory and Data Privacy Requirements: Compliance across the United States and India may shift as laws on data protection, payments, learning services, accessibility, and AI safety evolve. New or stricter rules can require changes to data flows, consent management, storage locations, age verification, identity checks, KYC and AML reviews, and content moderation. Meeting these standards can involve legal reviews, vendor assessments, security controls, and audits, which raise costs and extend release timelines. Noncompliance can trigger penalties, forced feature changes, integration pauses with payment processors, and loss of user trust.

Risk 6 – Long-Term CEO Outlook: Leadership capacity is intentionally lean until traction and funding justify a full-time CEO. During this period, Dr. Deepak Bhootra serves part-time, supported by advisors and domain experts. This can slow down prioritization and decision-making, dilute day-to-day accountability, and create gaps in cross-functional coordination, partner engagement, and investor communications. It also introduces key person risk and context switching fatigue, which can extend execution timelines and reduce consistency in goal ownership and follow through.

Risk 7 – Competition and Market Fragmentation: Career technology is crowded and fragmented across geographies, price points, and use cases. Users can choose from global platforms, local coaching boutiques, creator led courses, university certificates, job boards, and social networks. Switching costs are low, and features are easy to copy. Noise in channels like SEO, YouTube, and Instagram raises acquisition costs and makes differentiation harder. Incumbents may lock in partnerships, sponsors, or exclusive creators. The result can be higher customer acquisition costs, pressure on pricing, slower trust-building, and a longer path to product-market fit.

File C – Business Description, Issuance, and Capitalization to a crowdfunding platform

Risk 6 - Economic Downturn Impacting Subscriptions: in a recession or hiring slowdown, consumers and small teams cut discretionary learning spend, compare lower cost substitutes, and delay renewals. Price sensitivity rises, trial to paid conversion falls, and existing users downgrade, pause, or churn. Enterprise and university partners may freeze budgets, lengthen procurement cycles, or shift to annual reviews, which slows pipeline velocity and cash collection. Currency swings between the U.S. dollar and the Indian rupee can also reduce realized revenue and increase payment friction, further pressuring growth.

Deepak Bhootra is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Interest Rate: 6.0%. Interest shall commence with the date of the convertible note and shall continue on the outstanding principal amount until paid in full or converted. Interest shall be computed on the basis of a year of 365 days for the actual number of days elapsed. All unpaid interest and principal shall be due and payable upon request of the Majority Holders on or after the Maturity Date.

Early-Bird & VIP Investors: Investors investing in the first \$100,000.00, will receive a valuation cap of \$4,500,000.00 and a discount rate of 85.000%. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

Conversion and Repayment

(a) Conversion Upon Qualified Financing Conversion upon a Qualified Financing. In the event that the Company issues and sells its shares of equity securities to investors (the "Investors") while this Note remains outstanding in an equity financing with total proceeds to the Company of not less than \$100,000 (excluding the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)) (a "Qualified Financing"), then the outstanding principal amount of this Note and any unpaid accrued interest shall automatically convert in whole without any further action by the Holder into Equity Securities sold in the Qualified Financing at a conversion price equal to the lesser of (i) the price paid per unit for Equity Securities by the Investors in the Qualified Financing multiplied by 0.85, and (ii) the quotient resulting from dividing \$500,000 by the number of outstanding common units of the Company immediately prior to the Qualified Financing (assuming conversion of all securities convertible into common units and exercise of all outstanding options and warrants, but excluding the units of equity securities of the Company issuable upon the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)). The issuance of Equity Securities pursuant to the conversion of this Note shall be upon and subject to the same terms and conditions applicable to Equity Securities sold in the Qualified Financing. Notwithstanding this paragraph, if the conversion price of the Notes as determined pursuant to this paragraph (the "Conversion Price") is less than the price per unit at which Equity Securities are issued in the Qualified Financing, the Company may, solely at its option, elect to convert this Note into units of a newly created series of preferred unit having the identical rights, privileges, preferences and restrictions as Equity Securities issued in the Qualified Financing, and otherwise on the same terms and conditions, other than with respect to (if applicable): (i) the per unit liquidation preference and the conversion price for purposes of price-based anti-dilution protection, which will equal the Conversion Price; and (ii) the per unit dividend, which will be the same percentage of the Conversion Price as applied to determine the per unit dividends of the Investors in the Qualified Financing relative to the purchase price paid by

the investors;

(b) Conversion upon a Change of Control. If the Company consummates a Change of Control (as defined in the Convertible Note) while this Note remains outstanding, the Company shall repay the Holder in cash in an amount equal to the outstanding principal amount of this Note plus any unpaid accrued interest on the original principal. For purposes of this Note, a "Change of Control" means (i) a consolidation or merger of the Company with or into any other corporation or other entity or person, or any other corporate reorganization, other than any such consolidation, merger or reorganization in which the units of the Company immediately prior to such consolidation, merger or reorganization continue to represent a majority of the voting power of the surviving entity immediately after such consolidation, merger or reorganization; (ii) any transaction or series of related transactions to which the Company is a party in which in excess of 50% of the Company's voting power is transferred; or (iii) the sale or transfer of all or substantially all of the Company's assets, or the exclusive license of all or substantially all of the Company's material intellectual property; provided that a Change of Control shall not include any transaction or series of transactions principally for bona fide equity financing purposes in which cash is received by the Company or any successor, indebtedness of the Company is cancelled or converted or a combination thereof. The Company shall give the Holder notice of a Change of Control not less than 10 days prior to the anticipated date of consummation of the Change of Control. Any repayment pursuant to this paragraph in connection with a Change of Control shall be subject to any required tax withholdings, and may be made by the Company (or any party to such Change of Control or its agent) following the Change of Control in connection with payment procedures established in connection with such Change of Control.

(c) Procedure for Conversion. Procedure for Conversion. In connection with any conversion of this Note into units, the Holder shall surrender this Note to the Company and deliver to the Company any documentation reasonably required by the Company (including, in the case of a Qualified Financing, all financing documents executed by the investors in connection with such Qualified Financing). The Company shall not be required to issue or deliver the units into which this Note may convert until the Holder has surrendered this Note to the Company and delivered to the Company any such documentation. Upon the conversion of this Note into units pursuant to the terms hereof, in lieu of any fractional units to which the Holder would otherwise be entitled, the Company shall pay the Holder cash equal to such fraction multiplied by the price at which this Note converts.

(d) Interest Accrual. If a Change of Control or Qualified Financing is consummated, all interest on this Note shall be deemed to have stopped accruing as of a date selected by the Company that is up to 10 days prior to the signing of the definitive agreement for the Change of Control or Qualified Financing.

Senior Indebtedness

Overview

Building Career Infrastructure for Intentional Growth at Work.

The Company plans to generate revenue through operating as a digital-first career growth and post-hiring development platform designed to help professionals build clarity, confidence, and sustainable long-term career success through subscription-based digital products, AI-enhanced career tools, structured coaching programs, and community-driven learning experiences built around the RISEUP methodology.

Milestones

RISEUP AT WORK LLC was organized in the State of Texas in July 2025.

Since then, we have:

- Focused on career growth after hiring, not job search or recruitment prep
- Addresses a \$30B+ post-hiring career growth market
- Built on 20+ years of coaching experience and frameworks used by 1,500+ professionals
- Career infrastructure, not just content: strategy, accountability, and measurable outcomes
- AI-enabled tools to scale guidance without replacing the human layer
- Subscription model with coaching and institutional expansion over time
- Scholarship program expanding access for first-generation professionals and underserved communities

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was organized in July 2025 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended November 30, 2025, the Company

had revenues of \$0.

- *Assets.* As of November 30, 2025, the Company had total assets of \$2,049, including \$2,049 in cash.
- *Net Loss.* The Company has had net losses of \$20,449 through November 30, 2025.
- *Liabilities.* The Company's liabilities totaled \$0 through November 30, 2025.

Liquidity & Capital Resources

To-date, the company has been financed through approximately \$10,089 in capital contributions from the founder.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 4 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

RISEUP AT WORK LLC cash in hand is \$13,564, as of February 2026. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$2,500/month, for an average burn rate of \$2,500 per month. Our intent is to be profitable in 6 months.

RISEUP Career Studio was registered on 20 July 2025. Since then, we have focused on setting up and content creation. We have incurred specific expenses that are fully documented. However, given that we have not completed a full-year review.

Over the next three to six months following launch in Q1 2026, we expect to generate approximately \$100,000 in revenue. This figure is based on the conservative 2026 revenue projection of \$211,000 outlined in our finalized plan, with early revenue coming from paid subscriptions, AI toolkits for resumes, interviews, and LinkedIn optimization, as well as upgrades into cohort and one-to-one coaching programs. This places early monthly revenue in the \$15,000–\$20,000 range as the subscriber base begins converting from free to paid tiers. We are targeting a 50 percent gross margin. On \$100,000 of revenue during this initial operating window, direct delivery costs will be capped at \$50,000. These costs include coaching delivery tied specifically to paying users, AI inference usage, scalable hosting and platform fees directly linked to paid activity, and payment processing fees. This produces a gross profit of \$50,000 and maintains the 50 percent gross margin required for long-term scalability. Operating expenses for the same three-to-six-month period are expected to total approximately \$105,000. These expenses represent the work needed to build and operate the platform but are not tied to per-user delivery. The expected allocation includes \$40,000 for product and AI development, \$25,000 for marketing and affiliate distribution, \$25,000 for a lean core team covering content, operations, community, and technology, \$10,000 for coaching infrastructure and community operations, and \$5,000 for compliance, analytics, and the scholars program. Total operating expenses for the period are \$105,000. With gross profit of \$50,000 and operating expenses of \$105,000, the net cash burn over the next 3 to 6 months is approximately \$55,000. This is the amount of capital required to move from pre-launch into revenue-generating operations.

We are not profitable at this stage. Based on our financial model, RISEUP enters the market in Q1 2026 and begins generating revenue immediately, but we operate at a net burn during the initial scale-up period. Using our conservative revenue outlook and a 50 percent gross margin, we expect to generate approximately \$100,000 in revenue during the first three to six months post-launch, with direct delivery costs capped at \$50,000 and operating expenses of approximately \$105,000. This creates an early net burn of roughly \$55,000 as we transition from pre-launch to operating mode. To reach profitability, we require enough funding to cover both the early operating burn and the continued investment in AI development, marketing, coaching infrastructure, and core team capacity. With the Wefunder raise, the capital required to reach breakeven is approximately \$250,000. This amount enables us to: complete Phase 1 and Phase 2 of the product roadmap (resume builder, interview simulator, LinkedIn optimizer, dashboards); acquire and activate early users through marketing and affiliates; maintain a lean team to deliver core content, operations, and community infrastructure; and support coaching delivery and AI usage while keeping COGS aligned with our 50 percent margin target. We expect to reach profitability once total revenue scales beyond \$500,000 annually, which requires approximately 2,500–3,000 active paying users across subscription tiers and AI toolkit upgrades. Based on the finalized growth plan, we project reaching this level of recurring revenue in late 2027. This timeline accounts for gradual expansion across the five English-speaking launch markets, continued improvements in user conversion and retention, and the introduction of higher-value features and partnerships. In summary, we are not yet profitable. We require approximately \$250,000 in funding to reach a sustainable operating position, and we expect to achieve profitability by late 2027 as subscription, AI toolkit, and coaching revenues expand and operating leverage increases.

Outside of Wefunder, our additional sources of capital include founder investment, in kind contributions, and internal reinvestment from early revenue. The founding team has already provided the initial funding required for prototype AI development, content and curriculum creation, branding work, and core operational setup. Founders are also supplying significant non cash support in the form of product development time, coaching expertise, and strategic operations, which reduces the amount of external capital needed at this stage. We are not yet profitable. Our short term burn will be covered through three sources during the campaign period. The first source is the capital raised on Wefunder, which provides the primary working capital needed to support operating expenses while we bring the platform to market. The second source is continued founder support, which keeps payroll and vendor costs low because

substantial development and operational responsibilities remain in house. The third source is revenue from paying users, as we begin generating income immediately once the Explore and Builder tiers launch in Q1 2026. Even conservative early user conversion provides recurring monthly revenue that offsets a meaningful portion of our operating costs.

Together, these three capital sources create a stable financial structure during the pre-profit period. Wefunder provides working capital. Founder investment and in-kind contributions reduce the cost base. Early user revenue begins contributing to operating expenses from the first month of launch. This combined approach ensures that we can cover short-term burn throughout the campaign and maintain uninterrupted progress on product development, AI features, coaching infrastructure, and market expansion.

All projections in the above narrative are forward-looking and not guaranteed.
