The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Use of Proceeds: 7.9% Wefunder, 30.1% Payroll, 12% Beta testing, 30% product development, 20% sales. Raising our maximum would allow us to run more ads, maintain longer runway, and hire a sales expert.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle (“SPV”). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors’ interests in the investments will be recorded in each investor’s “Portfolio” page on the Wefunder platform. All references in this Form C to an Investor’s investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

NOTE: Investors may cancel an investment commitment until 48 hours prior to the deadline identified in these offering materials.

The intermediary will notify investors when the target offering amount has been met. If a material change occurs within five business days of the maximum number of days the offering is to remain open, the offering will be extended to allow for a period of five business days for the investor to reconfirm.

The Company's right to cancel. The Investment Agreement you will execute with us provides the Company the right to cancel for any reason before the offering deadline.

Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

Terms of the Revenue Share Agreement:

The company is issuing agreements to investors entitling them to repayment based on company revenues. Each investor's principal is the amount invested. The company will use 4% of its net revenues (less client refunds, chargebacks, and any taxes collected on behalf of governmental authorities) to repay investors. These payments will be made yearly, starting 365 days after the effective date of the agreement.

Each payment will be distributed pro rata among all investors based on the size of their investment. The company will continue making payments until each investor has received 1.8x their original investment, provided that the company may defer up to one yearly payment with advance notice to investors (a "Permitted Deferral").

The company may prepay all or part of the amounts due at any time. Prepayments must also be made pro rata to all investors.

In the event of default—including missed payments (except Permitted Deferrals), bankruptcy filing, or insolvency proceedings—all unpaid amounts become immediately due and payable.

Payments under this agreement are treated as loan repayments for tax and legal purposes, not as equity. Investors who receive more than their pro rata share must return the excess to be redistributed among all investors.

The agreement does not grant investors any voting rights, management rights, or equity ownership unless converted in connection with a future equity financing or liquidity event.

Terms of the SAFE:

We are offering a Simple Agreement for Future Equity (SAFE) that provides investors the right to receive Capital Units in the Company, if and when the Company conducts an equity financing.

Conversion to Preferred Equity:

Equity Financing:

If the company conducts an Equity Financing (sale of Preferred Units at a fixed valuation), the SAFE will automatically convert into the greater of:

1. The number of Standard Preferred Units equal to the Purchase Amount divided by the lowest price per unit offered to new investors; or
2. The number of SAFE Preferred Units equal to the Purchase Amount divided by the "SAFE Price," based on a post-money valuation cap of \$5,000,000, or \$4,500,000 for the first \$100k of investors/Wefunder VIP investors.

SAFE Preferred Units will have the same rights as Standard Preferred Units, except that price-based preferences (like liquidation or dividend preferences) are based on the SAFE conversion terms. SAFE Preferred Units carry no voting rights, unless otherwise required by law.

Liquidity Event:

If there is a Liquidity Event (such as a sale of the company or IPO), the SAFE entitles the investor to receive the greater of:

1. The Repayment Amount (1.64x the original investment, or 1.8x for the first \$100k of investors/Wefunder VIP investors), or
2. The value of the number of Common Units equal to the Repayment Amount divided by the "Liquidity Price."

If the company needs to qualify the transaction as a tax-free reorganization, it may reduce the cash portion of the payout, as long as the total value received remains the same and the change is applied pro rata to all investors with equal priority.

In a liquidity or dissolution event, investor payouts are:

- Junior to outstanding debt and creditor claims,
- Equal in priority with other SAFE and Preferred Unit holders, and
- Senior to holders of Common Units.

Dissolution Event:

If the company dissolves, investors receive their Repayment Amount after Senior Preferred Holders are paid. If funds are insufficient, assets are distributed pro rata among SAFE holders based on unpaid Repayment Amounts.

Repurchase Option:

If the company expects to trigger SEC reporting due to too many unit holders, it may repurchase the SAFE at the greater of:

- The Repayment Amount, or
- The fair market value of the SAFE (as determined by an independent appraiser).

If an Equity Financing occurs within 3 months of repurchase and the SAFE would have been worth more, the company must pay the difference to the investor.

Payments:

Any payments made to the Investor pursuant to Section 3 of the attached contract shall proportionally reduce, solely for purposes of determining the amount eligible for conversion under Section 10 of the attached contract in connection with a Conversion Event, the portion of the Investor's Purchase Amount that remains eligible for conversion. For this purpose, each dollar paid to the Investor shall be deemed to reduce the Investor's Purchase Amount by an amount equal to the total

paid to date divided by the Investor's applicable Repayment Multiple. Prior payments do not affect the Post-Money Valuation Cap or equity conversion terms applicable to that Investor's class.

Example: If \$3,600 has been paid to the Investor under this Agreement and the applicable Repayment Multiple is 1.8, then $\$3,600 \div 1.8 = \$2,000$ of the original \$10,000 Purchase Amount is deemed satisfied, and only the remaining \$8,000 of that original \$10,000 Purchase Amount will remain eligible for conversion pursuant to Section 10 of the attached contract.

VIP Bonus: DNA Chat Corporation will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

Securities Issued by the SPV: Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights: If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor: The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability: The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Any provision of this Safe may be amended, waived or modified by written consent of the Company and either:

- i. the Investor or
- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
 - A. the Purchase Amount may not be amended, waived or modified in this manner,
 - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
 - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal,

Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and

Overview

DNA precision medicine in each doctor's visit

The Company plans to earn revenue by offering a telemedicine/virtual care service that incorporates DNA information in each appointment. The Company's headquarters is in Clifton, New Jersey. All customers are located in the United States.

Milestones

DNA Chat Corporation was incorporated in the State of Delaware in March 2025.

Since then, we have:

- Pioneering the use of DNA sequencing in each doctor's visit
- 8-30x cost advantage for companies with self-insured healthcare
- Patent pending DNA Hyper-sharding technology
- Prevents 5-year diagnostic odyssey with 2 doctor's visits
- Everything is ready to sell — beta testing stage
- Insurance and Benefits Broker partner locked
- Founder with one successful exit

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was incorporated in March 2025 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended October 31, 2025, the Company had revenues of \$0.
- *Assets.* As of October 31, 2025, the Company had total assets of \$20,599, including \$20,229 in cash.
- *Net Loss.* The Company has had net losses of \$82,043 through October 31, 2025.
- *Liabilities.* The Company's liabilities totaled \$102,642 through October 31, 2025.

Liquidity & Capital Resources

To-date, the company has been financed with \$74,000 in debt and \$200,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 4 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no

guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

DNA Chat Corporation cash in hand is \$47,000, as of February 2026. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$20,000/month, for an average burn rate of \$20,000 per month. Our intent is to be profitable in 18 months.

Since the date of the financial statements, the Company has experienced several operational developments. We initiated deployment of the telemedicine component of our platform through our partner, DrCare247. We also executed an agreement with a second DNA sequencing laboratory, resulting in an approximate 10% reduction in sequencing costs.

During this period, we completed the design of our data center infrastructure, with an estimated per-user infrastructure cost of approximately \$0.25 per year, inclusive of hardware. Additionally, we have entered advanced discussions to formalize a commercial agreement with one of the six largest U.S. insurance and benefits brokers, and we have begun early conversations with a prospective first corporate customer.

There have been no material changes to the Company's overall operating expenses or financial condition, other than normal operating costs associated with continued product development and business development activities.

Over the next 3-6 months, the Company expects to generate approximately \$200,000 in revenue, assuming conservative month-over-month growth of approximately 10%. Operating expenses during this period are expected to remain relatively stable and primarily consist of software development, cloud and infrastructure costs, third-party laboratory services, and general operating expenses. We anticipate expenses of roughly \$100k during the next 3-6 months. Under our base-case assumptions, the Company expects to reach profitability within approximately 18 months. Under an accelerated growth scenario, driven by the anticipated onboarding of a large insurance and benefits broker and corresponding employer adoption, and assuming month-over-month revenue growth of approximately 20%, the Company believes it could reach profitability within approximately 8 months.

The Company is currently revenue-generating and does not require additional capital solely to initiate revenue generation. Any additional capital raised would be used to accelerate growth, expand partnerships, and scale operations rather than to fund baseline revenue activity.

The Company is not currently profitable and is not generating revenue at this time. Based on our current operating plan and cost structure, we expect that raising our target funding amount of approximately \$250,000 would be sufficient to reach profitability under our base-case assumptions.

Even under a conservative downside scenario, the Company expects to reach profitability within approximately 18 months following the completion of this funding, although this outcome is not guaranteed and is subject to execution, market adoption, and partnership timelines. As of the date of this writing, the Company has approximately \$130,000 in reservations, which is sufficient to cover estimated operating expenses for approximately eight months. This existing runway is expected to allow the Company to continue development, initiate commercial traction, and pursue early customer and partner onboarding prior to a subsequent financing round.

In addition to the funds being raised through WeFunder, the Company currently has access to additional capital from a \$100,000 SAFE investment as well as founder contributions in the form of a non-current liability loan. These sources of capital, combined with existing

current liability loan. These sources of capital, combined with existing reservations, are sufficient to support the Company's operations through the current phase of development.

The Company has already secured more reservations than its minimum target, ensuring that its short-term burn will be adequately covered throughout the duration of the campaign. These reservations provide additional runway and commercial traction, positioning the Company to effectively manage its financial needs during the fundraising process.

As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. If applicable, the Company may also be required to pay Wefunder certain fees for the preparation of tax filings. Such fees and the Company's obligation to deliver required tax documents are further specified in the related Tax Services Agreement ("TSA").

Potential Dissolution of the SPV. The Company has agreed that it will pay an administrative fee and / or certain tax fees to Wefunder, in addition to delivering required tax information in the manner prescribed by the TSA, where applicable. Failure to pay such fees or provide Wefunder with required tax information could result in the dissolution of the SPV (an "SPV Dissolution Event"). Subsequent to an SPV Dissolution Event, the securities held by the SPV would be distributed directly and proportionally to the individual investors. This could create administrative complexities, as investors would need to manage the securities themselves rather than having them held and administered by the SPV. Additionally, the unplanned distribution of securities may not align with investors' intended investment strategy or asset allocation.

Upon an SPV Dissolution Event, the Investor hereby consents to and agrees to accept direct assignment of the SPV's rights and obligations under any investment agreements between the SPV and the Company that is located in the Form C or C/A offering materials. The Investor acknowledges they will be bound by all terms and conditions of such agreements as if they were an original party thereto.
