Building a community bathhouse involves both opportunity and risk. We believe in transparency and want every investor to understand the challenges that can affect a project like this. Below are the key risks we've identified and how we're working to mitigate them. **Construction Delays or Cost Overruns:** Renovating a building involves hidden structural or utility issues that could increase costs or delay opening.

Permitting and Code Compliance: Health department, building, ADA, and local/state regulations are strict and subject to interpretation. Delays or

pool/spa regulations are strict and subject to interpretation. Delays or unexpected code requirements could increase expenses or postpone operations.

Supply Chain & Contractor Reliability: Availability of specialized materials (tile, plumbing, sauna components) or contractor scheduling could affect timelines.

Utility Upgrades or System Failures: Bathhouses have high electrical and utility loads. Upgrades or system failures could add major cost or downtime.

Consumer Demand Uncertainty: While interest in wellness is strong, there's no guarantee of sufficient recurring members or daily visitors to achieve projected revenue.

Seasonality & Local Economy: Marin's tourism and discretionary-spending patterns may fluctuate with weather, economy, or wildfire season, affecting revenue stability.

Pricing Sensitivity: Inflation and higher operating costs may force price adjustments that reduce accessibility or volume.

Brand & Community Adoption: As a new concept, community perception or word-of-mouth will strongly influence success. Early missteps could harm reputation.

Under-Capitalization Risk: The project depends on raising sufficient combined capital (private + Wefunder). If total funds fall short, buildout or launch may be delayed or scaled back.

Revenue-Based Debt Obligation: Funds raised through Wefunder are a form of debt. If revenues are delayed or lower than expected, repayment may take longer or be at risk.

Health & Safety Compliance: Public bathing facilities are heavily regulated by state and county health departments. Violations could cause temporary closures or fines.

Operational Complexity: Managing temperature-controlled pools, saunas, steam rooms, and guest turnover is operationally demanding and could lead to higher maintenance cost

Name and Location: The name of the business and/or location and build-out scope may change

Camryn Rose and Elliot Rose are part-time officers. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items

listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: Construction & build-out 78.1%, soft costs (design, permitting & progression fees) 14% These funds will allow us to complete our design and permitting process, lock in construction deposits and begin initial construction work on the Fairfax bathhouse, 7.9% Wefunder fees.

If we raise: **\$150,000**

Use of Proceeds: Construction & Build-Out 46.1% Core construction of the Fairfax bathhouse, including interior framing, plumbing, electrical, tiling, and finish carpentry for saunas, cold plunge, and communal lounge areas. Include permitting & engineering Operating Expenses (OpEx) 31% --Pre-opening and initial operating costs such as rent, insurance, utilities, payroll, and working capital reserves during the ramp-up phase. Marketing & Community Launch 6% -- Branding, signage, community outreach, digital campaigns, and pre-opening membership marketing. Professional Services 1%--Legal, CPA Remaining / Contingency 8% --Project contingency to cover unforeseen construction or startup expenses, 7.9% Wefunder fees.

THE OFFERING

13. Describe the terms of the securities being offered.

The company is issuing promissory notes to investors. The principal amount of each note is the amount invested by the investor. The company will use **3% of its gross revenues** to pay back principal on the notes (the percentage may increase if greater than \$200,000 is raised, see "Revenue Percentage" below). Each note will be paid back based on its pro rata share of all notes issued in this offering. The company will make interest payments to the investor quarterly after reaching Breakeven for the first time (see "Breakeven" definition below). The company may prepay principal and interest at any time. The company will continue payments until investors have received **1.5x their principal investment (the repayment amount)**, provided however that at any time the company may defer up to 1 such payments upon notice to the Lender.

Upon the occurrence of an event of default (as defined in each note), all unpaid principal, accrued interest and other amounts owing will automatically be immediately due, payable and collectible by the company pursuant to applicable law.

"**Breakeven**" means the point at which the Company's Gross Revenues equals or exceeds its total Operating Costs and Expenses (as defined below), calculated on a Quarterly (as defined below) basis, and the Company begins generating positive cash flow available for distributions, as certified by the Company's CEO or other officer.

"**Payment Start Date**" means the first day of the calendar Quarter immediately following the first full Quarter in which the Company achieves Breakeven, except in the case of a Permitted Deferral (as defined in the attached Revenue Loan Agreement). For example: if Breakeven is first achieved in Quarter 3, the Payment Start Date shall be the first day of Quarter 4.

Payments will continue after reaching Breakeven even if in the future the company's expenses start to exceed its revenues.

"**Revenue Percentage**" means (i) three percent (3.0%), if the total funds raised through all Notes in this crowdfunding offering is less than two hundred thousand dollars (\$200,000); (ii) four percent (4.0%), if the total funds raised through all Notes in this crowdfunding offering is greater than two hundred thousand dollars (\$200,000) but less than two hundred and fifty thousand dollars (\$250,000), or (iii) five percent (5%), if the total funds raised through all Notes in this crowdfunding offering is greater than two hundred and fifty thousand dollars (\$250,000). The company currently has 10,000,000 authorized Class A Membership Interests. Per the Operating Agreement, there is plans to have 4 classes of Membership Interests: (1) "Class A Membership Interests", which are entitled to vote on Company matters, engage in the management of the Company, and share in the economic benefits of ownership; (2) "Class B Membership Interests", which are only entitled to share in the economic benefits offered to the Class B Members, who are not entitled to vote on Company matters; (3) "Class C Membership Interests", which are only entitled to share in the economic benefits offered to the Class C Members, who are not entitled to vote on Company matters; and (4) "Class D Membership Interests", which are only entitled to share in the economic benefits offered to the Class D Members, who are not entitled to vote on Company matters. There are no Class B, C, or D Membership Interests currently authorized or outstanding. Liquidation Preferences: 1st-creditors incl member loans, then Class C members, then Class A members, then Class B, then Class D. Refer to the attached Operating Agreement for full details on all rights.

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect gross revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns.

As holders of a majority-in-interest of voting rights in the Company, the unitholders may make decisions with which the Investor disagrees, or that negatively affect the gross revenues of the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the unitholders may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The unitholders may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

Historical Results of Operations

Our company was organized in August 2025 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended October 14, 2025, the Company had revenues of \$241.12.
- *Assets.* As of October 14, 2025, the Company had total assets of \$89,752.34, including \$71,752.34 in cash.
- *Net Loss.* The Company has had net losses of \$22,047.66 through October 14, 2025.
- *Liabilities.* The Company's liabilities totaled \$11,800 through October 14, 2025.

Liquidity & Capital Resources

To-date, the company has been financed with \$50,000 in debt and \$100k in capital contributions from the founder.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital over the next few months to a year. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering and soft commitments from investors outside of Wefunder. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Grotto LLC cash in hand is \$106,403 as of February 2026. Over the last three months, revenues have averaged \$80/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$7,429/month, for an average burn rate of \$7,349 per month. Our intent is to be profitable after 5 months of being open and operational.

Since the date our financials cover we have had continued costs toward beginning construction and advertising, but no significant changes have occurred.

We are not anticipating any revenue beyond investments or contributions over the next 3-6 months. We need to raise about \$1.2M to become revenue generating. We are anticipating an opening date of December 2026 which is when revenue will largely begin. Some revenue may begin in the months leading up to that from presale memberships etc. Over the next 3-6 months we expect approximately \$200k in expenses.

Because we have not opened we are not profitable. We are anticipating a raise of \$1.2M to open at which point another 5 months of business operations before we become profitable.

Besides funds raised through Wefunder, other sources of capital include founders' Personal Investment- \$100k, Business Loan \$50k. We will be using these funds throughout the campaign.

All projections in the above narrative are forward-looking and not guaranteed.
