Our business depends on parental trust and perception regarding child mental health and wellbeing, which may be difficult to establish and maintain.

Our services are directed toward children and teens and are purchased by parents or guardians who must trust the safety, effectiveness, and appropriateness of our programming. Any negative publicity, perceived incident involving a child participant, dissatisfaction shared online, or misunderstanding of our methodology could significantly harm our reputation. Because decisions regarding children's mental wellbeing are particularly sensitive, even isolated events—whether or not substantiated—could reduce demand for our services and materially impact our growth.

We operate in a highly regulated and evolving legal environment related to children's data privacy and online interactions, and failure to comply could expose us to liability.

Our platform collects personal information about children and families and facilitates live virtual group sessions. We are subject to stringent data protection and child privacy laws, including the Children's Online Privacy Protection Act (COPPA), state privacy laws, and international data protection regulations for non-U.S. participants. Compliance requires ongoing investment in policies, systems, and training. Any actual or alleged failure to safeguard participant data, obtain proper consents, or comply with applicable regulations could result in fines, litigation, reputational damage, or restrictions on our operations.

Our programs are not clinical therapy, and confusion regarding the scope or intended use of our services could create legal, regulatory, or reputational risk.

tapouts provides coaching and educational programming focused on emotional skills, resilience, and mindset development. While our programs are described as "science-informed," they are not intended to diagnose, treat, or cure mental health conditions. Parents or participants may misunderstand or mischaracterize our services as therapeutic or medical in nature, which could expose us to claims, regulatory scrutiny, or professional liability concerns, particularly if a child requires clinical intervention beyond the scope of our offerings.

Our reliance on qualified coaches presents operational and scalability risks.

The quality of our services depends heavily on our ability to recruit, train, and retain experienced youth coaches who can deliver engaging, safe, and effective group sessions. Competition for qualified professionals with experience in education, psychology, or youth development is significant. As we scale, maintaining consistent coaching quality across regions and time zones may be challenging. Failure to attract or retain sufficient coaches, or variability in coach performance, could negatively affect participant outcomes and customer satisfaction.

Our live, group-based virtual model introduces risks related to technology reliability and participant behavior.

Our services are delivered primarily through third-party video conferencing platforms such as Zoom. Any service outages, security vulnerabilities, or technical failures could disrupt sessions and damage user trust. Additionally, because sessions involve live interactions among minors, inappropriate behavior by participants—even if not caused by us—could expose the Company to complaints, reputational harm, or legal risk despite safeguards and moderation practices.

We face competition from both traditional and digital alternatives, which may limit our ability to grow or maintain pricing.

The market for child enrichment, social-emotional learning, and youth mental wellness is fragmented and increasingly competitive. We compete with in-person programs, school-based initiatives, therapy practices, digital mental health apps, and free or low-cost online content. Some competitors have significantly greater financial, marketing, or brand resources than we do. If we are unable to differentiate our offerings, demonstrate value, or keep pace with competitors' innovations, our growth and margins could be adversely affected.

Our business model relies on recurring subscriptions, and we may experience higher-than-expected churn.

Our revenue depends on parents enrolling and continuing to pay for weekly sessions over time. Families may discontinue participation due to scheduling challenges, perceived lack of ongoing value, changes in a child's interests, or financial constraints. Because children may "age out" or transition to other activities, maintaining long-term engagement can be difficult. Higher churn rates would require increased marketing and customer acquisition spending to sustain revenue growth.

We are an early-stage company with limited operating history, and our future financial performance is uncertain.

While we have served thousands of families and report positive satisfaction metrics, we remain in a relatively early stage of development. Our ability to achieve long-term profitability depends on scaling enrollment, managing costs, and executing our growth strategy. We may require additional capital to fund operations, expand our team, or invest in technology and curriculum development. There can be no assurance that we will successfully execute our plans or that investors will realize a return on their investment.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

THE OFFERING

13. Describe the terms of the securities being offered.

The SAFEs. We are offering securities in the form of a Simple Agreement for

Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, **Investors will receive a number of shares of Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

- i. the total value of the Investor's investment, divided by
 - a. the price of **Preferred Stock** issued to new Investors
- ii. if the valuation for the company is more than **\$60,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. For investors up to the first **\$500,000.00** of the securities, investors will receive a valuation cap of **\$50,000,000.00**. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- ii. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- iii. Senior to payments for Common Stock.

VIP Bonus

tapouts will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Downside Protection (Liquidation Preference): In a sale or wind-down, Series Seed investors get paid back their investment (\$1.74/share) before Common stockholders receive anything. Common stockholders only get what is left over. Future Investment Rights (Pro Rata): Series Seed investors have the right to invest in future funding rounds to maintain their ownership percentage. The Company generates revenue through a digital youth mental-wellbeing platform that delivers weekly online coaching sessions for children. It combines behavioral science, and structured emotional-skill curricula to help families improve resilience, confidence, and emotional regulation.

Milestones

tapouts, Inc. was incorporated in the State of Delaware in January 2021.

Since then, we have:

- \$5.5M annual recurring revenue based on January 2026 MRR
- 174% year-over-year revenue growth from 2024 to 2025
- 200,000+ kids scheduled across 28,500 live sessions
- \$7.4M raised, including from top-tier VCs such as Joyance and Satori Neuro
- \$810 average lifetime value with 82% first session attendance
- Addressing a \$50B+ global youth mental health market
- A scalable, group-based model designed for growth

Historical Results of Operations

- **Revenues & Gross Margin.** For the period ended December 31, 2024, the Company had revenues of \$1,783,095 compared to the year ended December 31, 2023, when the Company had revenues of \$467,569. Our gross margin was approximately 62.81% in fiscal year 2025, and 51.5% in 2024.
- **Assets.** As of December 31, 2024, the Company had total assets of \$343,074, including \$328,074 in cash. As of December 31, 2023, the Company had \$317,695 in total assets, including \$302,695 in cash.
- **Net Loss.** The Company has had net losses of \$2,060,119 and net losses of \$1,520,226 for the fiscal years ended December 31, 2024 and December 31, 2023, respectively.
- **Liabilities.** The Company's liabilities totaled \$592,096 for the fiscal year ended December 31, 2024 and \$408,557 for the fiscal year ended December 31, 2023.

Liquidity & Capital Resources

To-date, the company has been financed with \$1,283,299 in debt, \$1,350,057 in equity, and \$6,795,284 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in the first half of 2026. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

tapouts, Inc. cash in hand is approximately \$710,000, as of January 2026. Over the last three months, revenues have averaged \$415,000/month, cost of goods sold has averaged \$158,000/month, and operational expenses have averaged \$480,000/month, for an average burn rate of \$223,000 per month. Our intent is to be profitable in 24 to 36 months.

Since the date of our last financial report (December 31, 2024), the Company has seen material changes in the scale of operations. Revenue has grown significantly, increasing from \$1.78M in 2024 to approximately \$5.1M in 2025. Expenses have also increased during this period to support this higher volume of business and continued expansion. Consequently, the Company has not yet reached profitability and continues to operate with a monthly burn rate.

Over the next 6 months (February 2026 through July 2026), we project our monthly revenues to grow from approximately \$520,000 to \$877,000. Over the next 6 months we expect approximately \$1.6M in expenses. During this same period, we expect our contribution margin to break even.

We are not currently profitable. We expect to need \$10m in total funding to reach profitability. We expect to reach this point in 24 to 36 months.

Besides funds raised through Wefunder, other sources of capital include a concurrent equity financing round targeting \$10,000,000 from institutional and strategic investors.

As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.
