Early-Stage Product Risk:

GenWell is still in active development. Features, UX, and AI systems are evolving, and timelines may shift.

Network Effects Not Yet Proven: GenWell depends on building both sides of a marketplace (users + clinicians/brands). If either side grows slowly, engagement and conversions may lag.

User Acquisition Costs Could Fluctuate:

While our model is designed to avoid Meta/TikTok CAC inflation, market conditions, platform algorithm changes, or slower viral growth could impact early traction.

Monetization Depends on Contributor Adoption. Our revenue model relies on clinicians and brands subscribing and spending via GenWell. If adoption is slower than expected, revenue timelines could extend and effect our ability to operate / fundraise.

Competitive Market Dynamics. Major incumbents (Meta, TikTok, aggregators, telehealth marketplaces) may attempt to copy our approach or change features that impact visibility

Dependence on Emerging AI Technologies. Our AI-guided navigation layer relies on continuous model improvements. Unexpected changes to APIs or model performance could affect product reliability

Operating History. As a young company, GenWell has limited financial history and is building its brand from scratch.

Fundraising Risk

Future funding rounds are not guaranteed. Slower capital markets or investor sentiment could impact our ability to raise.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: 60% product development (tech stack + engineer payroll), 10% network growth & enablement, 15% user marketing, 7.1% operations, 7.9% WeFunder Fee

If we raise: **\$124,000**

Use of Proceeds: 40% product development (tech stack + engineer payroll), 20% network growth, 25% user marketing, 7.1% operations, 7.9% WeFunder Fee. Our minimum raise allows us to launch a closed beta pilot and make limited product improvements during our pre-seed fundraising process. Reaching our maximum raise enables us to significantly accelerate product development while simultaneously executing early go-to-market and marketing efforts, positioning the company for a stronger and more efficient pre-seed launch.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an

Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

NOTE: Investors may cancel an investment commitment until 48 hours prior to the deadline identified in these offering materials.

The intermediary will notify investors when the target offering amount has been met. Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock** on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, **Investors will receive a number of shares of Preferred Stock calculated using the method that results in the greater number of Preferred Stock:**

1. the total value of the Investor's investment, divided by
 1. the price of **Preferred Stock** issued to new Investors multiplied by
 2. the **discount rate** (80%), or
2. if the valuation for the company is more than **\$6,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
 1. the Valuation Cap divided by
 2. the total amount of the Company's capitalization at that time.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have

voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Any provision of this Safe may be amended, waived or modified by written consent of the Company and either:

- i. the Investor or
- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
 - A. the Purchase Amount may not be amended, waived or modified in this manner,
 - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
 - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and
- B. Wefunder Portal may reduce the amount of an investor's investment if the reason for the reduction is that the Company's offering is oversubscribed.

RESTRICTIONS ON TRANSFER OF THE SECURITIES BEING OFFERED:

NOTE: The term "accredited investor" means any person who comes within any of the categories set forth in Rule 501(a) of Regulation D, or who the seller reasonably believes comes within any of such categories, at the time of the sale of the securities to that person.

The term "member of the family of the purchaser or the equivalent" includes a child, stepchild, grandchild, parent, stepparent, grandparent, spouse or spousal equivalent, sibling, mother-in-law, father-in-law, son-in-law, daughter-in-law, brother-in-law, or sister-in-law of the purchaser, and includes adoptive relationships. The company has not yet authorized preferred stock, which investors in the SAFE (if converted) will receive. Preferred stock will have liquidation preferences over common stock.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional equity, an Investor's interest will typically also be diluted.

Based on the risk that an Investor's rights could be limited, diluted or otherwise qualified, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The shareholders have the right to redeem their securities at any time. **Shareholders** could decide to force the Company to redeem their **securities** at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional stock, an Investor's interest will typically also be diluted.

- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was incorporated in January 2025 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Assets.* As of December 31, 2025, the Company had total assets of \$13,571.53, including \$13,571.53 in cash.

Liquidity & Capital Resources

To-date, the company has been financed with \$5,000 in SAFEs, \$12,000 in grants, and \$30,000 in founder capital contributions.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 4 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 2 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

GenWell, Inc cash in hand is \$5,581.31, as of January 2026. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$5,573/month, for an average burn rate of \$5,573 per month. Our intent is to be profitable in 48 months.

Our financial reflect our current state of operations. We run an incredibly lean team and burn during our bootstrapped company phase to ensure that we proved market need prior to increasing spend.

Revenue: \$0 in the next 6 months. We expect operating expenses of approximately \$15,000-\$20,000 per month, or \$45,000-\$120,000 over the next 3-6 months, primarily related to product development, technical services, and early operational costs. Actual expenses may vary depending on the amount raised. We expect to be revenue-generating in 2027. Over the next 6-9 months, we expect minimal revenue as we focus on product development, contributor onboarding, and early community growth. Our primary expenses will be: Engineering + product development (70%)

Contributor network growth (10-15%)

User marketing (10-15%)

Operations & compliance (5-10%)

Our goal during this phase is to complete our V1 product, launch our AI-guided health discovery experience, and seed the platform with early clinician and brand contributors. To reach revenue generation, we need to complete: Core product build (feed, AI, Discovery, and SaaS contributor tools)

Contributor onboarding (free tier)

Activation of our subscription tiers for contributors clinicians and health brands

Based on our current roadmap, we expect to begin generating subscription and marketplace revenue within 12 months, once contributors can onboard into our paid tiers and users are able to search, discover, and transact on the platform.

The capital from this round enables us to launch our MVP, further prove market traction through tangible user metrics, and successfully raise our Pre-Seed Round in January 2026 to execute the requirements above.

We are not yet revenue generating. GenWell is in the product-development and early-market-entry stage, and our focus over the next 12-18 months is growth and platform development rather than near-term profitability.

To reach profitability, we need to complete the following milestones:

Build and scale the core GenWell product (health search feed, contributor tools, AI navigation, and discovery marketplace)

Onboard and activate paying contributors into our subscription tiers

Launch revenue channels, including:

Contributor SaaS subscriptions

Marketplace commissions

Advertising / sponsored placements

Grow our user base to the engagement levels that unlock marketplace transactions and contributor value

Based on conservative modeling, we expect profitability to be achievable once we reach approximately 5,000 paying contributors and a scaled consumer base that supports marketplace transactions.

With efficient burn, we estimate needing \$3-4M in additional capital beyond this raise to reach that point — raised through a combination of this Wefunder round and a future pre-seed/seed round.

Our timeline to reach profitability is 36-48 months, depending on:

engineering and hiring pace,

user and contributor growth rate,

the rollout of marketplace and advertising revenues.

Even though profitability is not the immediate goal, our business model is designed for high-margin, predictable revenue built on: subscription fees from clinicians and vetted health brands, marketplace commissions, and media spend flowing through a trusted health discovery platform. The capital from this Wefunder round extends our runway and funds the technical and operational milestones required to activate these revenue streams.

Johns Hopkins Medicine & Ward Infinity Accelerator awarded GenWell a \$12k Non-Dilutive grant in August 2025, combined with founder-led bootstrapping, will fuel our pre-raise runway. We run intentionally hyper-lean at this phase to extend our runway while making meaningful progress towards our larger raise.
