Macroeconomic Risk

Nano Surgical Inc.'s performance depends in part on consumer spending and discretionary purchasing behavior. Economic downturns, inflation, reduced disposable income, or supply-chain disruptions could reduce buying and selling activity on the platform

Early-Stage Company Risk

Nano Surgical Inc. is an early-stage medical device company with a limited operating history. The company may face challenges related to product development, regulatory execution, manufacturing scale-up, and market adoption that could adversely affect financial performance.

Regulatory and Compliance Risk

Medical device products are subject to evolving regulatory requirements in the U.S. and internationally. Delays, changes in interpretation, or additional compliance obligations could increase costs, delay commercialization, or limit market access.

Manufacturing and Supply Chain Risk

The company relies on third-party manufacturers and suppliers for components, assembly, and packaging. Disruptions, quality issues, cost increases, or vendor concentration could negatively impact margins, timelines, or product availability.

Market Adoption and Commercialization Risk

Although the company targets high-frequency aesthetic and surgical procedures, adoption depends on practitioner behavior, training, workflow integration, and reimbursement dynamics. Slower-than-expected adoption could impact revenue growth.

Capital and Liquidity Risk

The company may require additional capital to execute its long-term growth strategy. There can be no assurance that additional financing will be available on favorable terms, or at all, which could constrain operations or strategic flexibility.

Forced Liquidity Risk

If Nano Surgical Inc. is unable to raise sufficient capital, experiences unexpected operational setbacks, or faces adverse market conditions, it could be required to pursue strategic alternatives on an accelerated timeline. In such a scenario, asset sales, licensing transactions, or a company sale could occur at valuations below intrinsic or long-term potential value, resulting in dilution or loss for investors.

Intellectual Property Risk

While the company seeks to protect its technology through trademarks, know-how, and other intellectual property strategies, enforcement can be costly and uncertain. Competitors may develop alternative solutions that reduce differentiation.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Steven Hacker is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle (“SPV”). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors’ interests in the investments will be recorded in each investor’s “Portfolio” page on the Wefunder platform. All references in this Form C to an Investor’s investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

The intermediary will notify investors when the target offering amount has been met. Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

The main terms of the SAFEs are provided below. Capitalized terms used but not defined herein shall have the meanings ascribed to them in the SAFE.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity (“SAFE”), which provides Investors the right to **Preferred Stock** in the Company (“**Preferred Stock**”), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, **Investors will receive a number of shares of Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

1. the total value of the Investor’s investment, divided by
 1. the price of **Preferred Stock** issued to new Investors
2. if the valuation for the company is more than **\$22,000,000.00** (the “Valuation Cap”), the amount invested by the Investor divided by the quotient of
 1. the Valuation Cap divided by
 2. the total amount of the Company Capitalization (as defined in the SAFE in Appendix B) at the time of conversion.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company’s capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the “Cash-Out Amount”) or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the “Conversion Amount”)

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor’s right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);

2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
 - A. the Purchase Amount may not be amended, waived or modified in this manner,
 - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
 - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and
- B. Wefunder Portal may reduce the amount of an investor's investment if the reason for the reduction is that the Company's offering is oversubscribed.

For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

The initial amount invested in a SAFE is determined by the investor, and we do not guarantee that the SAFE will be converted into any particular number of **shares of Preferred Stock**. In the future, we will perform valuations of our **stock (including both common stock and Preferred Stock)** that take into account, as applicable, factors such as the following:

- unrelated third party valuations;
- the price at which we sell other securities in light of the relative rights, preferences and privileges of those securities;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;

- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;
- trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
- the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

Issuer repurchases of securities. On any issue involving conflicts of interest, the executive management and Board of Directors of the Company will be guided by their good faith judgement as to the Company's best interests. The Company may engage in transactions with affiliates, subsidiaries or other related parties, which may be on terms which are not arm's-length, but will be in all cases consistent with the duties of the management of the Company to its shareholders. By acquiring an interest in the Company, the Investor will be deemed to have acknowledged the existence of any such actual or potential conflicts of interest and to have waived any claim with respect to any liability arising from the existence of any such conflict of interest.

Management's Discussion and Analysis of Financial Condition and Results of Operations

You should read the following discussion and analysis of our financial condition and results of operations together with our financial statements and the related notes and other financial information included elsewhere in this offering. Some of the information contained in this discussion and analysis, including information regarding the strategy and plans for our business, includes forward-looking statements that involve risks and uncertainties. You should review the "Risk Factors" section for a discussion of important factors that could cause actual results to differ materially from the results described in or implied by the forward-looking statements contained in the following discussion and analysis.

Overview

Nano Surgical, Inc. designs, develops, and commercializes illuminated handheld medical and aesthetic instruments and related accessories. The Company's core focus is improving visibility, workflow efficiency, and safety in minor surgical, dermatologic, and aesthetic procedures through integrated lighting and ergonomic device design. The Company operates in both professional clinical markets and consumer aesthetic markets.

Milestones

Nano Surgical was originally formed as Nano Surgical LLC, a Delaware LLC, on October 15, 2021, and later converted into Nano Surgical, Inc. on March 25, 2025. The earlier investments listed in the past raises section were made before that conversion, while the company was operating as the LLC.

Since then, we have:

- Thousands of devices sold. Gen 2 launched with strong paid upgrade conversion and pre-order demand.
- Founder is a 30+ year clinician who built and uses lumohs for his own practice.
- Notable personal investors from ex-Google/Wing VC and other notable venture investors.
- Already raised \$2M+ from Ex-CEO's Citrix, Digital Ocean, PPOM (Health ins.) & other notable execs.
- Aesthetics-first entry with expansion into surgical & defense applications-\$100B+ market opportunity
- A "Harry's Razor"-style model built with proprietary blade cartridges with recurring revenue & SAAS.
- Capital-efficient: validated platform, scaled manufacturing, expanding device portfolio & reach.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was incorporated in March 2025 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2025, the Company had revenues of \$43,676. For the period ended December 31, 2024, the Company had revenues of \$129,949.
- *Assets.* As of December 31, 2025, the Company had total assets of \$1,487,657, including \$455,667 in cash. As of December 31, 2024, the Company had total assets of \$184,347, including \$130,225 in cash.
- *Net Loss.* The Company has had net losses of \$1,026,446 through December 31, 2025. The Company has had net losses of \$145,498 through December 31, 2024.
- *Liabilities.* The Company's liabilities totaled \$2,330,412 through December 31, 2025. The Company's liabilities totaled \$656 through December 31, 2024.

Liquidity & Capital Resources

To-date, the company has been financed with \$650,000 in equity and \$2,400,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 8 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This

will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Nano Surgical, Inc. cash in hand is \$625,000, as of March 2026. Over the last three months, revenues have averaged \$900/month, cost of goods sold has averaged \$50,000/month, and operational expenses have averaged \$40,000/month, for an average burn rate of \$89,100 per month. Our intent is to be profitable in 12 months.

The Company replaced its enterprise full time sales consultant with a part-time military-focused sales consultant, reducing sales consulting expenses. Concurrently, the Company engaged a full-time platform and IT contractor to support technology and infrastructure needs. This represents a shift in expense allocation rather than a net increase in operating costs.

In the past month, the Company has received over 100 paid shipping-upgrade pre-orders related to its second-generation Lumohs Pro device, as well as more than 10 pre-orders for the Lumohs Pro Kit. These pre-orders reflect early customer demand trends; however, shipment of second-generation devices is not expected until approximately mid-March pending completion of remaining regulatory requirements. Revenue associated with these pre-orders has not yet been recognized.

Other than the items described above, the Company has not experienced material changes in its financial condition or operations outside the ordinary course of business.

Over the next three to six months, the Company expects to begin recognizing revenue upon shipment of its second-generation devices, subject to completion of remaining regulatory requirements and supply-chain timing. Initial revenues are expected to be driven primarily by existing pre-orders and early customer sales rather than large-scale distribution.

Operating expenses during this period are expected to remain generally consistent with the current monthly run-rate, with primary cost categories including regulatory compliance, manufacturing preparation, contractor compensation, and targeted marketing activities. Recent personnel and contractor adjustments have resulted in a reallocation of expenses rather than a material increase in overall operating costs. We project roughly \$300k in revenue and \$350k in expenses over the next 6 months.

While initial revenue generation is not dependent on a large capital raise, the Company does expect to deploy additional capital to support a planned transition in operational focus from research and development, prototyping, manufacturing setup, and regulatory activities toward expanded sales, marketing, and distribution efforts. Management anticipates this strategic shift in resource allocation to be substantially implemented over the next approximately six months.

The Company is not currently profitable. To date, operating expenditures have been primarily directed toward research and development, regulatory compliance, prototyping, manufacturing setup, and initial infrastructure build-out rather than revenue-focused sales activities. As a result, the Company has operated at a planned net loss during its development phase.

Management anticipates that profitability will be driven by the transition from development and regulatory activities toward scaled product sales and distribution. Based on current expense run-rates and projected gross margins for second-generation devices, the Company estimates that approximately \$850,000 in additional working capital would support sufficient inventory build, marketing expansion, and distribution scale to reach operating profitability. This estimate

assumes continued regulatory progress, stable manufacturing costs, and conversion of existing pre-orders into recognized revenue. While the exact timing of profitability is subject to regulatory completion, production timelines, and market adoption, management currently expects the Company to approach break-even within approximately 12-18 months following commencement of regular product shipments. This projection reflects a planned shift in resource allocation from R&D and regulatory spend toward sales-driven activities rather than a significant increase in fixed overhead.

In addition to funds raised through Wefunder, the Company has historically been supported through prior private SAFE investments from individual accredited investors and initial first-generation product sales. While first-generation sales are no longer a primary source of capital, they contributed to earlier operating support and market validation. The Company also maintains the ability to pursue additional private placements or strategic investor participation if needed. As the Company is not yet profitable, short-term operating burn during the campaign period is expected to be covered through a combination of existing cash reserves, remaining proceeds from prior private financings, and ongoing revenue from early product shipments as they commence. Management closely monitors monthly operating expenses and retains flexibility to moderate discretionary spending — including marketing scale, inventory timing, and contractor utilization — to align cash outflows with available capital during this period. This approach is intended to maintain operational continuity while the Company completes regulatory milestones and transitions toward revenue-generating sales activities.

All projections in the above narrative are forward-looking and not guaranteed.
