



Offering Statement for Beyond Brix, Inc. ("Beyond Brix")

Beyond Brix, Inc. ("Beyond Brix," the "Company," "we," or "us"), a Texas Corporation incorporated on 7/28/2025, is holding the following offering:

Beyond Brix is offering promissory notes to investors and interests will be sold in increments of \$1.00. Up to \$1,000,000 in interests sold in \$1.00 increments with a minimum target amount of \$10,000. The minimum investment amount will be \$500 and the offering deadline will be December 31st, 2026.

Offering Structure:

- **Type:** Promissory Notes (debt)
- **Target Raise:** \$10,000
- **Maximum Raise:** \$1,000,000
- **Interest Rate:** 12% per annum
- **Maturity:** 36 months from the date the loan is issued
- **Payments:** Semi-annually

Revenue Participate Bonus:

In addition to the interest and principal payments above, investors who invest in increments of \$10,000 will receive a Revenue Participation Bonus.

- **Who gets it:** Each \$10,000 invested earns one Bonus (a \$20,000 investment earns two). Limited to the first 20 qualifying \$10,000 increments accepted in the offering (\$200,000 total), first-come, first-served. Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Business Overview:

Beyond Brix® is a Texas-based homebuilding company that manufactures precision-engineered permanent homes using its proprietary Timber Engineered Super Structures (TESS)® building system. The Company's homes are produced in a controlled factory environment — with plumbing and electrical pre-installed — and erected on-site in weeks rather than the months required by traditional stick-built construction. The result is a permanent, mortgageable, code-compliant home delivered in roughly half the time of conventional construction, at a predictable cost and with structural quality the Company believes exceeds traditional site-built homes.

The Company is headquartered at 111 Sandra Muraida Way, Suite 100, Austin, Texas 78703, and initially serves the greater Austin metropolitan area, targeting deliveries within an approximately 50-mile radius of Austin. The TESS® product platform is built on eight years of product development and real-world deployment in South Africa; the purpose of the Company's current expansion is not to design a new product, but to bring a proven one to the American market — built in America, for Americans.

Problem:

The United States faces an estimated shortage of approximately 3.8 million housing units, within a U.S. residential construction market exceeding \$3 trillion. Traditional homebuilding has not kept pace: it is slow, labor-constrained, expensive, and unpredictable in both schedule and cost. Site-built construction routinely takes many months, exposes projects to weather and trade-labor variability, and offers buyers little transparency into the quality of what is behind their walls.

Factory-built alternatives have historically concentrated in the HUD-code (manufactured housing) segment, which does not produce the permanent, mortgageable, IRC-coded homes that developers and homebuyers in high-growth markets like Central Texas demand at scale.

Solution:

Beyond Brix® addresses this gap with its TESS® platform — advanced Timber Engineered Super Structures manufactured to expert precision in a controlled environment and assembled on-site in weeks. Key attributes of the product include:

- **Precision manufacturing** — Structural components are engineered and factory-built with plumbing and electrical wiring pre-installed, delivering consistency and quality assurance that site-built construction cannot match.
- **Speed** — From precision-built superstructure to turn-key home, on-site assembly is completed in weeks, not months, with no compromise on quality.
- **Durability** — A permanent, mortgageable home engineered for an approximately 100-year structural life, with a roof designed never to require replacement.

- **Efficiency** — Wall insulation values exceeding R-40 (versus a typical R-13 standard), an estimated 20–30% energy savings, approximately 50% water reduction, and approximately 90% less embodied carbon than conventional construction.
- **Design** — Contemporary architecture with bold rooflines, floor-to-ceiling glazing, high ceilings, open-plan living, and integrated smart-home technology.

Products and Pricing:

The Company offers a range of home models at a turnkey sales price of \$160 per square foot, excluding land. Turnkey pricing includes delivery and assembly, kitchen, bathroom(s), major appliances, and landscaping allowance. The Company partners with Texas land developers to bring completed homes to market at accessible price points:

Business Model:

Beyond Brix® operates a business-to-business-to-consumer model centered on volume relationships with land developers. The Company manufactures TESS® homes in its Texas factory and sells them primarily through signed contracts and letters of intent with Texan land developers, who control entitled land and bring finished communities to market. This developer-led channel allows the Company to secure multi-unit committed demand in advance of production, reduce customer-acquisition cost, and match factory throughput to contracted orders.

Revenue is generated from the turnkey sale of homes at \$160 per square foot (excluding land). Because homes are precision-manufactured in a controlled environment, the Company expects gross-cost efficiency of approximately 20–30% versus comparable site-built construction, supporting both competitive pricing and attractive unit economics as production scales.

Traction:

The Company has secured substantial committed and pipeline demand in advance of full U.S. production:

In addition, the TESS® product platform has eight years of development and deployment history in South Africa, providing proven product performance ahead of U.S. market expansion.

Market Opportunity:

The U.S. residential construction market exceeds \$3 trillion annually, and the national housing shortage is estimated at approximately 3.8 million units. The Company's initial market — the greater Austin, Texas metropolitan area — is among the fastest-growing housing markets in the country. Beyond Brix® initially targets deliveries within an approximately 50-mile radius of Austin, with a scalable manufacturing model designed to expand capacity as demand grows.

Competitive Advantage:

The Company believes its competitive position rests on a combination of advantages that would be difficult and time-consuming for a competitor to replicate:

- **VDL Steelweld partnership** — The Company's automation line was co-designed with VDL and is not available off-the-shelf; the Company estimates a competitor would face a 9–12 month replication lead time, backed by VDL's 55+ years of engineering experience.
- **IRC-coded at scale** — To the Company's knowledge, no other Texas factory produces IRC-coded permanent homes at a planned scale of up to 7,000+ units per year. The HUD-coded segment is well served; IRC-coded homes at mass scale are not.
- **Structural cost advantage** — An estimated 20–30% finished-cost efficiency versus site-built construction. Matching it would require the factory, the land, the automation design, and the VDL relationship simultaneously.
- **Proven product** — Eight years of product development and deployment in South Africa de-risk the product ahead of U.S. expansion.
- **Product performance** — Approximately 100-year structural life, 20–30% energy savings, approximately 50% water reduction, 95%+ factory automation, and approximately 90% less embodied carbon.

Growth Path:

Management's plan scales production from first U.S. deliveries in 2026 toward mega-factory volumes by 2030. On the basis of the planned production ramp and current turnkey pricing, the Company projects approximately \$850 million in revenue by 2030 with an EBITDA margin of approximately 36% by 2030. These projections are forward-looking estimates prepared by management; they are not guarantees of future performance, and actual results may differ materially.

We may have difficulty raising needed capital in the future as a result of, among other factors, being pre-revenue, as well as the inherent business risks associated with our Company and present and future market conditions.

The Company's success depends on the experience and skill of its directors, officers and other key personnel.

In particular, we are dependent on our directors, officers and key personnel. The loss of any such person(s) could harm the Company's business, financial condition, cash flow and performance. Accordingly, you should not invest in the Company unless you are willing to entrust all aspects of the management of the Company and the investment decisions we make on the behalf of the Company.

Although dependent on certain key personnel, the Company does not have any key person life insurance policies on any such people

We are dependent on certain key personnel in order to conduct our operations and execute our business plan, however, the Company has not purchased any insurance policies with respect to those individuals in the event of their death or disability. Therefore, if any of these personnel die or become disabled, the Company will not receive any compensation to assist with such person's absence. The loss of such person could negatively affect the Company and our operations. We have no way to guarantee key personnel will stay with the Company, as many states do not enforce non-competition agreements, and therefore acquiring key man insurance will not ameliorate all of the risk of relying on key personnel.

Damage to our reputation could negatively impact our business, financial condition and results of operations.

Our reputation and the quality of our brand are critical to our business and success and will be critical to our success as we form and advise new markets. Any incident that erodes confidence in our brand could reduce the Company's value and damage our business. We may be adversely affected by any negative publicity, regardless of its accuracy. Also, there has been a marked increase in the use of social media platforms and similar devices, including blogs, social media websites and other forms of internet-based communications that provide individuals with access to a broad audience. The availability of information on social media platforms is virtually immediate as is its impact. Information posted may be averse to our interests or may be inaccurate, each of which may harm our performance, prospects or business. The harm may be immediate and may disseminate rapidly and broadly, without affording us an opportunity for redress or correction.

Risks Related to the Offering

The U.S. Securities and exchange Commission does not pass upon the merits of the Securities or the terms of the Offering, nor does it pass upon the accuracy or completeness of any Offering document or literature.

You should not rely on the fact that our Form C is accessible through the U.S. Securities and Exchange Commission's EDGAR filing system as an approval, endorsement or guarantee of compliance as it relates to this Offering. The U.S. Securities and Exchange Commission has not reviewed this Form C, nor any document or literature related to this Offering.

Neither the Offering nor the Securities have been registered under federal or state securities laws.

No governmental agency has reviewed or passed upon this Offering or the Securities. Neither the Offering nor the Securities have been registered under federal or state securities laws. Investors will not receive any of the benefits available in registered Offerings, which may include access to quarterly and annual financial statements that have been audited by an independent accounting firm. Investors must therefore assess the adequacy of disclosure and the fairness of the terms of this Offering based on the information provided in this Form C and the accompanying exhibits.

The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.

Unless the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the use of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

The Company has the right to limit individual Investor commitment amounts based on the Company's determination of an Investor's sophistication.

The Company may prevent any Investor from committing more than a certain amount in this Offering based on the Company's determination of the Investor's sophistication and ability to assume the risk of the investment. Transfer Agent - In entering into an agreement on PicMii Crowdfunding's Funding Portal to purchase securities, both investors and the Company must agree that a transfer agent, which keeps records of our outstanding Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed) or that the Company is capable of maintaining investment records on their own. Options, Warrants and Other Rights

17. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of securities?

Investors should understand the potential for dilution. The investor's stake in a company could be diluted due to the company issuing additional shares. In other words, when the company issues more shares, the percentage of the company that you own will go down, even though the value of the company may go up. You will own a smaller piece of a larger company. This increase in number of shares outstanding could result from a stock offering (such as an initial public offering, another crowdfunding round, a venture capital round, angel investment), employees exercising stock options, or by conversion of certain instruments (e.g., convertible bonds, preferred shares or warrants) into stock. If the company decides to issue more shares, an investor could experience value dilution, with each share being worth less than before, and control dilution, with the total percentage an investor owns being less than before. There may also be earnings dilution, with a reduction in the amount earned per share (though this typically occurs only if the company offers dividends, and most early-stage companies are unlikely to offer dividends, preferring to invest any earnings into the company)

18. Are there any differences not reflected above between the securities being offered and each other class of security of the issuer?

The issuer is offering promissory notes, and therefore, no securities will be sold in the offering.

19. How could the exercise of rights held by the principal owners identified in Question 5 above affect the purchasers of Securities being offered?

The holder of a majority of the voting rights in the Company may make decisions with which you disagree, or that negatively affect the value of your investment in the company, and you will have no recourse to change those decisions. Your interests may conflict with the interests of other investors, and there is no guarantee that the company will develop in a way that is

advantageous to you. For example, the majority shareholder may decide to issue additional shares to new investors, sell convertible debt instruments with beneficial conversion features, or make decisions that affect the tax treatment of the company in ways that may be unfavorable to you. Based on the risks described above, you may lose all or part of your investment in the securities that you purchase, and you may never see positive returns.

20. How are the securities being offered valued? Include examples of methods for how such securities may be valued by the issuer in the future, including during subsequent corporate actions.

The securities being offered are valued at the issuer's discretion. An early-stage company typically sells its shares (or grants options over its shares) to its founders and early employees at a very low cash cost, because they are, in effect, putting their "sweat equity" into the company. When the company seeks cash investments from outside investors, like you, the new investors typically pay a much larger sum for their shares than the founders or earlier investors, which means that the cash value of your stake is immediately diluted because each share of the same type is worth the same amount, and you paid more for your shares than earlier investors did for theirs.

There are several ways to value a company, and none of them is perfect and all of them involve a certain degree of guesswork. Any of these methods, plus others, may be used to determine valuation in the future:

Liquidation Value - The amount for which the assets of the company can be sold, minus the liabilities owed, e.g., the assets of a bakery include the cake mixers, ingredients, baking tins, etc. The liabilities of a bakery include the cost of rent or mortgage on the bakery. However, this value does not reflect the potential value of a business, e.g., the value of the secret recipe. The value for most startups lies in their potential, as many early-stage companies do not have many assets.

Book Value - This is based on analysis of the company's financial statements, usually looking at the company's balance sheet as prepared by its accountants. However, the balance sheet only looks at costs (i.e., what was paid for the asset), and does not consider whether the asset has increased in value over time. In addition, some intangible assets, such as patents, trademarks or trade names, are very valuable but are not usually represented at their market value on the balance sheet.

Earnings Approach - This is based on what the investor will pay (the present value) for what the investor expects to obtain in the future (the future return), taking into account inflation, the lost opportunity to participate in other investments, the risk of not receiving the return. However, predictions of the future are uncertain and valuation of future returns is a best guess.

Different methods of valuation produce a different answer as to what your investment is worth. Typically, liquidation value and book value will produce a lower valuation than the earnings approach. However, the earnings approach is also most likely to be risky as it is based on many

assumptions about the future, while liquidation value and book value are much more conservative.

Future investors (including people seeking to acquire the company) may value the company differently. They may use a different valuation method, or different assumptions about the company's business and its market. Different valuations may mean that the value assigned to your investment changes. It frequently happens that when a large institutional investor such as a venture capitalist makes an investment in a company, it values the company at a lower price than the initial investors did. If this happens, the value of the investment would go down.

21. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

The company's Certificate of Incorporation or Bylaws can be amended by the holders of a majority of the issued and outstanding shares of the Company. As minority owners, the crowdfunding investors are subject to the decisions made by the majority owners. The issued and outstanding shares of common stock give management voting control of the company. As a minority owner, you may be outvoted on issues that impact your investment, such as, among other things: (a) the liquidation, dissolution or winding up of the company, or effecting any merger or consolidation; (b) amendment of any provision of the Certificate of Incorporation or Bylaws; (c) creation and issuance of other securities having rights, preferences or privileges senior to the common stock sold to the crowdfunding investors, or increasing the authorized number of shares of stock of the company; or (d) creation of any debt security.

22. What are the risks to purchasers associated with corporate actions including:

- 1. Additional issuances of securities**

The authorization and issuance of additional shares of the company's common stock will dilute the ownership of the crowdfunding investors. As a result, if the company achieves profitable operations in the future, its net income per share will be reduced because of dilution, and the market price of the company's common stock, if there is a market price, could decline as a result of the additional issuances of securities. If the company repurchases securities, so that the above risk is mitigated, and there are fewer shares of common stock outstanding, the company may not have enough cash available for marketing expenses, growth, or operating expenses to reach our goals. If we do not have enough cash to operate and grow, we anticipate the market price of our securities would decline. A sale of the company or of all of the assets of the company may result in an entire loss of your investment. We cannot predict the market value of the company or its assets, and the proceeds of a sale may not be cash, but instead, unmarketable securities, or an assumption of liabilities. It is unlikely that in the near term, a sale would result in a premium that is significant enough over book value to generate a return to our investors. We may need to negotiate with a related party for additional capital. No assurance can be given that such funds will be available or, if available, will be on commercially reasonable terms satisfactory to us.

Even if such financing is available, it may be on terms that are materially averse to your interests with respect to dilution of book value, dividend preferences, liquidation preferences, or other terms.

Beyond Brix, Inc.'s financial statements for the year ended December 31, 2025 were reviewed by an independent accountant in accordance with Statements on Standards for Accounting and Review Services promulgated by the AICPA. The financial statements were prepared in accordance with U.S. GAAP. As of December 31, 2025, the Company reported total assets of \$7.43 million, including \$6.0 million of intangible assets, \$825,000 of other assets, \$603,975 of accounts receivable, and \$1,927 of cash.

For the year ended December 31, 2025, Beyond Brix generated \$600,000 in net revenue and reported no cost of revenue, resulting in gross profit of \$600,000. The Company incurred \$323,229 in general and administrative expenses and \$13,774 in interest expense, resulting in income from operations of \$276,771 and net income of \$262,997. The Company reported no provision for income taxes for the year.

As of December 31, 2025, the Company reported total liabilities of approximately \$5.17 million, consisting primarily of \$4.825 million in subordinated liabilities, \$106,980 in advances from stockholders, and \$235,722 in accounts payable. The Company reported shareholders' equity of approximately \$2.26 million. The financial statements note that the advances from stockholders are recorded as long-term liabilities and are typically interest-bearing with repayment terms.

The financial statements provided cover the year ended December 31, 2025 and do not include comparative 2024 financial information. Accordingly, the Company's 2025 results provide the basis for evaluating its current financial position and operating performance. The Company's financial position reflects positive net income and substantial intangible assets, while its relatively low cash balance and significant liabilities should be considered in evaluating its liquidity and capital requirements.
