Ace Pickleball Club Media LLC (the “Company,” “we,” “us”, “Issuer” or “our”), is offering up to **\$4,989,800** (the “Maximum Offering Amount”) worth of Class B Units of the Company (the “Securities” or singularly the “Security”) at a price of **\$1.00** per Security (collectively, the “Offering”). Purchasers of Securities are sometimes referred to herein as “Purchasers” or “Investors”. The minimum Target Offering Amount is **\$25,562.50** (the “Target Offering Amount”) (collectively, the “Offering”). The Target Offering Amount and Maximum Offering Amount includes the investor processing fee total for all investments. The Offering is being conducted on a best-efforts basis and the Company must reach its Target Amount by August 11, 2027 (the “Target Date”).

Unless the Company raises at least the Target Offering Amount under this Offering by the Target Date, no Securities will be sold in this Offering, all investment commitments will be canceled, and all committed funds will be returned. For the avoidance of doubt, no initial subscriptions from new investors will be accepted after August 11, 2027. If the Company reaches its Target Offering Amount prior to the Target Date, the Company may conduct the first of multiple closings, provided that the Offering has been posted for 21 days and that investors who have committed funds will be provided notice five business days prior to the close.

Ace Pickleball Club Media, LLC ("APCM") is a vertically integrated media company initially focused on the rapidly growing sport of pickleball with the goal of expanding into sports, health, and wellness. The Company develops and operates owned media channels, live experiences, and marketing services designed to connect players, brands, clubs, and industry stakeholders through high-quality content and targeted advertising.

Business Model

Unlike traditional pickleball media companies that rely primarily on a single publication or social media presence, APCM is building an ecosystem of complementary businesses that reinforce one another and create multiple revenue opportunities.

The Company's primary operating divisions include:

Beyond the Bounce – a digital and print media brand producing original editorial content, newsletters, interviews, educational articles, video programming, podcasts, and social media content focused on pickleball culture, instruction, health, travel, equipment, and industry news.

Courtside XP – an experiential advertising business focused on retail digital signage, audio, brand activations, and other live experiences designed to engage consumers and sponsors.

Hi Digital Group – a marketing agency specializing in digital advertising, creative services, branding, website development, lead generation, and media buying for service-based and retail businesses including sports, health, wellness, and adjacent markets.

The Company expects to generate revenue from a diversified mix of sources, including:

A significant competitive advantage of APCM is its strategic relationship with Ace Pickleball Club, one of the largest indoor pickleball club operators in the United States. While APCM operates independently, it expects to benefit from preferred access to a highly engaged pickleball audience through in-club media opportunities, digital channels, events, and strategic marketing relationships. There can be no assurance that these relationships will continue indefinitely or produce anticipated results.

Management believes the pickleball industry remains in the early stages of commercialization and expects increasing demand from consumer brands, equipment manufacturers, healthcare companies, travel providers, financial services firms, and other advertisers seeking access to the sport's rapidly expanding participant base. The Company intends to position itself as a leading media platform within this growing ecosystem.

Competitors

The Dink Pickleball, The Kitchen Pickleball, and Pickleball Magazine. There are also other digital advertising agencies and experiential media networks with which the Company will be competing.

Industry

Pickleball's media and market landscape has boomed into a multibillion-dollar industry. The sector currently features media brands like The Dink, Pickleball Magazine, and The Kitchen. Key segments of the current pickleball media and market include: Digital Media & News: Outlets like The Dink Pickleball include online coverage, publishing newsletters, running podcasts, and hosting amateur circuits. Entertainment: The sport has penetrated mainstream pop culture with Apple TV original media projects like the sports comedy feature film, The Dink. Equipment & Lifestyle: The market features a large retail ecosystem. Players can track paddle specs, reviews, and brands via resources like Pickleball Central.

Current Stage

The Company is in the commercialization stage and is currently launching its initial operating businesses. While pre-revenue, management has completed organizational formation, brand development, strategic partnerships, and business planning and expects to begin revenue generation following the launch of its media properties.

Phase I:

Launch Ace Pickleball Club Media, publish inaugural issue of Beyond the Bounce, launch website and newsletter, expand Hi Digital Group, and onboard founding advertising partners.

Expand digital audience, increase publication frequency, grow podcast and video programming, launch in-club digital advertising network across Ace Pickleball Club locations.

Phase II:

Introduce Courtside XP experiential events, expand branded content offerings, increase sponsorship inventory, pursue strategic media partnerships.

Scale nationally through additional distribution channels, expand advertising platform, launch new media products and subscription offerings where appropriate.

Phase III:

Become the leading media, marketing, and experiential platform serving the pickleball industry while expanding into adjacent active lifestyle categories.

Perks

Revenue Risk

A substantial portion of anticipated revenue is expected to come from advertising, sponsorships, subscriptions, and marketing services. Advertising, sponsorships and marketing spending is cyclical and may decline during economic downturns or changes in customer marketing budgets.

Competition

The Company competes with established sports media companies, pickleball-focused publishers, social media creators, podcasts, digital marketing agencies, event organizers, and other content creators. Some competitors may have greater financial resources, larger existing audiences, and longer operating histories.

Early Stage Company

We are a pre-revenue early-stage company. Our company was formed on June 19, 2026, under the laws of the State of Nevada, and we have not yet generated revenue or profits. The likelihood of our creation of a viable business must be considered in light of the problems, expenses, difficulties, complications, and delays frequently encountered in connection with the growth of a business, operation in a competitive industry, and the continued development of our products, services, and technology. We expect our operating expenses will increase for the near term, and there is no assurance that we will be profitable in the near future. You should consider our business, operations, and prospects in light of the risks, expenses, and challenges faced as an emerging growth company.

Dependence on Key Personnel

We are currently dependent on a few key personnel. Our success depends, to a large degree, on our ability to retain the services of our executive management team, whose industry knowledge and leadership would be difficult to replace. The loss of any of these individuals could have a material adverse effect on the Company.

Competing Interests

Our Managers, Jay Diederich and Joseph Sexton, also devote time to other related business activities, including operation and growth of Ace Pickleball Club and affiliated businesses. As a result, they may not devote all of their professional time to the Company. While we believe these related businesses provide strategic advantages, including access to audience, content, industry relationships, and commercial opportunities, competing demands on management's time could delay certain initiatives or otherwise adversely affect the Company's operations and financial performance.

Increases in the costs of materials caused by inflation, global conflicts, government policy, pandemics, and climate risks could adversely affect our results of operations

Supply chain risk could increase our costs and limit the availability of critical materials and supplies for operations. The markets for materials are particularly volatile due to factors beyond our control, such as limited sources, seasonal shifts, governmental policy, climate conditions, recent inflationary trends, military and geopolitical conflicts, and industry demand. Any such changes may negatively impact our members and guests and could adversely affect sales, guest and member numbers and the Company as a whole.

Customer Base and Market Acceptance

Pickleball is the fastest-growing sport in the United States across all age groups. The Company's overall target customer demographics are males and females ages 8 to 80. If the popularity of pickleball significantly diminishes or the Company cannot expand its customer base in relation to the growing acceptance of pickleball as a preferred sport, it will have a materially adverse effect on the Company's present and future business activities and growth.

Trends in Customer Preferences and Spending

The Company's operating results may fluctuate significantly from period to period due to various factors, including customer purchasing patterns, pickleball popularity as a sport, competitive pricing, debt service, principal payments, and general economic conditions. There is no assurance that the Company will be successful in marketing its services, and operational excellence or that the revenues from the sale of such products will be significant.

Consequently, the Company's revenues may vary by quarter, and the Company's operating results may experience fluctuations.

Risk Related to our reliance on third-party license for the "Ace Pickleball Club" brand

Our business, marketing, and sales efforts are dependent on our licensing agreement with Ace Pickleball Club LLC for the "Ace Pickleball Club" brand. Our ability to generate revenue from products and services incorporating this brand is contingent upon the continued validity and enforceability of this license. The loss or termination of this license for any reason would have a material adverse effect on our business, financial condition, and results of operations. Our license with Ace Pickleball Club is subject to termination or non-renewal under certain conditions. While we believe we are in compliance with the terms of our agreement, there is no guarantee that the licensor will not find grounds to terminate it. Furthermore, the license is set to expire in 15 years, and there is no assurance that we will be able to renew it on commercially reasonable terms, or at all. Any termination or failure to renew could require us to cease all use of the brand and discontinue products that are dependent on the license, severely impacting our business. Additionally, we do not have complete control over the reputation and quality standards associated with the "Ace Pickleball Club" brand, which are largely controlled by the licensor and its affiliates and franchisees. If the licensor or other licensees of the brand fail to maintain high-quality standards or if their actions damage the brand's reputation, our business and financial performance could be negatively affected. Any negative publicity or controversy involving the licensor could also harm our company through association. Our success is also dependent on Ace Pickleball Club, LLC and its affiliates continuing to invest in and market the brand. If the licensor reduces its efforts or resources allocated to the brand, our ability to grow and market our products under the license could be limited.

Finally, we could become involved in intellectual property disputes involving the licensed brand. If the licensor is unable to protect its intellectual property, or if another party asserts that our use of the brand infringes on their rights, we could be forced to litigate or discontinue our use, incurring significant costs.

Our business is subject to data security risks, including security breaches

We, or subsidiaries on our behalf, collect, process, store, and transmit substantial amounts of information, including information about our customers and partners. We take steps to protect the security and integrity of the information we collect, process, store, or transmit, but there is no guarantee that inadvertent or unauthorized use or disclosure will not occur or that third parties will not gain unauthorized access to this information despite such efforts. Security breaches, computer malware, computer hacking attacks, and other compromises of information security measures have become more prevalent in the business world and may occur on our systems or those of our subsidiaries, affiliates, or vendors in the future. Large Internet companies and websites have, from time to time, disclosed sophisticated and targeted attacks on portions of their websites, and an increasing number have reported such attacks resulting in breaches of their information security. Our third-party vendors and we are at risk of suffering from similar attacks and breaches. Although we take steps to maintain confidential and proprietary information on our information systems, these measures and technology may not adequately prevent security breaches, and we rely on our third-party vendors to take appropriate measures to protect the security and integrity of the information on those information systems. Our customers may be targeted by parties using fraudulent spoofing and phishing emails to misappropriate passwords, payment information, or other personal information or to introduce viruses through trojan horse programs or otherwise through our computers, smartphones, tablets, or other devices. Despite our efforts to mitigate the effectiveness of such malicious email campaigns through product improvements, spoofing and phishing may damage our brand and increase our costs. These events or circumstances could materially adversely affect our business, financial condition, and operating results.

Turmoil of Markets

Control By Management

Return of Profits

A member will be entitled to receive revenue profits proportionate to the Membership Units held by that member as described in the Operating Agreement. The Company's Managers will determine if profits are distributed based upon the Company's results of operations, financial condition, capital requirements, and other circumstances

No Assurance of Protection for Proprietary Rights; Reliance on Trade Secrets

In some instances, the Company may rely on trade secrets to protect intellectual property, proprietary technology, and processes that the Company has acquired, licensed, developed, or may develop in the future. There can be no assurances that secrecy obligations will be honored or that others will not independently develop similar or superior products or technology. The protection of intellectual property and/or proprietary technology through claims of trade secret status has been the subject of increasing claims and litigation by various companies to protect proprietary rights and for competitive reasons, even where proprietary claims are unsubstantiated. The prosecution of proprietary claims or the defense of such claims is costly and uncertain, given the uncertainty and rapid development of the principles of law pertaining to this area. There is no current market for any Units of the Company's equity. There is no formal marketplace for the resale of the Company's Units. Investors should assume that they may not be able to liquidate their investment for some time, or be able to pledge their shares as collateral.

Changing Economic Conditions

Consumer discretionary spending and corporate advertising budgets are sensitive to broader economic conditions. Inflation, recession, or other macroeconomic factors may reduce demand for the Company's products and services.

No Assurance of Profitability

When a Distribution as the Managers deems appropriate, such Distribution is to be made (i) first to the Class A Members and the Class B Members, in proportion to the amount of each such Member's total unreturned Capital Contribution bears to the aggregate amount of all unreturned Capital Contributions of all such Members, until the cumulative amount distributed to such Members; and (ii) second, to the Class A Members and the Class B Members pro rata in proportion to the respective ownership interests. Each Class A and Class B Member (each a "Preemptive Member") has the right to purchase such Preemptive member's Pro Rata Portion of any New Securities that the Company may from time to time propose to issue or sell to any party.

As a minority holder of the Security, you will have limited rights in regards to the corporate actions of the Company, including additional issuances of securities, Company repurchases of securities, a sale of the Company or its significant assets, or Company transactions with related parties. Further, investors in this Offering may have rights less than those of other investors, and will have limited influence on the corporate actions of the Company.

Dilution

Investors should understand the potential for dilution. When an investor makes an investment in a class of securities that represents ownership in a company (common shares or interests are most common), the investor's percentage of ownership can go down over time, which is called dilution. An investor's stake in a company may be diluted due to the company issuing additional securities of the same class. In other words, when a company issues more securities that reflect ownership (or additional equity interests), the percentage of the company that you own will go down, even though the value of the company may go up. The investor will own a smaller piece of a larger company. This increase in the number of securities outstanding could result from various other issuance types too, like a stock offering (such as an initial public offering, another crowdfunding round, a venture capital round or angel investment), employees exercising stock options, or by conversion of certain instruments (e.g. convertible bonds, preferred shares or warrants) into securities reflecting ownership of the same class.

If a company decides to issue more securities, an investor could experience value dilution, with each security being worth less than before, and control dilution, with the total percentage an investor owns being less than before. There may also be earnings dilution, with a reduction in the amount earned per securities (though this typically occurs only if the company offers dividends, and most early-stage companies are unlikely to offer dividends, preferring to invest any earnings into the company).

The type of dilution that hurts early-stage investors mostly occurs when a company sells more securities representing ownership in a "down round," meaning at a lower valuation than in earlier offerings. An example of how this might occur is as follows (numbers are for illustrative purposes only):

- In June 2022 Jane invests \$20,000 for shares/interests that represent 2% of a company valued at \$1 million.
- In December, the company was doing very well and sells \$5 million in shares/interests to venture capitalists on a valuation (before the new investment) of \$10 million. Jane now owns only 1.3% of the company but her stake is worth \$200,000.
- In June 2023 the company has run into serious problems and in order to stay afloat it raises \$1 million at a valuation of only \$2 million (the "down round"). Jane now owns only 0.89% of the company and her stake is worth only \$26,660.

This type of dilution might also happen upon conversion of convertible notes into securities representing ownership. Typically, the terms of convertible notes issued by early-stage companies provide that in the event of another round of financing, the holders of the convertible notes get to convert their notes into equity at a "discount" to the price paid by the new investors, i.e., they get more securities than the new investors would for the same price. Additionally, convertible notes may have a "price cap" on the conversion price, which effectively acts as a securities price ceiling. Either way, the holders of the convertible notes get more securities for their money than new investors. In the event that the financing is a "down round" the holders of the convertible notes will dilute existing equity holders, and even more than the new investors do, because they get more securities for their money.

If you are making an investment expecting to own a certain percentage of the Company or expecting the Securities to hold a certain amount of value, it's important to realize how the value of the Securities can decrease by actions taken by the Company. Dilution can make drastic changes to the value of the Securities, ownership percentage, voting control, and earnings per Security.

VALUATION

Pre-Money Valuation: \$9,959,184

Valuation Details:

As discussed in "Dilution" above, the valuation of the company will determine the amount by which the investor's stake is diluted in the future. An early-stage company typically sells its shares (or grants options over its shares) to its founders and early employees at a very low cash cost, because they are, in effect, putting their "sweat equity" into the company. When the company seeks cash investments from outside investors, like you, the new investors typically pay a much larger sum for their shares than the founders or earlier investors, which means that the cash value of your stake is immediately diluted because each share of the same type is worth the same amount, and you paid more for your shares than earlier investors did for theirs. There are several ways to value a company, and none of them is perfect and all of them involve a certain amount of guesswork. The same method can produce a different valuation if used by a different person.

Liquidation Value — The amount for which the assets of the company can be sold, minus the liabilities owed, e.g., the assets of a bakery include the cake mixers, ingredients, baking tins, etc. The liabilities of a bakery include the cost of rent or mortgage on the bakery. However, this value does not reflect the potential value of a business, e.g., the value of the secret recipe. The value for most startups lies in their potential, as many early-stage companies do not have many assets (they probably need to raise funds through a securities offering in order to purchase some equipment).

Book Value — This is based on analysis of the company's financial statements, usually looking at the company's balance sheet as prepared by its accountants. However, the balance sheet only looks at costs (i.e., what was paid for the asset), and does not consider whether the asset has increased in value over time. In addition, some intangible assets, such as patents, trademarks or trade names, are very valuable but are not usually represented at their market value on the balance sheet.

Earnings Approach — This is based on what the investor will pay (the present value) for what the investor expects to obtain in the future (the future return), taking into account inflation, the lost opportunity to participate in other investments, the risk of not receiving the return. However, predictions of the future are uncertain and valuation of future returns is a best guess.

Different methods of valuation produce a different answer as to what your investment is worth. Typically, liquidation value and book value will produce a lower valuation than the earnings approach. However, the earnings approach is also most likely to be risky as it is based on many assumptions about the future, while the liquidation value and book value are much more conservative.

Future investors (including people seeking to acquire the company) may value the company differently. They may use a different valuation method, or different assumptions about the company's business and its market. Different valuations may mean that the value assigned to your investment changes. It frequently happens that when a large institutional investor such as a venture capitalist makes an investment in a company, it values the company at a lower price than the initial investors did. If this happens, the value of the investment will go down.

Related Party Transactions

Ace Pickleball Club, LLC ("Ace") owns all of the Class A Units in the Company and is the controlling member of the Company. The Managers of the Company are Joseph Sexton and Jay Diederich, who are also the respective President and CEO of Ace.

Ace has granted a license to the Company for the Ace name and certain intellectual property. This license is integral to the business plan and success of the Company. The license has an annual fee of \$1.00.

Transferability of securities

Pursuant to Regulation CF, for a year, the securities can only be resold:

- In an IPO;
- To the Company;
- To an accredited investor; and
- To a member of the family of the purchaser or the equivalent, to a trust controlled by the purchaser, to a trust created for the benefit of a member of the family of the purchaser or the equivalent, or in connection with the death or divorce of the purchaser or other similar circumstance.

NOTE 1 – NATURE OF OPERATIONS

Ace Pickleball Club Media LLC (the “Company”) was incorporated in the State of Nevada on June 19, 2026. The Company operates as a holding entity for a diversified media and marketing platform through its wholly-owned subsidiaries, Courtside XP LLC and Hi Digital Group LLC, both formed in Nevada on June 19, 2026.

- Courtside XP LLC is an experiential advertising group designed to leverage the Ace Pickleball Club ecosystem to provide advertisers direct access to members and guests through display, audio, and in-club activations.
- Hi Digital Group LLC is a digital marketing agency focused on human-driven intelligence, utilizing tools such as Buxton Analytics to tailor branding and advertising campaigns for both SMBs and national brands.

As of June 19, 2026, the Company had not commenced operations and is expected to incur losses before achieving positive retained earnings. These conditions raise substantial doubt about the Company’s ability to continue as a going concern (see Note 5). Management intends to fund operations over the next twelve months through capital raises and revenue-generating activities. Failure to obtain additional short-term financing may result in cessation of operations. The accompanying financial statements do not include any adjustments that might arise from these uncertainties.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (“US GAAP”). Any reference in these notes to applicable guidance is meant to refer to U.S. GAAP as found in the Accounting Standards Codification (“ASC”) and Accounting Standards Updates (“ASU”) of the Financial Accounting Standards Board (“FASB”).

Fiscal Year-End

The Company’s fiscal year ends on December 31st. These financial statements cover the inception date of June 19, 2026.

Use of Estimates

The preparation of the financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and the footnotes thereto. Actual results could differ from those estimates. It is reasonably possible that changes in estimates will occur in the near term.

Risks and Uncertainties

The Company has a limited operating history. The Company’s business and operations are sensitive to general business and economic conditions in the United States. A host of factors beyond the Company’s control could cause fluctuations in these conditions. Adverse conditions may include

recession, downturn or otherwise, local competition or changes in consumer taste. These adverse conditions could affect the Company's financial condition and the results of its operations.

Cash

Cash consists of funds held in the Company's checking and savings account. These balances are carried at face value, which approximates fair value due to their short-term nature. As of June 19, 2026, the Company does not yet have any cash in bank.

Accounts Payable

As of June 19, 2026, accounts payable is classified as a current liability in the accompanying financial statements. These balances represent obligations to third party for services received in the ordinary course of business.

Accounts payable are recorded at cost, which approximates fair value due to their short-term nature, and are typically settled within the agreed payment terms. Management evaluates outstanding balances regularly and considers all amounts to be fully payable within the normal operating cycle.

Fair Value Measurements

Generally accepted accounting principles define fair value as the price that would be received to sell an asset or be paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price) and such principles also establish a fair value hierarchy that prioritizes the inputs used to measure fair value using the following definitions (from highest to lowest priority):

- Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.
- Level 2 – Observable inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, including quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in markets that are not active; or other inputs that are observable or can be corroborated by observable market data by correlation or other means.
- Level 3 – Prices or valuation techniques requiring inputs that are both significant to the fair value measurement and unobservable.

As of June 19, 2026, the carrying amount of the Company's financial liability approximate their fair value, and no assets required fair value measurement at that date.

Revenue Recognition

The Company recognizes revenue when persuasive evidence of an arrangement exists, performance has occurred, the fee for the arrangement is fixed or determinable and collectability is reasonably assured. As of the date of inception June 19, 2026, the Company had not begun recognizing sales.

Organizational Costs

In accordance with FASB ASC 720, organizational costs, including costs of incorporation, are expensed as incurred.

Income Taxes

The Company uses the liability method of accounting for income taxes as set forth in ASC 740, *Income Taxes*. Under the liability method, deferred taxes are determined based on the temporary differences between the financial statement and tax basis of assets and liabilities using tax rates expected to be in effect during the years in which the basis differences reverse. A valuation allowance is recorded when it is unlikely that the deferred tax assets will be realized.

The Company assesses its income tax positions and records tax benefits for all years subject to examination based upon its evaluation of the facts, circumstances and information available at the reporting date. In accordance with ASC 740-10, for those tax positions where there is a greater than 50% likelihood that a tax benefit will be sustained, our policy is to record the largest amount of tax benefit that is more likely than not to be realized upon ultimate settlement with a taxing authority that has full knowledge of all relevant information. For those income tax positions where there is less than 50% likelihood that a tax benefit will be sustained, no tax benefit will be recognized in the financial statements. The Company has determined that there are no material uncertain tax positions.

Recent Accounting Pronouncements

The FASB issues ASUs to amend the authoritative literature in ASC. Management believes that those issued to date either (i) provide supplemental guidance, (ii) are technical corrections, (iii) are not applicable to us or (iv) are not expected to have a significant impact on our financial statements.

NOTE 3 – MEMBER'S EQUITY

As of June 19, 2026 (date of inception), the Company has issued 4,581,224 Class A units to Ace Pickleball Club, LLC, a Nevada limited liability company. Ace Pickleball Club, LLC is the Company's founding member and controlling owner and is therefore considered a related party. The Company operates under a brand licensing agreement with Ace Pickleball Club, LLC, and the Company's Managers, Jay Diederich and Joseph Sexton, also serve as the Chief Executive Officer and President, respectively, of Ace Pickleball Club, LLC.

No capital contributions have been made, and no capital contribution receivables have been recognized or recorded.

NOTE 4 – COMMITMENTS AND CONTINGENCIES

The Company is not currently involved with and does not know of any pending or threatening litigation against the Company as of June 19, 2026.

NOTE 5 – GOING CONCERN

These financial statements are prepared on a going concern basis. The Company's ability to continue is dependent upon management's plan to raise additional funds capital contributions from Members, and the ability to achieve profitable operations. The financial statements do not include any adjustments that might be necessary if the Company is not able to continue as a going concern.

NOTE 6 – SUBSEQUENT EVENTS

Subsidiary Entity Formation

On July 15, 2026, the Company established Beyond the Bounce Media LLC, a wholly owned subsidiary incorporated in the State of Nevada. The subsidiary was formed to engage in content production and distribution with a focus on pickleball and other sports. Management notes that this industry remains highly fragmented, with numerous small participants and no dominant market leader.

Anticipated Crowdfunded Offering

The Company is offering (the “Crowdfunded Offering”) up to \$4,880,000 in membership units to prospective investors via Regulation CF. The Company must receive commitments from investors totaling the minimum amount by the offering deadline listed in the Form C, as amended in order to receive any funds.

Management’s Evaluation

Management has evaluated subsequent events through August 7, 2026, the date the financial statements were available to be issued. Based on this evaluation, no material events were identified that require adjustment or disclosure in the financial statements.
