A crowdfunding investment involves risk. Investors should not invest any funds unless they can afford to lose the entire investment.

In making an investment decision, investors must rely on their own examination of the issuer and the terms of the offering, including the merits and risks involved. These securities have not been recommended or approved by any federal or state securities commission or regulatory authority. Furthermore, these authorities have not passed upon the accuracy or adequacy of this document.

The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

These securities are offered under an exemption from registration; however, the U.S. Securities and Exchange Commission has not made an independent determination that these securities are exempt from registration.

Royal Care Companion Support Corporation has been operating since 2015, but like many service-based businesses in the home care industry, we have limited financial history upon which investors can evaluate our long-term prospects. We are not currently profitable and have incurred losses since inception. We expect to continue incurring losses for the foreseeable future as we invest in expanding our caregiver workforce, marketing our services, and building our operational infrastructure. The home care services industry requires substantial ongoing investment in recruiting, training, compliance, and quality assurance. There is no assurance that we will achieve or sustain profitability, and if we do not, we may be unable to continue operations or provide any return to investors.

Our business model is entirely dependent on maintaining a sufficient workforce of qualified, reliable caregivers to serve our clients. The home care industry faces significant challenges in caregiver recruitment and retention, including competition for workers, wage pressures, and high turnover rates. We currently have only five employees, which limits our capacity to provide services and our ability to scale operations. If we are unable to recruit and retain qualified caregivers who meet our standards and comply with applicable licensing and training requirements, we will be unable to serve existing clients or accept new clients, which would materially harm our revenue and growth prospects. Additionally, any quality issues or misconduct by caregivers could damage our reputation and expose us to liability.

With only five employees, our operations depend heavily on the continued service and performance of our small management team and key personnel. The loss of any key employee could significantly disrupt our operations, client relationships, and growth plans. We do not maintain key person life insurance on any of our personnel. Given our limited resources and small team, we may face challenges in attracting and retaining qualified management and operational staff, particularly in competition with larger, better-funded home care providers in the Los Angeles market. Our inability to replace key personnel or expand our management team as needed could prevent us from executing our business plan and achieving our growth objectives.

Providing in-home care and companion services to elderly, disabled, or medically vulnerable individuals exposes us to substantial liability risks. Our caregivers work in clients' homes, often with limited direct supervision, and provide assistance with activities of daily living that carry inherent risks of injury, accidents, or adverse events. We could face claims related to caregiver negligence, abuse or neglect allegations, medication errors, falls, injuries, or other incidents occurring during the provision of care. Even unfounded claims could result in significant legal costs, reputational damage, and loss of clients. While we may carry liability insurance, such insurance may not be adequate to cover all potential claims, and any significant uninsured liability could have a material adverse effect on our financial condition and ability to continue operations.

The home care services market in Los Angeles is highly competitive and fragmented, with numerous established providers ranging from large national chains to local agencies. Many of our competitors have significantly greater financial resources, larger caregiver workforces, established referral networks with hospitals and physicians, stronger brand recognition, and more sophisticated marketing capabilities. These competitors may be able to offer more competitive pricing, provide services in more locations, or invest more heavily in technology and quality improvements. We may be unable to compete effectively against these established players, which could limit our ability to attract and retain clients, maintain pricing, and achieve the market penetration necessary for profitability. Additionally, low barriers to entry in the home care industry mean that new competitors can enter our market relatively easily.

Demand for private-pay home care services is sensitive to economic conditions and the financial circumstances of our target clients and their families. During economic downturns or periods of financial uncertainty, potential clients may delay or forego home care services, rely on unpaid family caregivers, or seek lower-cost alternatives. Many of our potential clients are on fixed incomes or depend on family members to fund their care. Increases in the cost of living, healthcare expenses, or other financial pressures could reduce the ability or willingness of clients to pay for our services. Additionally, changes in government healthcare programs, insurance reimbursement policies, or long-term care insurance coverage could affect the affordability and demand for home care services, which could materially impact our revenue and growth prospects.

Our business is subject to comprehensive federal, state, and local regulations governing healthcare services, employment practices, and business operations. In California, home care agencies must comply with licensing requirements, caregiver background checks, training mandates, and quality standards enforced by state regulatory agencies. We must also comply with employment laws including minimum wage requirements, overtime rules, meal and rest break requirements, workers' compensation insurance, and other labor regulations that are particularly stringent in California. Changes to healthcare regulations, employment laws, or licensing requirements could significantly increase our compliance costs, require modifications to our business practices, or impose new operational restrictions. Failure to maintain required licenses or comply with applicable regulations could result in fines, penalties, loss of licensure, or inability to operate, any of which could have a material adverse effect on our business.

In the course of providing home care services, we collect, store, and use sensitive personal information about our clients, including health information, financial information, and other confidential data. We are subject to federal and state data privacy and security laws, including HIPAA requirements for protected health information and California privacy laws such as the California Consumer Privacy Act. We must implement appropriate safeguards to protect this information from unauthorized access, use, or disclosure. Any data breach, cybersecurity incident, or failure to comply with applicable privacy laws could result in regulatory penalties, litigation, loss of client trust, and reputational damage. As a small company with limited resources, we may lack the sophisticated information security infrastructure and expertise of larger competitors, which could increase our vulnerability to data security incidents.

Our business relies primarily on our operational know-how, caregiver training methods, client relationships, and reputation rather than on patented technology or proprietary products. We have limited ability to prevent competitors from replicating our service model, recruiting our caregivers, or targeting our clients. While we may use confidential information, trade secrets, and contractual protections such as non-disclosure agreements and non-solicitation provisions, these measures may not be adequate to protect our competitive position. Caregivers or employees could leave to join competitors or start competing businesses, potentially taking knowledge of our operations, client information, or relationships with them. Our inability to protect our business methods and relationships could allow competitors to replicate our approach and compete more effectively against us.

We have limited cash reserves and will require substantial additional funding to expand our caregiver workforce, increase our marketing efforts, invest in technology and operational systems, and scale our business to achieve profitability. We intend to use the proceeds from this offering for working capital, including advertising expenses and payroll, but these funds may not be sufficient to achieve our growth objectives. We do not have any commitments or arrangements for additional financing, and there can be no assurance that we will be able to obtain additional capital when needed or on terms acceptable to us. Our ability to obtain financing may be limited by our operating history, lack of profitability, limited assets, and competitive market conditions. If we are unable to obtain adequate financing, we may be forced to curtail our growth plans, reduce operations, or cease business entirely, which would result in a total loss of investment for investors.

We will need to raise additional capital through future equity financings to fund our operations and growth. Any such financings will dilute the ownership percentage of existing investors, including purchasers of the securities in this offering. The SAFE securities being offered will convert into equity securities upon a future priced equity financing or other conversion event, and the number of shares you receive upon conversion will depend on the valuation at which the conversion occurs. Following conversion, your ownership will be further diluted by subsequent equity issuances, including financings, employee equity compensation, and convertible securities issued to other parties. We may also issue securities with rights, preferences, or privileges senior to those of the securities into which your SAFE converts. There is no limit on the amount of securities we may issue, and significant dilution could substantially reduce the value of your investment.

The securities being offered are Simple Agreements for Future Equity (SAFEs), which are not traditional debt or equity securities. SAFEs have no maturity date and do not accrue interest. Your SAFE will convert into equity securities only upon the occurrence of specific events, such as a future priced equity financing or a liquidity event. If no such conversion event occurs, your SAFE may remain outstanding indefinitely without converting, and you may never receive equity securities or any return on your investment. We have no obligation to cause a conversion event to occur, and we may choose to fund our operations through revenue, debt financing, or other means that do not trigger conversion. Additionally, if the company dissolves without a conversion or liquidity event, SAFE holders have only a limited right to payment from remaining assets after creditors and may receive nothing.

An investment in Royal Care Companion Support Corporation is highly speculative and involves a high degree of risk. You should invest only if you can afford to lose your entire investment. The company may never achieve profitability, may be unable to compete effectively in its market, may fail to obtain necessary additional financing, or may encounter operational, regulatory, or other challenges that prevent success. Even if the company achieves some level of success, there is no guarantee that the value of the securities into which your SAFE converts will ever exceed your investment amount. Many early-stage companies fail, and investors in such companies often lose their entire investment. You should not invest unless you understand and can bear the risk of losing everything you invest.

There is no public market for the SAFE securities being offered, and we do not expect one to develop. Even after your SAFE converts into equity securities, those equity securities will not be registered under federal or state securities laws and will be subject to significant restrictions on transfer. You will not be able to sell your securities unless an exemption from registration is available, which may never occur. The securities are subject to a minimum one-year holding period under federal law, and even after that period, resale will be restricted. You should expect to hold your investment for an indefinite period and should be prepared to bear the economic risk of your investment until the company is sold, conducts a public offering, or otherwise provides liquidity to investors, which may never occur. The lack of liquidity may make it impossible for you to recover your investment even if the company is successful.

Purchasers of the SAFE securities will have no voting rights and no ability to influence or control any aspect of the company's business or operations. All decisions regarding the business, including decisions about raising additional capital, entering into significant transactions, hiring and firing employees, selling the company, or dissolving the business, will be made by the company's management and board of directors without your input or approval. Even after your SAFE converts into equity securities, you will hold only a minority interest with no practical ability to affect company decisions. Additionally, as a private company, we are not subject to the reporting and disclosure requirements applicable to public companies, and you will have limited access to information about our financial condition, operations, and business developments. You will be dependent on management's decisions and will have limited ability to protect your investment if you disagree with the direction of the company.

In connection with this offering, the founder has designated themselves as the lead investor who will sign documents and make decisions on behalf of all investors in the special purpose vehicle structure. This arrangement creates significant conflicts of interest because the founder has interests both as the operator of the company and as the representative of investors, and these interests may not always align. Decisions that benefit the company or the founder personally may not be in the best interests of investors. For example, the founder may have access to material non-public information about the company's financial condition or prospects that could influence decisions made on behalf of investors. The founder may also face conflicts in negotiating terms of future financings, liquidity events, or other transactions where the interests of the company and investors diverge. Investors will have no independent third-party advocate representing their interests, and the founder will have broad discretion to make decisions that could adversely affect the value of your investment without your approval or input.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

The Offering

USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering? ⓘ

If we raise: **\$50,000**

Use of Proceeds: If only the minimum target amount is raised, Royal Care Companion expects to use proceeds approximately as follows: 50% Caregiver Payroll and Staffing, 23% Local Advertising and Client Outreach, 19.1% General Operating Expenses, and 7.9% Wefunder fee and related offering expenses. Management intends to allocate proceeds as described but may adjust priorities based on operational needs and market conditions.

If we raise: **\$124,000**

Use of Proceeds: If the maximum target amount is raised, Royal Care Companion expects to use proceeds approximately as follows: 50% Caregiver Payroll and Staffing, 23% Local Advertising and Client Outreach, 19.1% General Operating Expenses, and 79% Wefunder fee and related offering expenses. Raising our maximum will enable us to expand to other states in the US to provide service.

DELIVERY & CANCELLATIONS

11. How will the issuer complete the transaction and deliver securities to the investors?

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

NOTE: Investors may cancel an investment commitment until 48 hours prior to the deadline identified in these offering materials.

The intermediary will notify investors when the target offering amount has been met. If the issuer reaches the target offering amount prior to the deadline identified in the offering materials, it may close the offering early if it provides notice about the new offering deadline at least five business days prior to such new offering deadline.

If an investor does not cancel an investment commitment before the 48-hour period prior to the offering deadline, the funds will be released to the issuer upon closing of the offering and the investor will receive securities in exchange for his or her investment.

If an investor does not reconfirm his or her investment commitment after a material change is made to the offering, the investor's investment commitment will be canceled and the committed funds will be returned.

An Investor's right to cancel. An Investor may cancel his or her investment commitment at any time until 48 hours prior to the offering deadline.

If there is a material change to the terms of the offering or the information provided to the Investor about the offering and/or the Company, the Investor will be provided notice of the change and must re-confirm his or her investment commitment within five business days of receipt of the notice. If the Investor does not reconfirm, he or she will receive notifications disclosing that the commitment was cancelled, the reason for the cancellation, and the refund amount that the investor is required to receive. If a material change occurs within five business days of the maximum number of days the offering is to remain open, the offering will be extended to allow for a period of five business days for the investor to reconfirm.

If the Investor cancels his or her investment commitment during the period when cancellation is permissible, or does not reconfirm a commitment in the case of a material change to the investment, or the offering does not close, all of the Investor's funds will be returned within five business days.

Within five business days of cancellation of an offering by the Company, the Company will give each investor notification of the cancellation, disclose the reason for the cancellation, identify the refund amount the investor will receive, and refund the Investor's funds.

The Company's right to cancel. The Investment Agreement you will execute with us provides the Company the right to cancel for any reason before the offering deadline.

If the sum of the investment commitments from all investors does not equal or exceed the target offering amount at the time of the offering deadline, no securities will be sold in the offering, investment commitments will be cancelled and committed funds will be returned.

Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, **Investors will receive a number of shares of Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

- the total value of the Investor's investment, divided by
- the price of **Preferred Stock** issued to new Investors
- if the valuation for the company is more than **\$12,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
- the Valuation Cap divided by
- the total amount of the Company's capitalization at that time.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Stock**, investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock.

The Investor's right to receive its Cash-Out Amount is:

- Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- Senior to payments for Common Stock.

Securities issued by the SPVInstead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

- the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the investor's interest in the Company will depend upon many factors outside the control of the investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Board Of

Directors, and the Investor will have no independent right to name or remove an officer or member of the Board Of Directors of the Company.

Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. The investor may have the opportunity to increase its investment in the Company in such a transaction, but such opportunity cannot be assured.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview of the Business and Financial Condition

Royal Care Companion Support Corporation (DBA Royal Care Companion) provides in-home care services and companion support for individuals in Los Angeles, California. They offer home care aide and caregiver services to help people remain in their homes with professional assistance.

We are an early-stage company and have incurred operating losses and negative cash flows from operations since inception. We expect to continue to incur operating losses in the near term.

As of September 15, 2026, we had cash and cash equivalents of approximately \$15,000.

Our ability to continue operations is dependent on managing our expenses and, if necessary, obtaining additional financing.

This discussion should be read in conjunction with the financial statements and related notes included in this offering statement.

Business and Operating Uncertainty

Our business operates in an environment subject to various risks, uncertainties, and changing conditions, which makes it difficult to evaluate our business, financial condition, and prospects and may limit the comparability of our results of operations from period to period.

Financial Condition

As of December 31, 2025, our total assets were \$92,887.15 and our current and non-current liabilities, as reflected in available financial statement fields, were \$4,000.

Our financial statements reflect an early-stage company with limited operating history. Investors should not place undue reliance on historical financial information given the company's limited operating history and the likelihood that future results will differ from historical results.

Liquidity and Capital Resources

As of December 31, 2025, we had cash and cash equivalents of approximately \$20,000.

Based on our current operations, we have a monthly net cash burn of approximately \$20,000.

Our monthly net cash burn or profit may vary significantly from month to month due to the timing of receipts and expenditures and other short-term factors. As a result, period-to-period comparisons may not be meaningful.

Based on our current plan, we expect to have sufficient cash to fund operations for at least the next 12 months.

To date, our operations have been funded through minimal cash resources and have not included any external financing.

Liquidity Assumptions

Our assessment of our liquidity and ability to fund operations is not a projection and is based on current assumptions regarding operating expenses, cash requirements, and capital needs. These assumptions may change, and actual results may differ materially due to changes in operating conditions, timing of receipts and payments, and other factors.

Dependence on Additional Financing

There can be no assurance that additional financing will be available on acceptable terms, or at all. If we are unable to raise additional capital when needed, we may be required to materially reduce or suspend operations.

Indebtedness and Capital Structure

As of the date of this offering statement, we had total outstanding indebtedness consisting of 1 loan and approximately \$85,000 in aggregate principal obligations. The indebtedness consists of \$85,000. The material terms of such indebtedness are described in Item 24 of this Form C. (For the avoidance of doubt, SAFEs are not treated as indebtedness.)

We have not conducted any exempt offerings or raised capital in the past three years. The Company has been funded with \$350k in capital contributions from the Founder.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead investor quits or is removed, the Company will choose a Successor Lead investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such circumstances, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. If applicable, the Company may also be required to pay Wefunder certain fees for the preparation of tax filings. Such fees and the Company's obligation to deliver required tax documents are further specified in the related Tax Services Agreement ("TSA").

Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

Potential Dissolution of the SPV. The Company has agreed that it will pay an administrative fee and / or certain tax fees to Wefunder, in addition to delivering required tax information in the manner prescribed by the TSA, where applicable. Failure to pay such fees or provide Wefunder with required tax information could result in the dissolution of the SPV (an "SPV Dissolution Event"). Subsequent to an SPV Dissolution Event, the securities held by the SPV would be distributed directly and proportionally to the individual investors. This could create administrative complexities, as investors would need to manage the securities themselves rather than having them held and administered by the SPV. Additionally, the unplanned distribution of securities may not align with investors' intended investment strategy or asset allocation.

Upon an SPV Dissolution Event, the investor hereby consents to and agrees to accept direct assignment of the SPV's rights and obligations under any investment agreements between the SPV and the Company that is located in the Form C or C/A offering materials. The investor acknowledges they will be bound by all terms and conditions of such agreements as if they were an original party thereto.

4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
