



Offering Statement for NXCE Holdings, LLC ("NYCE X")

NXCE Holdings, LLC ("NYCE X," the "Company," "we," or "us"), a Delaware LLC incorporated on June 22, 2026, is holding the following offering:

NOTE TO INVESTORS ABOUT THE SPV

Regulation Crowdfunding allows an issuer to use a special purpose vehicle, or SPV. The technical legal term is a “crowdfunding vehicle.”

In this case, while the name of the Company itself is NXCE Holdings, LLC, the name of the SPV is NXCE Holdings SPV, LLC. You and all the other Regulation Crowdfunding investors will invest in NXCE Holdings SPV, LLC and NXCE Holdings SPV, LLC will, in turn, use your money to invest in NXCE Holdings, LLC. Hence, NXCE Holdings SPV, LLC will be reflected as one investor in NXCE Holdings, LLC.

NXCE Holdings, LLC believes this structure – with one investor rather than many – will make it easier to raise additional capital in the future because the Offering will leave the Company with only one investor on its capitalization table.

NXCE Holdings SPV, LLC will conduct no business other than to invest in NXCE Holdings, LLC. The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. NXCE Holdings SPV, LLC will be managed by the Company itself. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

All the information about “the Company” in this Form C refers to NXCE Holdings, LLC, not to NXCE Holdings SPV, LLC unless otherwise indicated.

NOTE TO INVESTORS: As explained above, you will invest in NXCE Holdings SPV, LLC, not in the Company directly. You will receive an interest in NXCE Holdings SPV, LLC called “Investor Shares” while NXCE Holdings SPV, LLC will receive units of Common Units issued by the Company. The governing documents of NXCE Holdings SPV, LLC, being its Certificate of Formation and Limited Liability Company Agreement (EXHIBIT E and EXHIBIT G), and the Investor Shares to be issued to you from NXCE Holdings SPV, LLC, are intended to put you in the same position as if you had purchased Non-Voting Units directly from the Company.

Voting Proxy to the Manager

The SPV investor units do not have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a voting proxy granted by Investor in the subscription agreement (Exhibit C), has appointed or will appoint the Manager, NXCE Holdings, LLC, as the Investor's true and lawful proxy (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by PicMii Crowdfunding, LLC, and (ii) execute, in connection with such voting power any instrument or document that the Manager determines is necessary and appropriate in the exercise of his or her authority. The Investor Shares shall have one hundred percent (100%) of the economic rights and no management rights other than to replace the Manager upon a majority vote at a duly called meeting. The Manager Shares shall be held only by NXCE Holdings, LLC, or its affiliates or assigns. The Manager Shares will confer no economic rights but shall confer one hundred percent (100%) of the management authority to the holders of the Manager Shares. The holders of Manager Shares shall have all rights necessary to manage the business affairs of the Company, including but not limited to, the authority to direct the acquisition, holding, and disposition of the Company's assets, and to make all decisions regarding the Company's operations without requiring the consent of the holders of the Investor Shares, subject to limitations in Delaware state law, participation in tender offers, mergers, acquisitions, or any other matters requiring shareholder approval.

Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Business Overview

NYCE X is a real estate advisory, sponsorship, management, and investor-network company focused on expanding access to institutional-scale real estate opportunities. The Company works alongside experienced real estate operators, developers, and other investment professionals to source, structure, advise on, and manage commercial and multifamily real estate transactions. NYCE X's business is centered on providing services to project sponsors and investment entities and developing a scalable investor network through its technology and membership platform.

The Company's operating model is designed to generate recurring and transaction-based revenue through its role as an advisor, sponsor, co-general partner, manager, and technology provider. Depending on the transaction, NYCE X may provide transaction sourcing and structuring services, project management, investor relations, treasury and administrative support, tokenization and related technology services, and other services associated with the formation and operation of real estate investment entities. The Company may also contribute its own capital to selected transactions in which it serves as sponsor or co-general partner. Such co-investments are made for the Company's own account as part of its broader operating and sponsorship activities and are not the principal business of the Company.

Business Model

NYCE X generates revenue primarily through the operation of its real estate advisory and investor-network business. Its anticipated sources of revenue include:

- **Advisory fees** earned for sourcing, evaluating, structuring, and advising on real estate transactions;
- **Management fees** earned for providing ongoing management, administrative, investor-relations, treasury, and other services to project entities and operating partners;
- **Sponsorship and transaction fees** earned in connection with transactions for which NYCE X serves as sponsor, co-general partner, or transaction advisor;
- **Technology and tokenization-related fees**, where applicable, for providing technology, administrative, or related services associated with the digital representation and administration of interests in project entities; and
- **B2C membership subscriptions** from individuals seeking access to the Company's investor network, educational resources, transaction opportunities, and related services.

The Company may also receive carried interest, performance-based compensation, or returns on capital that NYCE X invests for its own account in transactions it sponsors or manages. These potential returns are ancillary to the Company's primary operating activities and are not the Company's sole or principal source of revenue.

NYCE X's business is therefore designed around originating, structuring, managing, and servicing real estate transactions and operating an investor-network platform, rather than operating as a pooled investment vehicle for investors. The Company does not offer investors in the present offering a direct or indirect ownership interest in any particular real estate project.

What Investors in This Offering Are Buying

Investors in this Regulation Crowdfunding offering are purchasing Common Units of NYCE X itself. The securities offered in this offering do not represent a direct ownership interest in any particular real estate property, project entity, tokenized asset, or other investment opportunity sponsored or managed by NYCE X.

An investment in NYCE X represents an investment in the Company's overall operating business, including its advisory, transaction-sourcing, sponsorship, management, technology, tokenization, and membership activities. Investors should not expect that the proceeds of this offering will provide them with a direct interest in any particular property or project described by the Company.

The Company may use proceeds from this offering to support the development and expansion of its operating business, including personnel, technology, marketing, business development, transaction sourcing, working capital, platform development, and other general corporate purposes. To the extent permitted by applicable law and consistent with the Company's business strategy, the Company may also deploy a portion of its capital in connection with transactions that it sponsors or manages.

Market and Opportunity

NYCE X believes there is a significant opportunity to provide individuals with greater access to the institutional real estate ecosystem. Historically, many commercial and multifamily real estate transactions have been primarily accessible to large institutions, high-net-worth individuals, and established private investment networks.

The Company seeks to address this market through a combination of real estate transaction expertise, technology, and a direct-to-consumer investor network. Through its membership platform and relationships with investors, operators, developers, and other industry participants, NYCE X seeks to create a network through which real estate sponsors can access capital and individual investors can learn about and potentially participate in qualifying investment opportunities offered through separate transactions.

The Company believes its opportunity extends beyond any individual property or geographic market because its platform is intended to support multiple transactions and operating partners over time.

Project Pipeline

NYCE X has identified several prospective real estate transactions in which it may provide advisory, sponsorship, management, co-general-partner, tokenization, or other services. These opportunities are intended to illustrate the types of transactions the Company may pursue as part of its operating business and should not be interpreted as assets being offered to investors in this Regulation Crowdfunding offering.

The Company's current pipeline includes a prospective 2,500-acre university and innovation hub in KwaZulu-Natal, South Africa, where NYCE X has discussed a potential general-partner and transaction-support role; a prospective 1,001-unit luxury residential development at Miami Worldcenter, where the Company has discussed a potential co-general-partner and tokenization role; a prospective Qualified Opportunity Zone project in Philadelphia, where the Company has discussed potential GP, LP, and advisory involvement; and a prospective 380-unit condominium development in Dania Beach, Florida, where the Company has discussed a potential co-general-partner role. The Dania Beach project has an estimated total project cost of approximately \$335.5 million.

These projects remain prospective and are subject to due diligence, negotiations, financing, documentation, regulatory approvals, and other conditions. **None of the four projects has closed as of the date of this offering statement**, and there can be no assurance that NYCE X will ultimately participate in any of them or that any transaction will generate revenue for the Company.

Tokenization and Digital Assets

As part of its technology and transaction-services business, NYCE X may facilitate or provide technology related to the digital representation, administration, and transfer of interests in certain project entities. Such digital interests may be offered through separate transactions conducted by the applicable project entity or other sponsoring entity pursuant to an applicable securities-law exemption or registration.

The digital interests associated with individual projects are separate from the Common Units offered in this Regulation Crowdfunding offering. **Purchasers of the Common Units will not receive any tokens or direct interests in the Company's individual real estate projects as a result of this offering.**

Any secondary trading platform or other marketplace operated by an affiliate of NYCE X is a separate business and is not the issuer of the Common Units offered in this Regulation Crowdfunding offering. Any offering, sale, or secondary trading of securities through such platform will be subject to applicable securities laws and regulations.

Company's Role as Sponsor and Co-General Partner

In transactions where NYCE X serves as sponsor or co-general partner, the Company may contribute its own capital and perform services such as transaction sourcing, structuring, investor relations, treasury oversight, project administration, asset management, and coordination with operating partners. NYCE X may receive fees and performance-based compensation for these

services and may participate economically in the applicable project based on the terms negotiated for each transaction.

The Company's participation in individual transactions does not mean that investors in NYCE X's Common Units acquire an ownership interest in those transactions. Rather, NYCE X's ability to source, execute, manage, and generate revenue from transactions is part of the Company's broader operating business.

Risk Factors

Investing in the Securities involves a high degree of risk and may result in the loss of your entire investment. Before making an investment decision with respect to the Securities, we urge you to carefully consider the risks described in this section and other factors set forth in this Form C. In addition to the risks specified below, the Company is subject to same risks that all companies in its business, and all companies in the economy, are exposed to. These include risks relating to economic downturns, political and economic events and technological developments (such as hacking and the ability to prevent hacking). Additionally, early-stage companies are inherently riskier than more developed companies. Prospective Investors should consult with their legal, tax and financial advisors prior to making an investment in the Securities. The Securities should only be purchased by persons who can afford to lose all of their investment.

Risks Related to the Company's Business and Industry

We have a limited operating history upon which you can evaluate our performance, and accordingly, our prospects must be considered in light of the risks that any new company encounters. The Company is still in an early phase and we are just beginning to implement our business plan. There can be no assurance that we will ever operate profitably. The likelihood of our success should be considered in light of the problems, expenses, difficulties, complications and delays usually encountered by early-stage companies. The Company may not be successful in attaining the objectives necessary for it to overcome these risks and uncertainties.

Global crises such as COVID-19 can have a significant effect on our business operations and revenue projections.

There is an ongoing outbreak of a novel and highly contagious form of coronavirus ("COVID-19"), which the World Health Organization declared a global pandemic on March 11, 2020. The outbreak of COVID-19 has caused a worldwide public health emergency with a substantial number of hospitalizations and deaths and has significantly adversely impacted global commercial activity and contributed to both volatility and material declines in equity and debt markets. The global impact of the outbreak is rapidly evolving, and many national, state, and local governments have reacted by instituting mandatory or voluntary quarantines, travel prohibitions and restrictions, closures or reductions of offices, businesses, schools, retail stores, restaurants, and other public venues and/or cancellations, suspensions and/or postponements of certain events and activities, including certain non-essential government and regulatory activities. Businesses are also implementing their own precautionary measures, such as voluntary closures, temporary or permanent reductions in work force, remote working arrangements and emergency contingency plans.

Such measures, as well as the general uncertainty surrounding the dangers, duration, and impact of COVID-19, are creating significant disruption to supply chains and economic activity, impacting consumer confidence and contributing to significant market losses, including by having particularly adverse impacts on transportation, hospitality, healthcare, tourism, sports,

entertainment and other industries dependent upon physical presence. Technological infrastructure has, and will likely continue to be, strained for so long as mandatory or voluntary quarantines are instituted, which will change, and potentially disrupt, the operations of the Company. As COVID-19 continues to spread, potential additional adverse impacts, including a global, regional or other economic recession of indeterminate duration, are increasingly likely and difficult to assess and, if the spread of COVID-19 is prolonged, it could adversely affect many economies, global financial markets and the Company even after COVID- 19 is contained.

The extent of the impact of COVID-19 on the Company's operational and financial performance will depend on many factors, all of which are highly uncertain and cannot be predicted. Those factors include the duration and scope of the resulting public health emergency; the extent of any related restrictions implemented; the impact of such public health emergency on overall supply and demand, goods and services, investor liquidity, consumer confidence and levels of economic activity; and the extent of its disruption to important global, regional and local supply chains and economic markets. The effects of the COVID-19 pandemic may materially and adversely impact the value, performance and liquidity of the Company.

In addition, COVID-19 and the resulting changes to global businesses and economies likely will adversely impact the business and operations of the Company and therefore the business and operations of the Company. Certain businesses and activities may be temporarily or permanently halted as a result of government or other quarantine measures, voluntary and precautionary restrictions on travel or meetings and other factors, including the potential adverse impact of COVID-19 on the health of key personnel.

Regulatory changes and uncertainties.

The Company operates in a highly regulated industry subject to substantial change. In addition, both its labor and customer base are licensed and regulated by local, state, and federal governments. Policies may be changed for several reasons including, but not limited to economic conditions, public safety, socio-political factors, and such. As policy changes are made by regulators, there is no guarantee that the company will be able to provide services in its current form, which may place a substantial hardship on operations, causing an Investor to lose all or a portion of their investment.

The amount of capital the Company is attempting to raise in this Offering may not be enough to sustain the Company's current business plan.

In order to achieve the Company's near and long-term goals, the Company may need to procure funds in addition to the amount raised in the Offering. There is no guarantee the Company will be able to raise such funds on acceptable terms or at all. If we are not able to raise sufficient capital in the future, we may not be able to execute our business plan, our continued operations may require a significant pivot in strategy and execution, which could cause an Investor to lose all or a portion of their investment.

We may face potential difficulties in obtaining capital

We may have difficulty raising needed capital in the future as a result of, among other factors, our lack of revenue, as well as the inherent business risks associated with our Company and present and future market conditions.

The Company's success depends on the experience and skill of its manager and other key personnel.

In particular, we are dependent on our managers. The loss of the Managers, the Principals or any other key personnel could harm the Company's business, financial condition, cash flow and performance. Accordingly, you should not invest in the Company unless you are willing to entrust all aspects of the management of the Company and the investment decisions we make on the behalf of the Company.

Although dependent on certain key personnel, the Company does not have any key person life insurance policies on any such people

We are dependent on certain key personnel in order to conduct our operations and execute our business plan, however, the Company has not purchased any insurance policies with respect to those individuals in the event of their death or disability. Therefore, if any of these personnel die or become disabled, the Company will not receive any compensation to assist with such person's absence. The loss of such person could negatively affect the Company and our operations. We have no way to guarantee key personnel will stay with the Company, as many states do not enforce non-competition agreements, and therefore acquiring key man insurance will not ameliorate all of the risk of relying on key personnel.

Damage to our reputation could negatively impact our business, financial condition and results of operations.

Our reputation and the quality of our brand are critical to our business and success and will be critical to our success as we form and advise new markets. Any incident that erodes confidence in our brand could significantly reduce the Company's value and damage our business. We may be adversely affected by any negative publicity, regardless of its accuracy. Also, there has been a marked increase in the use of social media platforms and similar devices, including blogs, social media websites and other forms of internet-based communications that provide individuals with access to a broad audience. The availability of information on social media platforms is virtually immediate as is its impact. Information posted may be adverse to our interests or may be inaccurate, each of which may harm our performance, prospects or business. The harm may be immediate and may disseminate rapidly and broadly, without affording us an opportunity for redress or correct.

Risks Related to the Offering

The U.S. Securities and exchange Commission does not pass upon the merits of the Securities or the terms of the Offering, nor does it pass upon the accuracy or completeness of any Offering document or literature.

You should not rely on the fact that our Form C is accessible through the U.S. Securities and Exchange Commission's EDGAR filing system as an approval, endorsement or guarantee of compliance as it relates to this Offering. The U.S. Securities and Exchange Commission has not reviewed this Form C, nor any document or literature related to this Offering.

Neither the Offering nor the Securities have been registered under federal or state securities laws.

No governmental agency has reviewed or passed upon this Offering or the Securities. Neither the Offering nor the Securities have been registered under federal or state securities laws. Investors will not receive any of the benefits available in registered Offerings, which may include access to quarterly and annual financial statements that have been audited by an independent accounting firm. Investors must therefore assess the adequacy of disclosure and the fairness of the terms of this Offering based on the information provided in this Form C and the accompanying exhibits.

The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.

Unless the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the use of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

The Company has the right to limit individual Investor commitment amounts based on the Company's determination of an Investor's sophistication.

The Company may prevent any Investor from committing more than a certain amount in this Offering based on the Company's determination of the Investor's sophistication and ability to assume the risk of the investment. This means that your desired investment amount may be limited or lowered based solely on the Company's determination and not in line with relevant investment limits set forth by the Regulation CF rules. It is not currently contemplated that registration under the Securities Act or other securities laws will be affected. Investors will have no right to control the Company's operations.

The Investors will have no opportunity to control the day-to-day operations of the Company, including, without limitation, the investment and disposition decisions of the Portfolio Companies. In order to safeguard your limited liability for the liabilities and obligations of the Company, you must rely entirely on the Manager and Principals to conduct and manage the business affairs of the Company

Investors will not be entitled to any inspection or information rights other than those required by law.

Investors will not have the right to inspect the books and records of the Company or to receive financial or other information from the Company, other than as required by law. Other security holders of the Company may have such rights. Regulation CF requires only the provision of an annual report on Form C and no additional information. Additionally, there are numerous methods by which the Company can terminate annual report obligations, resulting in no information rights, contractual, statutory or otherwise, owed to Investors. This lack of information could put Investors at a disadvantage in general and with respect to other security holders, including certain security holders who have rights to periodic financial statements and updates from the Company such as quarterly unaudited financials, annual projections and budgets, and monthly progress reports, among other things.

The Company may never undergo a liquidity event and Investors may have to hold the Securities indefinitely.

The Company may never undergo a liquidity event such as a repurchase of the Securities by the Company, a sale of the Company or an initial public or coin offering. If a liquidity event does not occur, Investors could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities may be significantly diluted as a consequence of subsequent equity financings.

The Company's equity securities will be subject to dilution. The Company may issue additional equity to third-party financing sources in amounts that are uncertain at this time, and as a consequence holders of the Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the Investor's economic interests in the Company. The Securities may be substantially different from other equity securities offered or issued by the Company.

The Securities may be materially different from the other equity securities of the Company in many ways, including, but not limited to, liquidation preferences, dividend rights, or anti-dilution protection. The Securities may not provide the holders of such Securities with the same rights, preferences, protections, and other benefits or privileges provided to other investors of the Company.

In the event of the dissolution or bankruptcy of the Company, Investors will not be treated as debt holders and therefore are unlikely to recover any proceeds.

In the event of the dissolution or bankruptcy of the Company, the holders of the Securities will be entitled to distributions as described in the Securities. This means that such holders will only receive distributions once all of the creditors and more senior security holders, including any holders of preferred membership interests, have been paid in full. Neither holders of the Securities can be guaranteed any proceeds in the event of the dissolution or bankruptcy of the Company.

There is no guarantee of a return on an Investor's investment.

There is no assurance that an Investor will realize a return on their investment or that they will not lose their entire investment. For this reason, each Investor should read this Form C and all exhibits carefully and should consult with their attorney and business advisor prior to making any investment decision.

Regulation Crowdfunding allows an issuer to use a special purpose vehicle, or SPV. The technical legal term is a “crowdfunding vehicle.”

In this case, while the name of the Company itself is NXCE Holdings, LLC, the name of the SPV is NXCE Holdings SPV, LLC. You and all the other Regulation Crowdfunding investors will invest in NXCE Holdings SPV, LLC and NXCE Holdings SPV, LLC will, in turn, use your money to invest in NXCE Holdings, LLC. Hence, NXCE Holdings SPV, LLC will be reflected as one investor in NXCE Holdings, LLC.

NXCE Holdings, LLC believes this structure – with one investor rather than many – will make it easier to raise additional capital in the future because the Offering will leave the Company with only one investor on its capitalization table.

NXCE Holdings SPV, LLC will conduct no business other than to invest in NXCE Holdings, LLC. The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. NXCE Holdings SPV, LLC will be managed by the Company itself. All the information about “the Company” in this Form C refers to NXCE Holdings, LLC, not to NXCE Holdings SPV, LLC unless otherwise indicated.

NOTE TO INVESTORS: As explained above, you will invest in NXCE Holdings SPV, LLC, not in the Company directly. You will receive an interest in NXCE Holdings SPV, LLC called “Investor Shares” while NXCE Holdings SPV, LLC will receive units of Common Units issued by the Company. The governing documents of NXCE Holdings SPV, LLC, being its Certificate of Formation and Limited Liability Company Agreement (EXHIBIT E and EXHIBIT G), and the Investor Shares to be issued to you from NXCE Holdings SPV, LLC, are intended to put you in the same position as if you had purchased Non-Voting Units directly from the Company.

Voting Proxy to the Manager

The SPV investor units do not have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a voting proxy granted by Investor in the subscription agreement (Exhibit C), has appointed or will appoint the Manager, NXCE Holdings, LLC, as the Investor's true and lawful proxy (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by PicMii Crowdfunding, LLC, and (ii) execute, in connection with such voting power any instrument or document that the Manager determines is necessary and appropriate in the exercise of his or her authority. The Investor Shares shall have one hundred percent (100%) of the economic rights and no management rights other than to replace the Manager upon a majority vote at a duly called meeting. The Manager Shares shall be held only by NXCE Holdings, LLC, or its affiliates or assigns. The Manager Shares will confer no economic rights but shall confer one hundred percent (100%) of the management authority to the holders of the Manager Shares. The Manager Shares shall be held only by NXCE Holdings, LLC, or its affiliates or assigns. The Manager Shares will confer no economic rights but shall confer one hundred percent (100%) of the management authority to the holders of the Manager Shares. The holders of Manager Shares shall have all rights necessary to manage the business affairs of the Company, including but not limited to, the authority to direct the acquisition, holding, and disposition of the Company's assets, and to make all decisions regarding the Company's operations without requiring the consent of the holders of the Investor Shares, subject to limitations in Delaware state law, participation in tender offers, mergers, acquisitions, or any other matters requiring shareholder approval.

We may choose to modify the terms of the securities before the offering is completed. However, if the terms are modified, and we deem it to be a material change, we need to contact you and you will be given the opportunity to reconfirm your investment. Your reconfirmation must be completed within five business days of receipt of the notice of a material change, and if you do not reconfirm, your investment will be cancelled and your money will be returned to you.

Options, Warrants and Other Rights

17. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of securities?

Investors should understand the potential for dilution. The investor's stake in a company could be diluted due to the company issuing additional units. In other words, when the company issues more units, the percentage of the company that you own will go down, even though the value of the company may go up. You will own a smaller piece of a larger company. This increase in number of units outstanding could result from a stock offering (such as an initial public offering, another crowdfunding round, a venture capital round, angel investment), employees exercising stock options, or by conversion of certain instruments (e.g., convertible bonds, preferred units or warrants) into stock. If the company decides to issue more units, an investor could experience value dilution, with each unit being worth less than before, and control dilution, with the total percentage an investor owns being less than before. 19. How could the exercise of rights held by the principal owners identified in Question 5 above affect the purchasers of Securities being offered?

The holder of a majority of the voting rights in the company may make decisions with which you disagree, or that negatively affect the value of your investment in the company, and you will have no recourse to change those decisions. Your interests may conflict with the interests of other investors, and there is no guarantee that the company will develop in a way that is advantageous to you. For example, the majority shareholder may decide to issue additional units to new investors, sell convertible debt instruments with beneficial conversion features, or make decisions that affect the tax treatment of the company in ways that may be unfavorable to you. Based on the risks described above, you may lose all or part of your investment in the securities that you purchase, and you may never see positive returns.

20. How are the securities being offered valued? Include examples of methods for how such securities may be valued by the issuer in the future, including during subsequent corporate actions.

The issuer is raising this Regulation Crowdfunding round at a \$20,000,000 pre-money valuation, based on all outstanding units of Common Units.

The securities being offered are valued at the issuer's discretion. An early-stage company typically sells its units (or grants options over its units) to its founders and early employees at a very low cash cost, because they are, in effect, putting their "sweat equity" into the company. When the company seeks cash investments from outside investors, like you, the new investors typically pay a much larger sum for their units than the founders or earlier investors, which means that the cash value of your stake is immediately diluted because each unit of the same type is worth the same amount, and you paid more for your units than earlier investors did for theirs.

There are several ways to value a company, and none of them is perfect and all of them involve a certain degree of guesswork. Any of these methods, plus others, may be used to determine valuation in the future:

Liquidation Value - The amount for which the assets of the company can be sold, minus the liabilities owed, e.g., the assets of a bakery include the cake mixers, ingredients, baking tins, etc. The liabilities of a bakery include the cost of rent or mortgage on the bakery. However, this value does not reflect the potential value of a business, e.g., the value of the secret recipe. The value for most startups lies in their potential, as many early stage companies do not have many assets.

Book Value - This is based on analysis of the company's financial statements, usually looking at the company's balance sheet as prepared by its accountants. However, the balance sheet only looks at costs (i.e., what was paid for the asset), and does not consider whether the asset has increased in value over time. In addition, some intangible assets, such as patents, trademarks or trade names, are very valuable but are not usually represented at their market value on the balance sheet.

Earnings Approach - This is based on what the investor will pay (the present value) for what the investor expects to obtain in the future (the future return), taking into account inflation, the lost

opportunity to participate in other investments, the risk of not receiving the return. However, predictions of the future are uncertain and valuation of future returns is a best guess.

Different methods of valuation produce a different answer as to what your investment is worth. Typically, liquidation value and book value will produce a lower valuation than the earnings approach. However, the earnings approach is also most likely to be risky as it is based on many assumptions about the future, while liquidation value and book value are much more conservative.

Future investors (including people seeking to acquire the company) may value the company differently. They may use a different valuation method, or different assumptions about the company's business and its market. Different valuations may mean that the value assigned to your investment changes. It frequently happens that when a large institutional investor such as a venture capitalist makes an investment in a company, it values the company at a lower price than the initial investors did. If this happens, the value of the investment would go down.

21. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

The company's formation documents or operating agreement can be amended by the holders of a majority of the issued and outstanding units of the Company. As minority owners, the crowdfunding investors are subject to the decisions made by the majority owners. The issued and outstanding units of common stock give management voting control of the company. As a minority owner, you may be outvoted on issues that impact your investment, such as, among other things: (a) the liquidation, dissolution or winding up of the company, or effecting any merger or consolidation; (b) amendment of any provision of the Certificate of Formation or Operating Agreement; (c) creation and issuance of other securities having rights, preferences or privileges senior to the common stock sold to the crowdfunding investors, or increasing the authorized number of units of stock of the company; or (d) creation of any debt security.

22. What are the risks to purchasers associated with corporate actions including:

The authorization and issuance of additional units of the company's common stock will dilute the ownership of the crowdfunding investors. As a result, if the company achieves profitable operations in the future, its net income per unit will be reduced because of dilution, and the market price of the company's common stock, if there is a market price, could decline as a result of the additional issuances of securities. If the company repurchases securities, so that the above risk is mitigated, and there are fewer units of common stock outstanding, the company may not have enough cash available for marketing expenses, growth, or operating expenses to reach our goals. If we do not have enough cash to operate and grow, we anticipate the market price of our securities would decline. A sale of the company or of all of the assets of the company may result

in an entire loss of your investment. We cannot predict the market value of the company or its assets, and the proceeds of a sale may not be cash, but instead, unmarketable securities, or an assumption of liabilities. It is unlikely that in the near term, a sale would result in a premium that is significant enough over book value to generate a return to our investors. We may need to negotiate with a related party for additional capital. No assurance can be given that such funds will be available or, if available, will be on commercially reasonable terms satisfactory to us. Even if such financing is available, it may be on terms that are materially adverse to your interests with respect to dilution of book value, dividend preferences, liquidation preferences, or other terms.

Financial Condition of the Issuer

The financial statements of NXCE Holdings LLC cover the period ended July 14, 2026, and were prepared in accordance with U.S. generally accepted accounting principles (GAAP). The financial statements have been reviewed by an independent certified public accountant in accordance with applicable Statements on Standards for Accounting and Review Services. The accountant reported that, based on the review, they were not aware of any material modifications that should be made to the financial statements for them to conform with U.S. GAAP. NXCE Holdings LLC is a newly formed company, and accordingly, its financial history is limited.

The Company's financial statements include a balance sheet, statement of revenue and expenditures, and statement of cash flows for the period ended July 14, 2026. The statements and accompanying notes describe the Company's accounting policies and indicate that the Company had no bad debt expense during the period. The financial statements also note that, for U.S. federal income tax purposes, income tax obligations are generally attributable to the Company's members, and therefore no provision or liability for income taxes is included in the financial statements. Given the Company's early stage and limited operating history, investors should consider the Company's financial condition in the context of its status as a newly established entity and its plans to develop its investment and holding activities.
